### 2. Test Methodology

The measurement procedures described in the ANSI C63.10-2013 and the guidance provided in KDB558074 D01v05 were used in measurement of the EUT.

The EUT was tested per the guidance of KDB558074 D01v05. And ANSI C63.10-2013 was used to reference appropriate EUT setup and maximizing procedures of radiated spurious emission and AC line conducted emission testing.

#### 2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 2.2 EUT Exercise

The EUT was operated in the test mode to fix the TX frequency that was for the purpose of the measurements. According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

#### 2.3 General Test Procedures

#### **Conducted Emissions**

The power-line conducted emission test procedure is not described on the KDB558074 D01v05.

So this test was fulfilled with the requirements in Section 6.2 of ANSI C63.10-2013.

The EUT is placed on the wooden table, which is 0.8 m above ground plane and the conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-peak and Average detector.

#### **Radiated Emissions**

Basically the radiated tests were performed with KDB558074 D01v05. But some requirements and procedures like test site requirements, EUT setup and maximizing procedure were fulfilled with the requirements in Section 5 and 6 of the ANSI C63.10-2013. The EUT is placed on a non-conductive table. For emission measurements at or below 1 GHz, the table height is 80 cm. For emission measurements above 1 GHz, the table height is 1.5 m. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3 m away from the receiving antenna, which varied from 1 m to 4 m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the highest emission, the relative positions of the EUT were rotated through three orthogonal axes.

#### 2.4 Description of Test Modes

The EUT has been tested with the operating condition for maximizing the emission characteristics. A test program is used to control the EUT for staying in continuous transmitting. The Bluetooth low energy mode with below low, middle and high channels were tested and reported.

Measurement is made while the EUT is operating in transmission mode at the appropriate frequencies.



TM 1 Test Channel: Middle







#### 3.2 6 dB Bandwidth Measurement

#### ■ Test Requirements and limit, §15.247(a) & RSS-247 [5.2]

The bandwidth at 6 dB down from the highest in-band spectral density is measured with a spectrum analyzer connected to the EUT's antenna terminal while the EUT is operating in transmission mode at the appropriate frequencies.

The minimum permissible 6 dB bandwidth is 500 kHz.

Option 2 - The automatic bandwidth measurement capability of an instrument may be employed using the X dB bandwidth mode with X set to 6 dB, if the functionality described above (i.e., RBW = 100 kHz, VBW  $\geq$  3 × RBW, peak detector with maximum hold) is implemented by the instrumentation function. When using this capability, care shall be taken so that the bandwidth measurement is not influenced by any intermediate power nulls in the fundamental emission that might be  $\geq$  6 dB.

### 3.3 Maximum Power Spectral Density.

### ■ Test requirements and limit, §15.247(e) & RSS-247 [5.2]

The peak power density is measured with a spectrum analyzer connected to the antenna terminal while the EUT is operating in transmission mode at the appropriate frequencies.

#### Minimum Standard

The power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission



TM 1 Test Channel: Middle





### 3.4 Unwanted Emissions (Conducted)

### ■ Test requirements and limit, §15.247(d) & RSS-247 [5.5]

§15.247(d) specifies that in any 100 kHz bandwidth outside of the authorized frequency band, the power shall be attenuated according to the following conditions:

If the peak output power procedure is used to measure the fundamental emission power to demonstrate compliance to 15.247(b)(3) requirements, then the peak conducted output power measured within any 100 kHz outside the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum measured in-band peak PSD level

If the average output power procedure is used to measure the fundamental emission power to demonstrate compliance to **15.247(b)(3)** requirements, then the power in any 100 kHz outside of the authorized frequency band shall be attenuated by at least 30 dB relative to the maximum measured inband average PSD level.

In either case, attenuation to levels below the general emission limits specified in §15.209(a) is not required.

- 6. Sweep time = auto couple.

- 8. Allow the trace to stabilize (this may take some time, depending on the extent of the span).
- 9. Use the peak marker function to determine the maximum amplitude level.

If the emission level with above setting was close to the limit (ie, less than 3 dB margin) then zoom scan is required using RBW = 100 kHz, VBW = 300 kHz, SPAN = 100 MHz and BINS = 2001 to get accurate emission level within 100 kHz BW.

### TM 1 Conducted Spurious Emissions 2 (Test Channel : Middle)




### TM 1 Conducted Spurious Emissions 3 (Test Channel : Middle)









#### 3.5.2 Test Procedures

- 1. The EUT is placed on a non-conductive table. For emission measurements at or below 1 GHz, the table height is 80 cm. For emission measurements above 1 GHz, the table height is 1.5 m.
- 2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
- 3. EUT is set 3 m away from the receiving antenna, which is varied from 1 m to 4 m to find out the highest emissions.

#### 3.6 Power line Conducted Emissions

#### 3.6.2 Test Procedures

Conducted emissions from the EUT were measured according to the ANSI C63.10-2013.


- 1. The test procedure is performed in a 6.5 m × 3.5 m × 3.5 m (L × W × H) shielded room. The EUT along with its peripherals were placed on a 1.0 m (W) × 1.5 m (L) and 0.8 m in height wooden table and the EUT was adjusted to maintain a 0.4 meter space from a vertical reference plane.
- 2. The EUT was connected to power mains through a line impedance stabilization network (LISN) which provides 50 ohm coupling impedance for measuring instrument and the chassis ground was bounded to the horizontal ground plane of shielded room.
- 3. All peripherals were connected to the second LISN and the chassis ground also bounded to the horizontal ground plane of shielded room.
- 4. The excess power cable between the EUT and the LISN was bundled. The power cables of peripherals were unbundled. All connecting cables of EUT and peripherals were moved to find the maximum emission.






#### Test Procedure

#### Duty Cycle was measured using Section 6.0 b) of KDB558074 D01v05:

The zero-span mode on a spectrum analyzer or EMI receiver if the response time and spacing between bins on the sweep are sufficient to permit accurate measurements of the on and off times of the transmitted signal. Set the center frequency of the instrument to the center frequency of the transmission. Set RBW ≥ OBW if possible; otherwise, set RBW to the largest available value. Set VBW ≥ RBW. Set detector = peak or average.

The zero-span measurement method shall not be used unless both RBW and VBW are > 50/T and the number of sweep points across duration T exceeds 100. (For example, if VBW and/or RBW are limited to 3 MHz, then the zero-span method of measuring duty cycle shall not be used if T  $\leq$  16.7 microseconds.)


