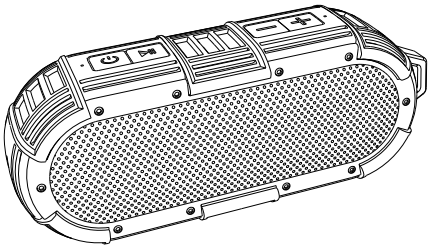

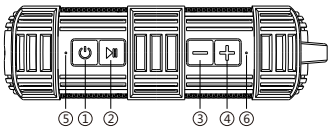

BLAST Speaker Instruction Manual

How to use the Speaker

The General Features



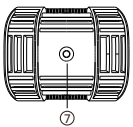
1. On/Off/ Button
Long press this button to power on/off the device.
2. Play/Pause Button/Hand-free Button
Short press this button to play/pause the playing music.
Short press this button to answer the incoming phone call.

3. PREV/Volume Down Button
Short press the button to play the previous track.
Hold in the button to turn down the volume

4. NEXT/Volume Up Button
Short press the button to play the next track.
Hold in the button to turn up the volume.

5. Bluetooth/Charging Indicator light
When the device is turned on, the light turn to blue and flashes.
When the Bluetooth is connected, the light stop flashing and remain blue
When charging the device, the red light turn on.
When the device is fully charged, the red light turn to green.

- 6.MIC
Receive your voice when making phone calls



7. Line-in/charging Interface
Inset the USB cable to charging the speaker.
Inset the 3.5mm audio cable to listen to music.

Pairing Instructions

- Active Bluetooth mode on mobile device and turn speaker on. Speaker will automatically enter pairing mode.
- Search for the Bluetooth Speaker from your mobile device
- Follow instruction on mobile device to complete pairing. If pass-code is needed,enter“ 0000 ” .
- After the Mobile Device and Bluetooth Speaker connect,sound can be controlled from the Buttons “+” “-” and “⏸” .
- If the mobile device has paired with a Bluetooth speaker previously, the match will finish automatically.
