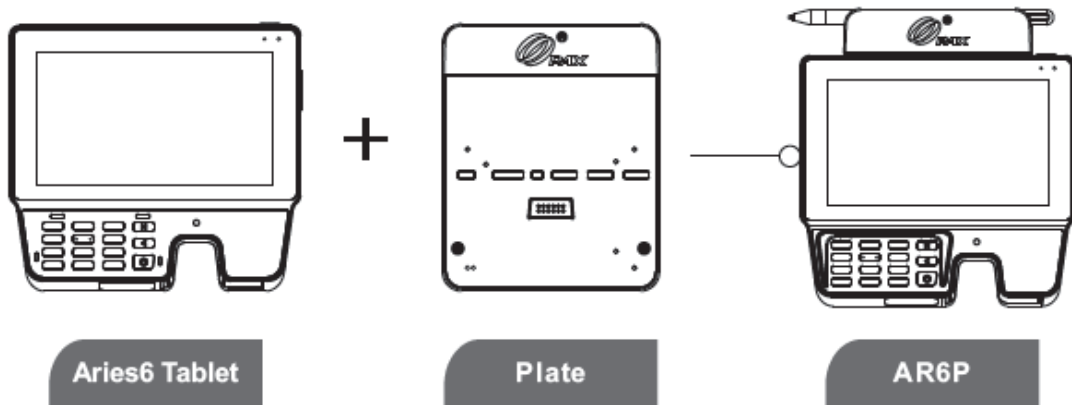

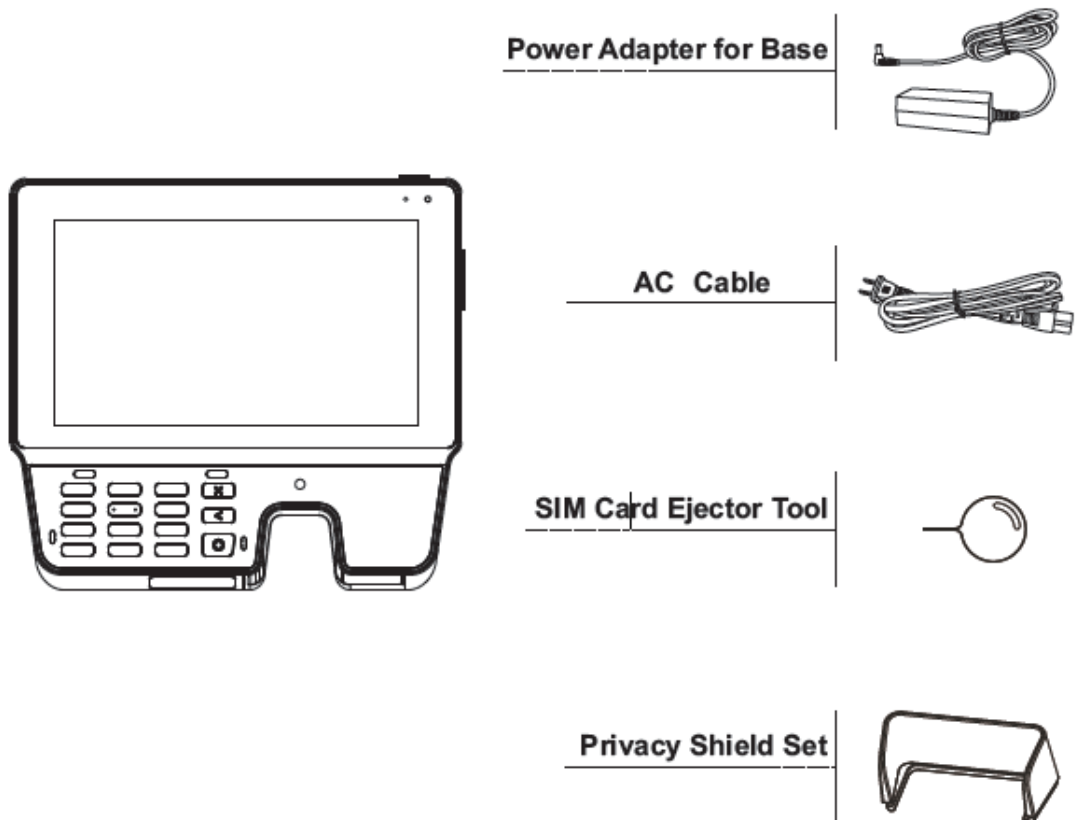

## Introduction

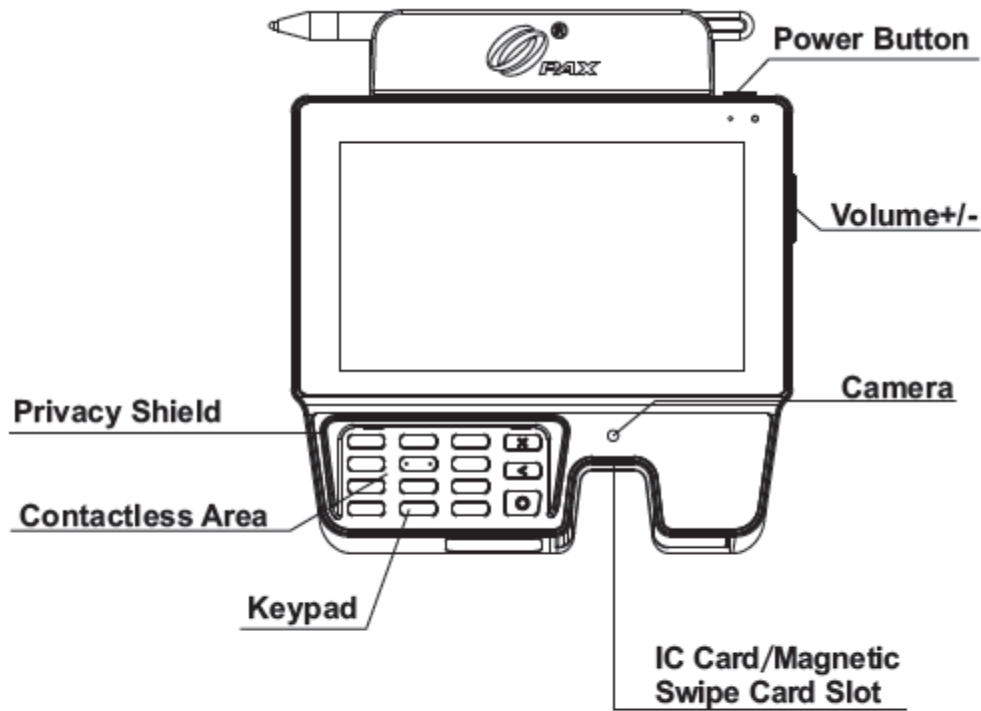

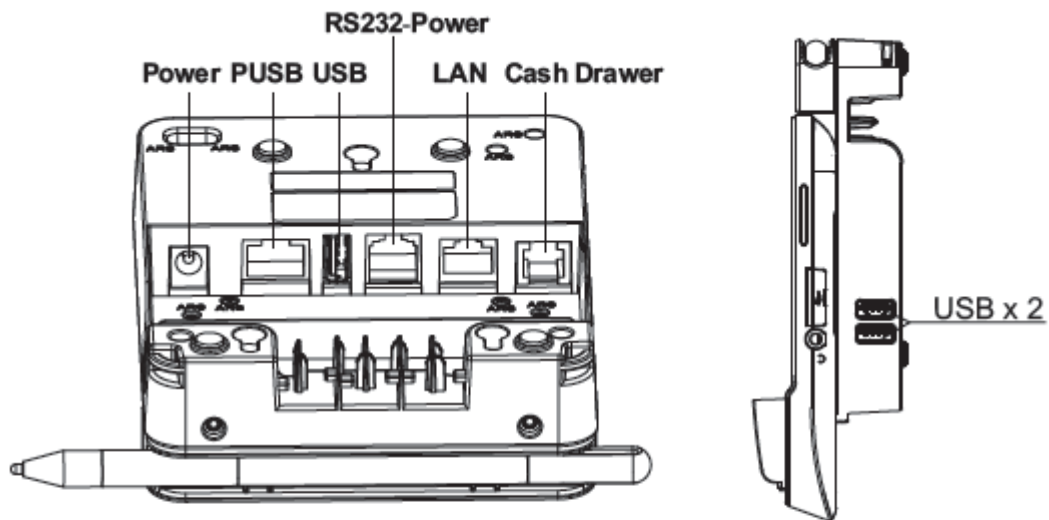

Front View

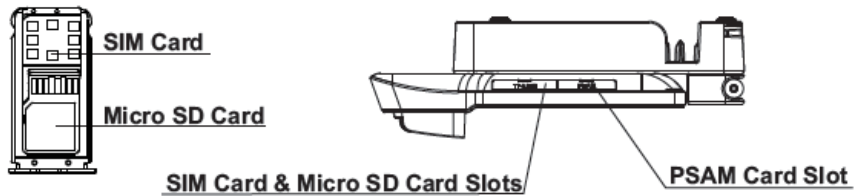

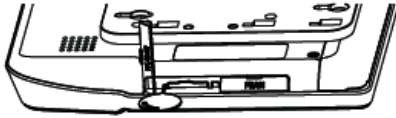

# Install and Remove SIM and PSAM Cards

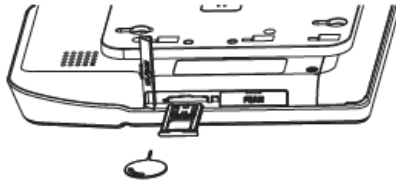


## SIM and Micro SD Cards

- Install** Use ejector tool to open tray. Position SIM Card and Micro SD card on tray. Gently push tray back into slot until firmly seated.

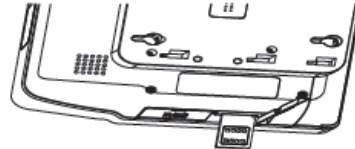


- Remove** Use ejector tool to open tray, take cards out and gently push tray back into slot until firmly seated.

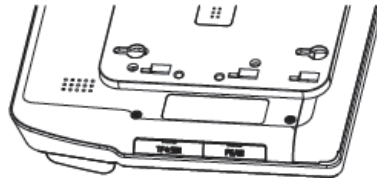


## PSAM Card

- Install** Open cover. Insert card with chip facing up. Close PSAM card slot cover.



- Remove** Push PSAM card further into slot. (The card will protrude slightly out of the slot) Push card again to remove it.



# Privacy Shield Options



**Caution:** If the privacy shield is not installed, you must use PCI-approved alternative methods to secure the tablet keypad.



Low Privacy Shield

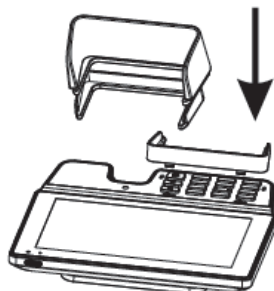


High Privacy Shield

## Install High Privacy Shield



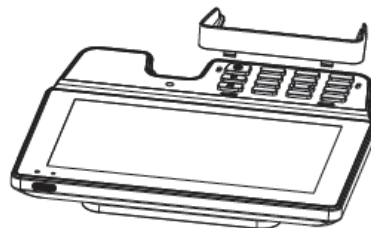
- Align the four pegs on lower privacy shield with the four holes around the tablet keypad.
- Press to secure privacy shield to tablet.
- Snap the higher rubber privacy shield onto the lower one.



## Install Low Privacy Shield



- Align the four pegs on privacy shield with the four holes around the tablet keypad.
- Press to secure privacy shield to tablet.



# Payment Options

## Tap



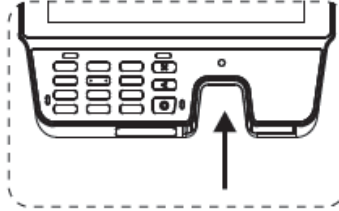
Hold contactless card or device over or under keypad to trigger payment.



## Dip



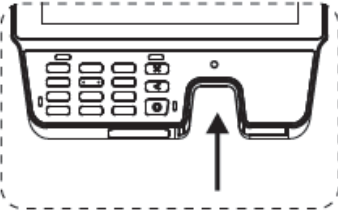
Insert card with IC chip facing up, then push it to the end of the card slot with blue light flashing and icon displaying on screen. Leave card inserted until prompted to remove.



## Swipe



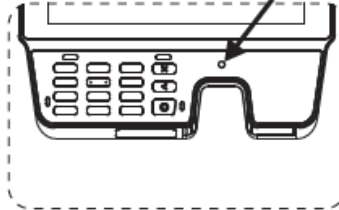
Insert magnetic stripe card into card slot and push to the end with magnetic stripe facing down, then pull out card at a constant speed to swipe card.



## Scan



Hold QR code in front of camera to trigger payment.

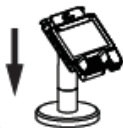


# Attach and Remove from Stand

## Install AR6P

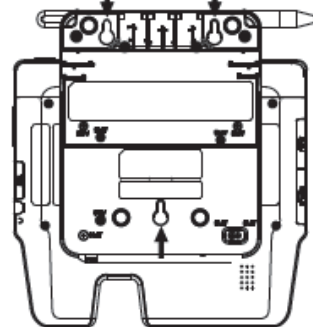


Align the 3 orienting holes on the AR6P with the 3 pegs on the stand.



Lower AR6P onto the stand and push it in the direction shown to secure the AR6P.

Push AR6P in the direction shown to remove it.

# Safety Precautions

## Location Cautions

1. Keep the device away from direct sunlight, excessive dust, moisture and heat.
2. Keep the device from the electrical devices that might introduce interferencesuchas microwave ovens and blow dryers.

## Cleaning Cautions

1. Do not use industrial strength or abrasive cleaner as it may damage or scratch thescreen.
2. Do not immerse device into any kind of liquid.
3. Do not spray water or cleaner into card reader or ports.
4. To clean screen, apply distilled water or mild glass cleaner onto a soft, link-freeclothand gently wipe screen.
5. To clean tablet, apply distilled water or plastic-safe cleaner onto a soft, lint-freeclothand gently wipe tablet.

## Usage Tips

1. Avoid exposing the device to an excessively hot, humid, dusty, or strongelectromagnetic environment.
2. Do not vibrate, shake, or drop the device.
3. Do not plug or unplug any part of the device while it is powered on. This maycausedamage to an internal circuit.
