





2.4.2 Test Procedures

- 1. The EUT was placed 0.4 meter from the conducting wall of the shielding room, and it was kept at least 80 centimeters from any other grounded conducting surface.
- 2. Connect EUT to the power mains through a line impedance stabilization network (LISN).
- 3. All the support units are connecting to the other LISN.
- 4. The LISN provides 50 ohm coupling impedance for the measuring instrument.
- 5. The FCC states that a 50 ohm, 50 microhenry LISN should be used.
- 6. Both sides of AC line were checked for maximum conducted interference.





3.4 20dB Spectrum Bandwidth Measurement

3.4.1 Limit

Intentional radiators must be designed to ensure that the 20 dB bandwidth of the emissions in the specific band 13.553~13.567MHz

3.4.2 Test Procedures

- The transmitter output (antenna port) was connected to the spectrum analyzer in peak Max hold mode.

3.5 Frequency Stability Measurement





- Configure the EUT according to ANSI C63.10. The EUT was placed on the top of the turntable 0.8 meter above ground. The phase center of the loop receiving antenna mounted antenna tower was placed 3 meters far away from the turntable.

4.5.3 Test Procedures

- Configure the EUT according to ANSI C63.10. The EUT was placed on the top of the turntable
 8 meter above ground. The phase center of the receiving antenna mounted on the top of a height-variable antenna tower was placed 3 meters far away from the turntable.

- 7. In case the emission is lower than 30MHz, loop antenna has to be used for measurement and the recorded data should be QP measured by receiver. Antenna Requirements.

4.5.4 Limit

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that the user can replace a broken antenna, but the use of a standard antenna jack or electrical connector is prohibited.
