

4. CALIBRATION AND UNCERTAINTY

4.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

4.2. SAMPLE CALCULATION

Where relevant, the following sample calculation is provided:

$$\text{Field Strength (dBuV/m)} = \text{Measured Voltage (dBuV)} + \text{Antenna Factor (dB/m)} + \text{Cable Loss (dB)} - \text{Preamp Gain (dB)}$$

$$36.5 \text{ dBuV} + 18.7 \text{ dB/m} + 0.6 \text{ dB} - 26.9 \text{ dB} = 28.9 \text{ dBuV/m}$$

4.3. MEASUREMENT UNCERTAINTY

5.4. WORST-CASE CONFIGURATION AND MODE

The worst-position was the EUT with highest emissions. To determine the worst-case, the EUT was investigated for X, Y, and Z-Positions, and the worst position among X, Y, and Z with slid out, AC/DC adapter and headset, after the investigations, the worst-position was turned out to be slid out Z-position with AC Adapter for cell band and Y-Position with AC Adapter and headset for PCS band.

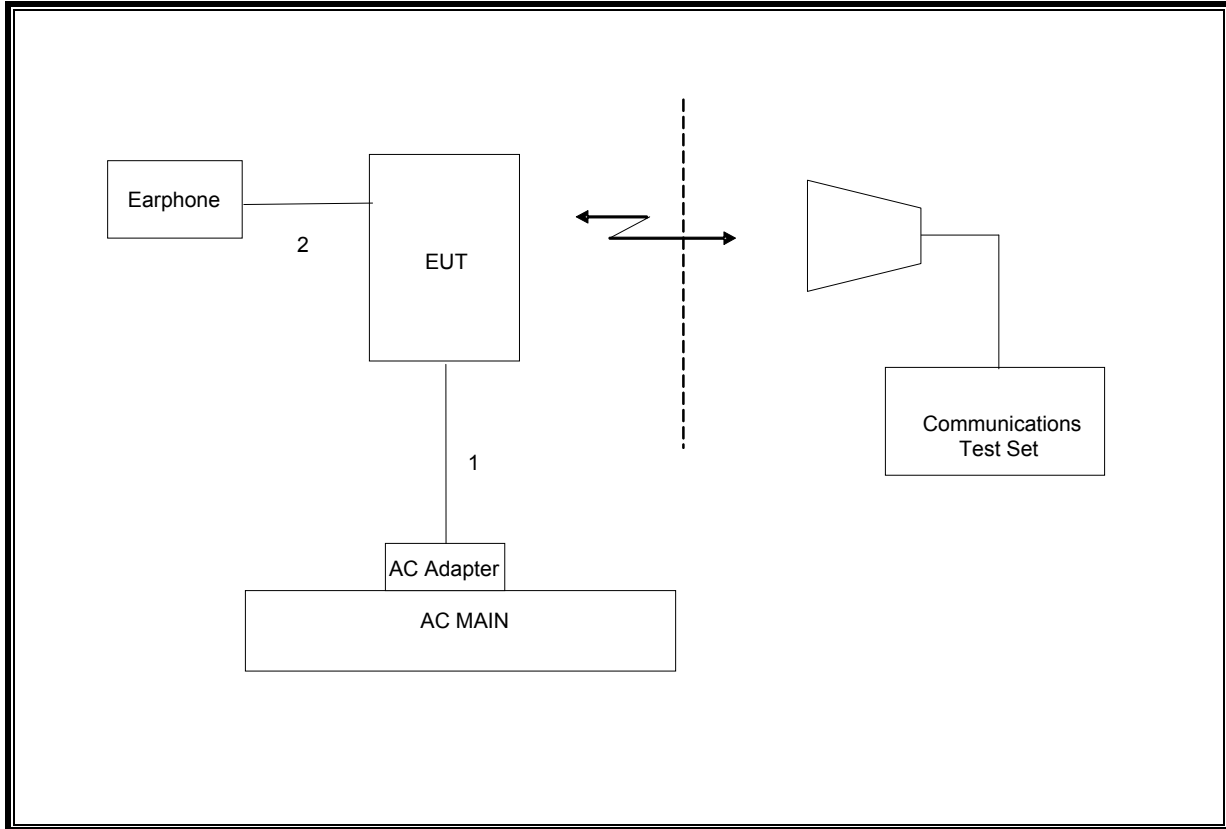
