GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The SHENZHEN TENDA TECHNOLOGY CO., LTD.'s product, model number: POE1300S (FCC ID: V7T1300S) (the "EUT") in this report is a PoE Adapter, which was measured approximately: 13.2 cm (L) x6.0 cm (W) x 3.4 cm (H), rated input voltage: AC 120V/60Hz, the highest operating frequency is 25MHz.

All measurement and test data in this report was gathered from production sample serial number: 120723002 (Assigned by BACL, Dongguan). The EUT was received on 2012-07-24.

Objective

This report is prepared on behalf of *SHENZHEN TENDA TECHNOLOGY CO.,LTD.* in accordance with Part 2, Subpart J, Part 15, Subparts A and B of the Federal Communication Commissions rules.

Test Facility

The Test site used by Bay Area Compliance Laboratories Corp. (Dongguan) to collect test data is located on the No.69 Pulongcun, Puxinhu Industrial Zone, Tangxia, Dongguan, Guangdong, China

Test site at Bay Area Compliance Laboratories Corp. (Dongguan) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on February 02, 2012. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2009.





Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, and LISN.

Based on CISPR 16-4-2, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of any conducted emissions measurement at Bay Area Compliance Laboratories Corp. (Dongguan) is 1.5 dB.

EUT Setup



from other units and other metal planes support units.

The setup of EUT is according with per ANSI C63.4-2009 measurement procedure. The specification used was with the FCC Part 15.107 Class B limits.

The EUT was connected to a 120 VAC/60 Hz power source.

EMI Test Receiver Setup

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

During the conducted emission test, the EMI test receiver was set with the following configurations:

Frequency Range	IF B/W
150 kHz – 30 MHz	9 kHz

Test Procedure

During the conducted emission test, the EUT was connected to the outlet of the first LISN and the other support equipments were connected to the outlet of the second LISN.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All data was recorded in the Quasi-peak and average detection mode.






Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR 16-4-2, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of a radiation emissions measurement from 30 MHz to 1 GHz at Bay Area Compliance Laboratories Corp. (Dongguan) is 4.9 dB.

EUT Setup

Below 1 GHz:



The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2009. The specification used was the FCC Part 15.109, Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The EUT connected to a 120 VAC/60 Hz power source.

EMI Test Receiver Setup

According to FCC 15.33 requirements, the system was measured from 30 MHz to 1 GHz.

During the radiated emission test, the EMI test receiver was set with the following configurations:

Test Procedure

For the radiated emissions test, the EUT was connected to the first AC floor outlet and the other support equipments were connected to the second AC floor outlet.

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

Data was recorded in Quasi-peak detection mode for frequency range of 30 MHz-1 GHz

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Loss and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Loss + Cable Loss - Amplifier Gain

The "**Margin**" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude




