(1) For Non-Beamforming Function:

Antenna Gain=5 dBi. This EUT supports MIMO 2X2, any transmit signals are correlated with each other, so Directional gain $=\mathrm{G}_{\mathrm{ANT}}+10 \log (\mathrm{~N}) \mathrm{dBi}$, that is Directional gain $=5+10 \log (2) \mathrm{dBi}=8.01$. So, the output power limit is $30-8.01+6=27.99$, the power spectral density limit is $8-8.01+6=5.99$.
(2) For Beamforming Function:

Beamforming Gain=3 dBi, Directional gain $=3+5=8 \mathrm{dBi}$. So, the output power limit is $30-8+6=28$, the power spectral density limit is $8-8+6=6$.
