Q#2: Please confirm that this device transmits with Pulse Modulation at 433.92 MHz and not Frequency Modulation as stated in the user manual. Does this device receive an FM signal?

Ans) This device uses FSK modulation (pulse coded signal). This device receive an FM signal.

Q#3: Are there any automatic transmissions or does this only transmit when a button is pressed?

Ans) The data is transmitted always with a control signal and there's no automatic transmissions. This device always transmits in accordance with the requirements of 15.231
