

A. Functions

- 1. Fix code, no need to pair
- 2. Manual button to control receiver ON/OFF.

B. Diagram



No.	Description	Function
1	LED indicator	Light up when ON/OFF button is pressed
2	ON OFF	Switch ON/OFF the receiver

C. Instruction

- a) Take off the insulation sheet from the battery cover on the back of the remote
- b) Press ON/OFF button on the transmitter to switch the receiver ON/OFF
- c) If the LED indicator does not light when the ON/OFF button is pressed, please replace the battery

D. Caution

1. When the battery of transmitter is in low voltage, it influences product transmitting distance
