#### **RF Exposure Evaluation**

#### 2.4 GHz DTS Transmitter

### Description

Door mounted keycard entry system with 2 wireless RF transmitters.

One transmitter is a RFID transmitter operating at 125 KHz. The 125 KHz transmitter is a verification only device. All emissions are less than 470 kHz and greater than 40 dB below the limit.

The 2nd transmitter is a DSS transmitter operating at 2.4 GHz. Only one transmitter is transmitting at a time.

#### **Measurement Result**

Tuned Frequency	Radiated Peak Output Power	RF Exposure Limit
2405	0.000170 mW	24.948 mW
2440	0.0000693 mW	24.590 mW
2475	0.0000348 mW	24.242 mW

The peak output power is lower than the low threshold of 60/2405 MHz = (24.948 mW), for d<2.5 cm general population category.

The SAR measurement is not necessary.
