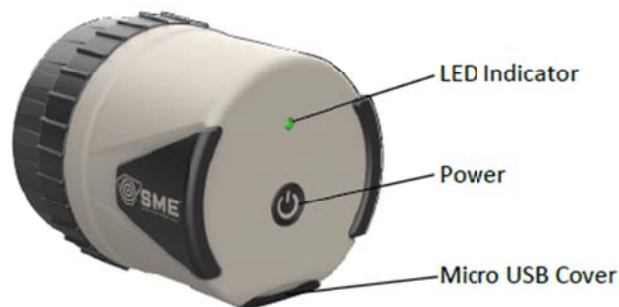


## Instruction Manual – Wifi Scope

Wirelessly streaming video to a compatible device via Wi-Fi as well as provide connectivity with the Cam APP. By attaching the Scope Wi-Fi to a spotting scope, using the spiral style grip, and using the Cam App to collect images, the end user is able to use any spotting scope



### Chuck Assembly

Centers and grips eyepiece

Fits eyepieces 25.4mm to 57.15mm

### Power ON

Long press the power button for 2 seconds to turn on the unit (Green LED is constant ON)

Turn ON Wifi on your mobile device(phone/tablet) and search the Wifi name

“Snapshot-CXXXXXX” and click connect.

### Power OFF

Long press the power button for 2 seconds to turn off the unit

### Charging while not at full charge

Red LED is constant ON

### Charging while at full charge

Green LED is constant ON

### Power ON and Unit is 10% useable battery life left

Red LED flashes every 3 seconds

### Micro USB port

Charging, power only

## **RF exposure statement**
