1 GENERAL

1.1 Purpose

The purpose of this report is to demonstrate compliance with Part 15 Subpart C of the FCC's Code of Federal Regulations for a Class II Permissive Change for the specific test requirements described in this document.

The purpose of the Class II Permissive change is to add a new antenna/host to the xG Technology Model xMaxW.

1.3 Product Description

The xG Technology Model xMaxW is a complete IEEE 802.11b/g radio solution. The EUT includes all radio components, clocking and regulation for a complete WLAN radio subsystem. The unit is integrated inside of xG technology host device model xVM (FCC ID: VEYXVMR1) which includes an ISM 900 MHz xMax radio transceiver.

Test Sample Condition: The samples were in good conditions with no observable physical damages.

1.4 Test Methodology and Considerations

The model xMaxW was evaluated for radiated emissions with the with the 2.4 GHz stubby monopole antenna while integrated inside of host device xVM. The evaluation was performed using the data rates listed as the worst case in the original certification. The radio configurations during the evaluation are reported below:

The unit was also evaluated for inter-modulation product emissions generated by simultaneous transmission with the co-located xMax 900 MHz radio. All intermodulation products were found to be compliant to the limits of FCC 15.209.

2.2 Laboratory Accreditations/Recognitions/Certifications

ACS is accredited to ISO/IEC 17025 by ANSI-ASQ National Accreditation Board under their ACLASS program and has been issued certificate number AT-1533 in recognition of this accreditation. 2.3 Radiated & Conducted Emissions Test Site Description

2.3.1 Semi-Anechoic Chamber Test Site

The EMC radiated test facility consists of an RF-shielded enclosure. The interior dimensions of the indoor semi-anechoic chamber are approximately 48 feet (14.6 m) long by 36 feet (10.8 m) wide by 24 feet (7.3 m) high and consist of rigid, 1/8 inch (0.32 cm) steel-clad, wood core modular panels with steel framing. In the shielded enclosure, the faces of the panels are galvanized and the chamber is self-supporting. 8-foot RF absorbing cones are installed on 4 walls and the ceiling. The steel-clad ground plane is covered with vinyl floor.

The turntable is driven by pneumatic motor, which is capable of supporting a 2000 lb. load. The turntable is flushed with the chamber floor which it is connected to, around its circumference, with a continuous metallic loaded spring. An EMCO Model 1050 Multi-device Controller controls the turntable position.

A pneumatic motor is used to control antenna polarizations and height relative to the ground. The height information is displayed on the control unit EMCO Model 1050.

The control room is an RF shielded enclosure attached to the semi-anechoic chamber with two bulkhead panels for connecting RF, and control cables. The dimension of the room is 7.3 m x 4.9 m x 3 m high and the entrance doors of both control and conducted rooms are 3 feet (0.91 m) by 7 feet (2.13 m).

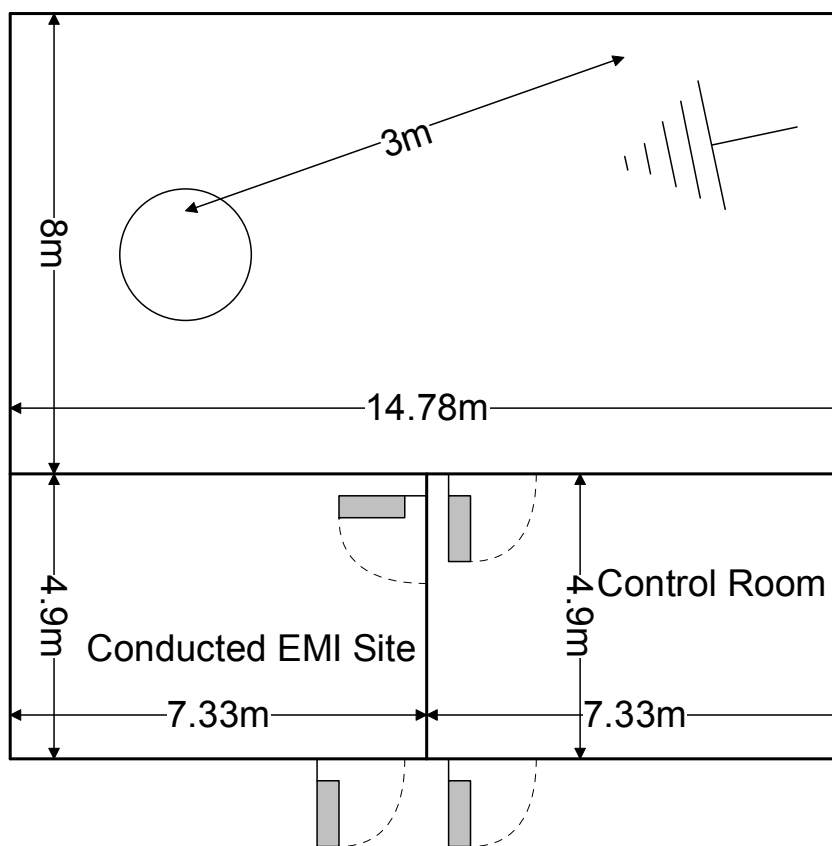


Figure 2.3.1-1: Semi-Anechoic Chamber Test Site

A diagram of the Semi-Anechoic Chamber Test Site is shown in Figure 2.3.1-1 below:

2.3.2 Conducted Emissions Test Site Description

The dimensions of the shielded conducted room are 7.3 x 4.9 x 3 m³. As per ANSI C63.4 2003 requirements, the data were taken using two LISNs; a Solar Model 8028-50 50 Ω /50 μ H and an EMCO Model 3825, which are installed as shown in Photograph 3. For 220 V, 50 Hz, a Polarad LISN (S/N 879341/048) is used in conjunction with a 1 kVA, 50 Hz/220 V EDGAR variable frequency generator, Model 1001B, to filter conducted noise from the generator.

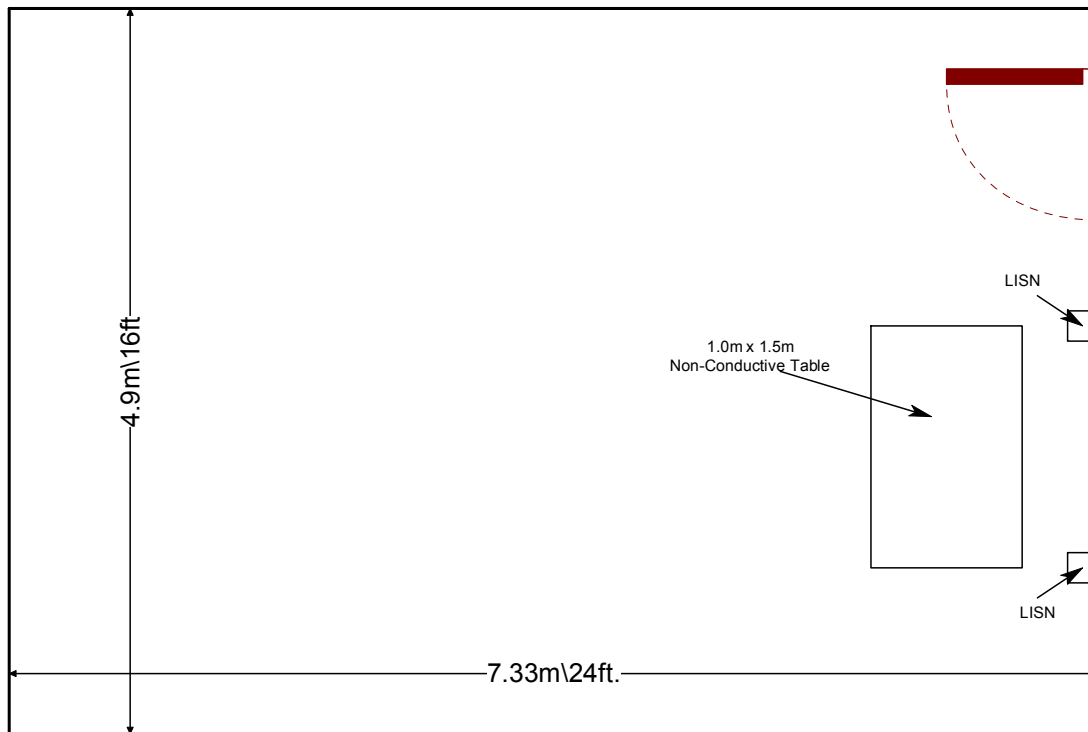


Figure 2.3.2-1: AC Mains Conducted EMI Site

A diagram of the room is shown below in figure 2.3.2-1:

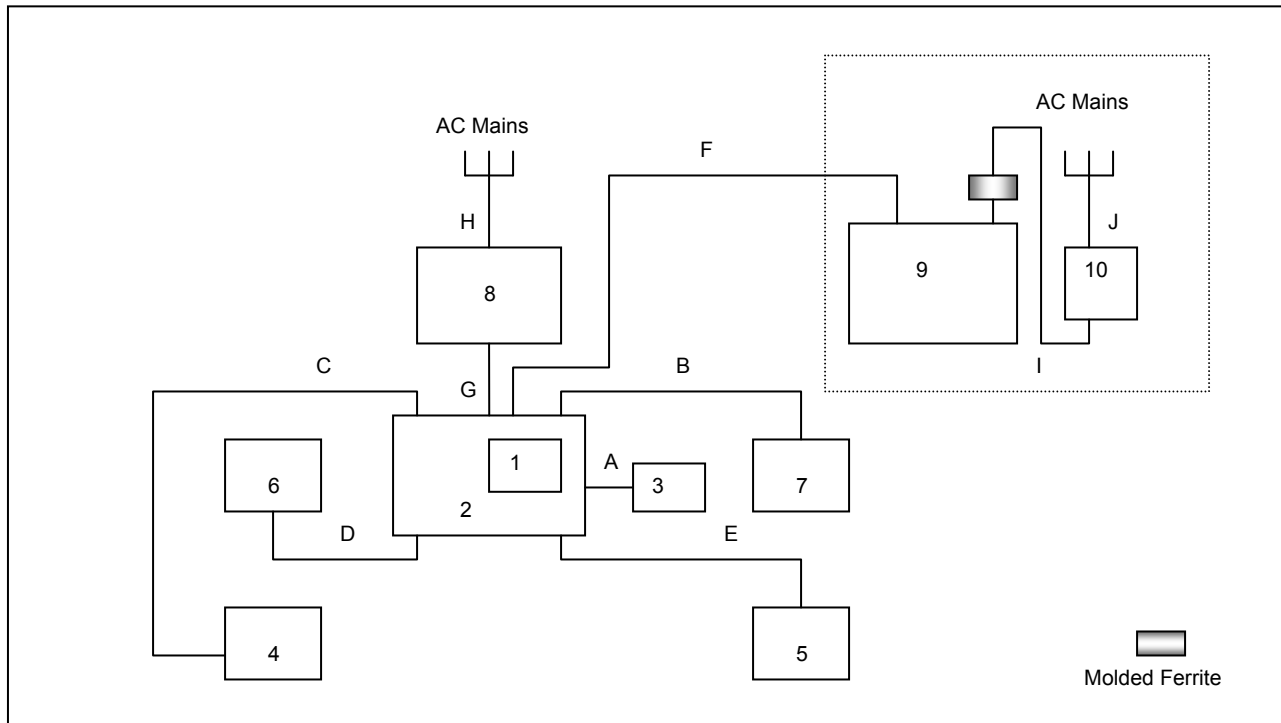

7 SUMMARY OF TESTS

Along with the tabular data shown below, plots were taken of all signals deemed important enough to document.

7.1 Antenna Requirement – FCC: Section 15.203

The xVM host device provides a TNC connector for the 2.4 GHz WLAN antenna. The host is professionally installed by an xG Technology personnel or subcontractor in a vehicular environment, thus meeting the requirements of Section 15.203.

7.2 Radiated Spurious Emissions - FCC Section 15.205

7.2.1.1 Measurement Procedure

Radiated emissions tests were made over the frequency range of 30 MHz to 26 GHz, 10 times the highest fundamental frequency.

The EUT was rotated through 360° and the receive antenna height was varied from 1m to 4m so that the maximum radiated emissions level would be detected. For frequencies below 1000MHz, quasi-peak measurements were made using a resolution bandwidth RBW of 120 kHz and a video bandwidth VBW of 300 kHz. For frequencies above 1000 MHz, peak measurements are made with RBW of 1 MHz and VBW of 3 MHz. Average measurements are performed in the linear scale using VBW of 30 Hz over a 5 second sweep.

7.2.1.2 Measurement Results

Radiated band-edge and spurious emissions found in the band of 30MHz to 26 GHz are reported in the tables below.

7.2.1.3 Sample Calculation:

$$R_C = R_U + CF_T$$

Where:

Example Calculation: Peak

Corrected Level: $58.5 + (-8.65) = 49.85 \text{ dB}\mu\text{V/m}$

Margin: $74 \text{ dB}\mu\text{V/m} - 49.85 \text{ dB}\mu\text{V/m} = 24.15 \text{ dB}$

Example Calculation: Average

Corrected Level: $45.08 + (-8.65) = 36.43 \text{ dB}\mu\text{V/m}$

Margin: $54 \text{ dB}\mu\text{V/m} - 36.43 \text{ dB}\mu\text{V/m} = 17.57 \text{ dB}$
