Is it a mandatory requirement to include the FCC 15.19(a)(3) statement (below) included in the device label or the manufacturer can op to include this statement in the user's manual only? Apple doesn't have this statement on the iPad or iPhone devices and we would like to follow the same rules.

"This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) this device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation."

The Apple I-phone device is tested to multiple rule parts as an unintentional radiator under part 15B Class B personal computers and peripherals and transmitters under Parts 22, 24 and Part 15.247. They certified the transmitters and used the DOC procedure for part 15B. This has a labeling requirement to include the FCC ID for the certification procedure and a FCC logo for the DOC procedure.

If your device is certified and also uses the DOC procedure you can also do the same as Apple.

If your device is only verified see 15.19 (5) which permits ?When the device is so small or for such use that it is not practicable to place the statement specified under paragraph (a) of this section on it, the information required by this paragraph shall be placed in a prominent location in the instruction manual or pamphlet supplied to the user or, alternatively, shall be placed on the container in which the device is marketed. However, the FCC identifier or the unique identifier, as appropriate, must be displayed on the device.?
