



Water Detector-Front






# How to use?- without the remote lead


You can use the Water Detector to monitor most appliances and pipes for leaks without the remote lead. Once paired with your Guardian Valve Controller, place the Water Detector on a flat surface under the item you want monitored where water

will collect if it leaks from above.

Water Detector can be made to rest against 3-1/4" base moulding for placement near






Use the remote lead with the Water Detector to detect leaks in hard-to-reach areas. The remote lead plugs into the Water Detector through the 3.5mm mini jack.
