CATEGORY 1 OR 2, 406 MHZ EPIRB**

Dear Mr. Jincheleau:

We have completed our review of your request, dated February 1, 2010, for approval of your SAFELINK AUTO and SAFELINK MANUAL+ 406 MHz beacons. Based on the information provided and the tests carried out, and in accordance with 47 CFR 80.1061 (c)(2), we conclude that the SAFELINK AUTO and SAFELINK MANUAL+ meet the relevant requirements of RTCM Standard 11000.2 (RTCM Paper 77-2002/SC110-STD) Standard for 406 MHz Satellite Emergency Position-Indicating Radiobeacons (EPIRBs), Version 2.1. The SAFELINK AUTO, equipped with an automatic float-free bracket, is designated as an RTCM Category 1 EPIRB, and the SAFELINK MANUAL+, with a manual release bracket, is designated as an RTCM Category 2 EPIRB; both models are COSPAS-SARSAT Class 2 (-20° C). We note that no other trade names have been provided for these EPIRBs. The Category 1 units may utilize a Hammar H2OE hydraulic release unit.
