

Test Procedures

AC Line Conducted Emission Test Procedure

The EUT operates from DC power only and offers no provision for connection to utility AC power systems. For testing purposes AC line conducted emissions testing was performed on the supporting laptop computer. Testing for the AC line-conducted emissions testing was performed as defined in sections 7 and 13.1.3 of ANSI C63.4-2009. The test setup including the EUT was arranged in typical equipment configurations and placed on a 1 x 1.5-meter wooden bench, 0.8 meters high located in a screen room. The power lines of the system were isolated from the power source using a standard LISN with a 50- μ Hy choke. EMI was coupled to the spectrum analyzer through a 0.1 μ F capacitor internal to the LISN. The LISN was positioned on the floor beneath the wooden bench supporting the EUT. The power lines and cables were draped over the back edge of the table.

Radiated Emission Test Procedure

The EUT was placed on a rotating 1 x 1.5-meter wooden platform, 0.8 meters above the ground plane at a distance of 3 meters from the FSM antenna. Testing for the radiated emissions was performed as defined in sections 8 and 13.1.4 of ANSI C63.4-2009. EMI energy was maximized by equipment placement, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken using a spectrum analyzer. Refer to photographs in the test setup exhibits for EUT placement during testing.

Summary of Results for Radiated Emissions in Restricted Bands

The EUT demonstrated compliance with the radiated emissions requirements of CFR 47 Part 15C Intentional Radiators. The EUT demonstrated a minimum margin of -0.1 dB below the radiated emissions requirements in restricted frequency bands. Peak, Quasi-peak, and average amplitudes were checked for compliance with the regulations. Worst-case emissions are reported with other emissions found in the restricted frequency bands at least 20 dB below the requirements.

AC Line Conducted Emissions Procedure

The EUT was arranged in the testing configuration, emulating a typical configuration, and placed on a 1 x 1.5-meter wooden bench 80 cm above the conducting ground plane, floor of a screen room. The bench was positioned 40 cm away from the wall of the screen room. The LISN was positioned on the floor of the screen room 80-cm from the rear of the EUT. The manufacturer supplied test support interface board was powered from DC supply and laptop powered from AC power adapter. The AC adapter for the laptop was connected to the LISN for AC line conducted emissions testing. A second LISN was positioned on the floor of the screen room 80-cm from the rear of the supporting equipment of the EUT. All power cords except the EUT were then powered from the second LISN. EMI was coupled to the spectrum analyzer through a 0.1 µF capacitor, internal to the LISN. Power line conducted emissions testing were carried out individually for each current carrying conductor of the EUT. The excess length of lead between the system and the LISN receptacle was folded back and forth to form a bundle not exceeding 40 cm in length. The screen room, conducting ground plane, analyzer, and LISN were bonded together to the protective earth ground. Preliminary testing was performed to identify the frequency of each radio frequency emission displaying the highest amplitude. The cables were repositioned to obtain maximum amplitude of measured EMI level. Once the worst-case configuration was identified, plots were made of the EMI from 0.15 MHz to 30 MHz then the data was recorded with maximum conducted emissions levels. Refer to figures one and two for plots of the EUT powered by AC adapter, AC Power Line conducted emissions.




Figure 1 AC Line Conducted Emissions Line 1




Figure 2 AC Line Conducted Emissions Line 2

General Radiated Emissions Procedure

The EUT was arranged in the testing configuration, emulating typical equipment configuration, with antenna ports loaded with 50-ohm restive loads and operated through all available modes with worst-case data recorded. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Plots were made of the radiated frequency spectrum from 30 MHz to 40,000 MHz for the preliminary testing. Refer to figures three through eleven for plots of the general radiated emissions spectrum taken in a screen room. Each radiated emission was then maximized at the OATS location before final radiated emissions measurements were performed. Final data was taken with the EUT located at the OATS at a distance of 3 meters between the EUT and the receiving antenna. The frequency spectrum from 30 MHz to 60,000 MHz was searched for general radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. Antennas used were Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 6000 MHz, Log Periodic from 200 MHz to 5 GHz and or double Ridge or pyramidal horns and mixers from 4 GHz to 60 GHz, notch filters and appropriate amplifiers and external mixers were utilized.




Figure 4 General Radiated Emissions taken at 1 meter in screen room




Figure 5 General Radiated Emissions taken at 1 meter in screen room




Figure 6 General Radiated Emissions taken at 1 meter in screen room




Figure 7 General Radiated Emissions taken at 1 meter in screen room




Figure 8 General Radiated Emissions taken at 1 meter in screen room




Figure 9 General Radiated Emissions taken at 1 meter in screen room




Figure 10 General Radiated Emissions taken at 1 meter in screen room




Figure 11 General Radiated Emissions taken at 1 meter in screen room

Operation in the Frequency Bands of 2400 – 2483.5 MHz and 5725 – 5850 MHz

The power output and emissions were measured at the antenna port in compliance with regulation. EUT emissions were also measured on the open area test site at a three-meter distance. The EUT and test configurations were placed on a wooden turntable 0.8 meters above the ground plane at a distance of 3 meters from the FSM antenna. The peak and quasi-peak amplitude of the frequencies below 1000 MHz were measured using a spectrum analyzer. 


Figure 12 Plot of Antenna Port Conducted (2 GHz, chain1, Operational Band, 5MHz Mode)




Figure 13 Plot of Antenna Port Conducted (2 GHz, chain1, Operational Band, 20MHz Mode)




Figure 14 Plot of Antenna Port Conducted (2 GHz, chain1, Operational Band, 40MHz Mode)




Figure 15 Plot of Antenna Port Conducted 6dB Band width (chain1, 2412 MHz, 5 MHz Mode)




Figure 16 Plot of Antenna Port Conducted 6dB Band width (chain1, 2437 MHz, 5 MHz Mode)




Figure 17 Plot of Antenna Port Conducted 6dB Band width (chain1, 2472 MHz, 5 MHz Mode)




Figure 18 Plot of Antenna Port Conducted 6dB Band width (chain1, 2412 MHz, 20 MHz Mode)




Figure 19 Plot of Antenna Port Conducted 6dB Band width (chain1, 2437 MHz, 20 MHz Mode,)




Figure 20 Plot of Antenna Port Conducted 6dB Band width (chain1, 2462 MHz, 20 MHz Mode)




Figure 21 Plot of Antenna Port Conducted 6dB Band width (chain1, 2422 MHz, 40 MHz Mode)




Figure 22 Plot of Antenna Port Conducted 6dB Band width (chain1, 2437 MHz, 40 MHz Mode)




Figure 23 Plot of Antenna Port Conducted 6dB Band width (chain1, 2452 MHz, 40 MHz Mode)




Figure 24 Plot of Antenna Port Conducted Power Spectral Density (chain1, 2412 MHz, 5 MHz Mode)




Figure 25 Plot of Antenna Port Conducted Power Spectral Density (chain1, 2437 MHz, 5 MHz Mode)




Figure 26 Plot of Antenna Port Conducted Power Spectral Density (chain1, 2472 MHz, 5 MHz Mode)




Figure 27 Plot of Antenna Port Conducted Power Spectral Density (chain1, 2412 MHz, 20 MHz Mode)




Figure 28 Plot of Antenna Port Conducted Power Spectral Density (chain1, 2437 MHz, 20 MHz Mode)




Figure 29 Plot of Antenna Port Conducted Power Spectral Density (chain1, 2462 MHz, 20 MHz Mode)




Figure 30 Plot of Antenna Port Conducted Power Spectral Density (chain1, 2422 MHz, 40 MHz Mode)




Figure 31 Plot of Antenna Port Conducted Power Spectral Density (chain1, 2437 MHz, 40 MHz Mode)




Figure 32 Plot of Antenna Port Conducted Power Spectral Density (chain1, 2452 MHz, 40 MHz Mode)




Figure 33 Plot of Antenna Port Conducted Emissions (2 GHz, chain1, Operation)




Figure 34 Plot of Antenna Port Conducted Emissions (2 GHz, chain1, Operation)




Figure 35 Plot of Antenna Port Conducted Emissions (2 GHz, chain1, Operation)




Figure 37 Plot of Antenna Port Conducted Emissions (2 GHz, chain1, Operation)

Figure 39 Plot of High Band Edge Compliance at Antenna Port (2 GHz, chain1, Operation)




Figure 40 Plot of Antenna Port Conducted (5GHz, chain1, Operational Band, 5MHz Mode)




Figure 41 Plot of Antenna Port Conducted (5GHz, chain1, Operational Band, 20MHz Mode)




Figure 42 Plot of Antenna Port Conducted (5GHz, chain1, Operational Band, 40MHz Mode)

Figure 43 Plot of Antenna Port Conducted 6dB Band width (chain 1, 5740 MHz, 5 MHz Mode)




Figure 44 Plot of Antenna Port Conducted 6dB Band width (chain 1, 5785 MHz, 5 MHz Mode)




Figure 45 Plot of Antenna Port Conducted 6dB Band width (chain 1, 5830 MHz, 5 MHz Mode)




Figure 46 Plot of Antenna Port Conducted 6dB Band width (chain 1, 5745 MHz, 20 MHz Mode)




Figure 47 Plot of Antenna Port Conducted 6dB Band width (chain 1, 5785 MHz, 20 MHz Mode)




Figure 48 Plot of Antenna Port Conducted 6dB Band width (chain 1, 5825 MHz, 20 MHz Mode)




Figure 49 Plot of Antenna Port Conducted 6dB Band width (chain 1, 5755 MHz, 40 MHz Mode)




Figure 50 Plot of Antenna Port Conducted 6dB Band width (chain 1, 5785 MHz, 40 MHz Mode)




Figure 51 Plot of Antenna Port Conducted 6dB Band width (chain 1, 5815 MHz, 40 MHz Mode)




Figure 52 Plot of Antenna Port Conducted Power Spectral Density (chain 1, 5740 GHz, 5MHz Mode)




Figure 53 Plot of Antenna Port Conducted Power Spectral Density (chain 1, 5785 GHz, 5MHz Mode)




Figure 54 Plot of Antenna Port Conducted Power Spectral Density (chain 1, 5830 GHz, 5MHz Mode)




Figure 55 Plot of Antenna Port Conducted Power Spectral Density (chain 1, 5745 GHz, 20MHz Mode)




Figure 56 Plot of Antenna Port Conducted Power Spectral Density (chain 1, 5785 GHz, 20MHz Mode)




Figure 57 Plot of Antenna Port Conducted Power Spectral Density (chain 1, 5825 GHz, 20MHz Mode)




Figure 58 Plot of Antenna Port Conducted Power Spectral Density (chain 1, 5755 GHz, 40MHz Mode)




Figure 59 Plot of Antenna Port Conducted Power Spectral Density (chain 1, 5785 GHz, 40MHz Mode)




Figure 60 Plot of Antenna Port Conducted Power Spectral Density (chain 1, 5815 GHz, 40MHz Mode)




Figure 61 Plot of Antenna Port Conducted Emissions (5 GHz, chain 1, operation)




Figure 62 Plot of Antenna Port Conducted Emissions (5 GHz, chain 1, operation)




Figure 63 Plot of Antenna Port Conducted Emissions (5 GHz, chain 1, operation)




Figure 64 Plot of Antenna Port Conducted Emissions (5 GHz, chain 1, operation)




Figure 65 Plot of Antenna Port Conducted Emissions (5 GHz, chain 1, operation)




Figure 66 Plot of Antenna Port Conducted Emissions (5 GHz, chain 1, operation)




Figure 67 Plot of Antenna Port Conducted Emissions (5 GHz, chain 1, operation)




Figure 68 Plot of Antenna Port Conducted Emissions (5 GHz, chain 1, operation)




Figure 69 Plot of Antenna Port Conducted Low Band Edge Compliance (5 GHz, chain1, operation)




Figure 70 Plot of Antenna Port Conducted High Band Edge Compliance (5 GHz, chain1, operation)




Figure 71 Plot of Antenna Port Conducted (2GHz, chain2, Operational Band, 5MHz Mode)




Figure 72 Plot of Antenna Port Conducted (2GHz, chain2, Operational Band, 20MHz Mode)




Figure 73 Plot of Antenna Port Conducted (2GHz, chain2, 2 Operational Band, 40MHz Mode)




Figure 74 Plot of Antenna Port Conducted 6dB Band width (chain2, 2412 MHz, 5 MHz Mode)




Figure 75 Plot of Antenna Port Conducted 6dB Band width (chain2, 2437 MHz, 5 MHz Mode)




Figure 76 Plot of Antenna Port Conducted 6dB Band width (chain2, 2472 MHz, 5 MHz Mode)




Figure 77 Plot of Antenna Port Conducted 6dB Band width (chain2, 2412 MHz, 20 MHz Mode)




Figure 78 Plot of Antenna Port Conducted 6dB Band width (chain2, 2437 MHz, 20 MHz Mode,)




Figure 79 Plot of Antenna Port Conducted 6dB Band width (chain2, 2462 MHz, 20 MHz Mode)




Figure 80 Plot of Antenna Port Conducted 6dB Band width (chain2, 2422 MHz, 40 MHz Mode)




Figure 81 Plot of Antenna Port Conducted 6dB Band width (chain2, 2437 MHz, 40 MHz Mode)




Figure 82 Plot of Antenna Port Conducted 6dB Band width (chain2, 2452 MHz, 40 MHz Mode)




Figure 83 Plot of Antenna Port Conducted Power Spectral Density (chain2, 2412 MHz, 5 MHz Mode)




Figure 84 Plot of Antenna Port Conducted Power Spectral Density (chain2, 2437 MHz, 5 MHz Mode)




Figure 85 Plot of Antenna Port Conducted Power Spectral Density (chain2, 2472 MHz, 5 MHz Mode)




Figure 86 Plot of Antenna Port Conducted Power Spectral Density (chain2, 2412 MHz, 20 MHz Mode)




Figure 87 Plot of Antenna Port Conducted Power Spectral Density (chain2, 2437 MHz, 20 MHz Mode)




Figure 88 Plot of Antenna Port Conducted Power Spectral Density (chain2, 2462 MHz, 20 MHz Mode)




Figure 89 Plot of Antenna Port Conducted Power Spectral Density (chain2, 2422 MHz, 40 MHz Mode)




Figure 90 Plot of Antenna Port Conducted Power Spectral Density (chain2, 2437 MHz, 40 MHz Mode)




Figure 91 Plot of Antenna Port Conducted Power Spectral Density (chain2, 2452 MHz, 40 MHz Mode)




Figure 92 Plot of Antenna Port Conducted Emissions (chain2, 2.4MHz Operation)




Figure 93 Plot of Antenna Port Conducted Emissions (chain2, 2.4MHz Operation)




Figure 94 Plot of Antenna Port Conducted Emissions (chain2, 2.4MHz Operation)




Figure 95 Plot of Antenna Port Conducted Emissions (chain2, 2.4MHz Operation)




Figure 96 Plot of Antenna Port Conducted Emissions (chain2, 2.4MHz Operation)




Figure 97 Plot of Low Band Edge Compliance at Antenna Port (chain2, 2.4MHz Operation)




Figure 98 Plot of High Band Edge Compliance at Antenna Port (chain2, 2.4MHz Operation)




Figure 99 Plot of Antenna Port Conducted (5GHz, chain2, Operational Band, 5MHz Mode)




Figure 100 Plot of Antenna Port Conducted (5GHz, chain2, Operational Band, 20MHz Mode)




Figure 101 Plot of Antenna Port Conducted (5GHz, chain2, Operational Band, 40MHz Mode)




Figure 102 Plot of Antenna Port Conducted 6dB Band width (chain2, 5740 MHz, 5 MHz Mode)




Figure 103 Plot of Antenna Port Conducted 6dB Band width (chain2, 5785 MHz, 5 MHz Mode)




Figure 105 Plot of Antenna Port Conducted 6dB Band width (chain2, 5745 MHz, 20 MHz Mode)




Figure 106 Plot of Antenna Port Conducted 6dB Band width (chain2, 5785 MHz, 20 MHz Mode)




Figure 107 Plot of Antenna Port Conducted 6dB Band width (chain2, 5825 MHz, 20 MHz Mode)




Figure 108 Plot of Antenna Port Conducted 6dB Band width (chain2, 5755 MHz, 40 MHz Mode)




Figure 109 Plot of Antenna Port Conducted 6dB Band width (chain2, 5785 MHz, 40 MHz Mode)




Figure 110 Plot of Antenna Port Conducted 6dB Band width (chain2, 5815 MHz, 40 MHz Mode)




Figure 111 Plot of Antenna Port Conducted Power Spectral Density (chain2, 5740 GHz, 5MHz Mode)




Figure 112 Plot of Antenna Port Conducted Power Spectral Density (chain2, 5785 GHz, 5MHz Mode)




Figure 113 Plot of Antenna Port Conducted Power Spectral Density (chain2, 5830 GHz, 5MHz Mode)




Figure 114 Plot of Antenna Port Conducted Power Spectral Density (chain2, 5745 GHz, 20MHz Mode)




Figure 115 Plot of Antenna Port Conducted Power Spectral Density (chain2, 5785 GHz, 20MHz Mode)




Figure 116 Plot of Antenna Port Conducted Power Spectral Density (chain2, 5825 GHz, 20MHz Mode)




Figure 117 Plot of Antenna Port Conducted Power Spectral Density (chain2, 5755 GHz, 40MHz Mode)




Figure 118 Plot of Antenna Port Conducted Power Spectral Density (chain2, 5785 GHz, 40MHz Mode)




Figure 119 Plot of Antenna Port Conducted Power Spectral Density (chain2, 5815 GHz, 40MHz Mode)




Figure 120 Plot of Antenna Port Conducted Emissions (5 GHz chain2, operation)




Figure 121 Plot of Antenna Port Conducted Emissions (5 GHz chain2, operation)




Figure 122 Plot of Antenna Port Conducted Emissions (5 GHz chain2, operation)




Figure 123 Plot of Antenna Port Conducted Emissions (5 GHz chain2, operation)




Figure 124 Plot of Antenna Port Conducted Emissions (5 GHz chain2, operation)




Figure 125 Plot of Antenna Port Conducted Emissions (5 GHz chain2, operation)




Figure 126 Plot of Antenna Port Conducted Emissions (5 GHz chain2, operation)




Figure 126 Plot of Antenna Port Conducted Emissions (5 GHz chain2, operation)




Figure 128 Plot of Antenna Port Conducted Low Band Edge Compliance (5 GHz chain2, operation)




Figure 129 Plot of Antenna Port Conducted High Band Edge Compliance (5 GHz chain2, operation)




Figure 130 Plot of Radiated Emissions at High Band Edge

Summary of Results for Transmitter Radiated Emissions of Intentional Radiator

The EUT demonstrated compliance with the conducted and radiated emissions requirements of CFR47 Part 15.247. Conducted antenna port power of 26.01 dBm, 0.4 Watts (chain 1), 25.89 dBm, 0.4 Watts (cahin2) was measured. The EUT demonstrated a minimum radiated emission margin of -0.2 dB below the harmonic emission requirements. There are no other significantly measurable emissions in the restricted bands other than those recorded in this report. Other emissions were present with amplitudes at least 20 dB below the requirements. The specifications of 15.247 were met; there are no deviations or exceptions to the requirements.

Statement of Modifications and Deviations

No modifications to the EUT were required for the unit to demonstrate compliance with the CFR47 Part 15C emissions standards. There were no deviations to the specifications.

Receiver Spurious Emissions

Receiver Antenna Power Conduction Limits

Receivers which provide terminals for the connection of an external receiving antenna may be tested to demonstrate compliance with the provisions of 15.109 and RSS-210 with the antenna terminals shielded and terminated with a termination equal to the impedance specified for the antenna, provided these receivers also comply with the following: With the receiver antenna terminal connected to a resistive termination equal to the impedance specified or employed for the antenna, the power at the antenna terminal at any frequency within the range of measurements specified shall not exceed 2.0 nanowatts (-57 dBm). The antenna port was connected to a spectrum analyzer for testing the antenna-conducted emissions. The antenna connection under test was connected to the spectrum analyzer through a short coaxial cable. The spectrum analyzer provided the 50-ohm load for the antenna port. 


Figure 131 Plot of Receiver Antenna Port Conducted Emissions




Figure 132 Plot of Receiver Antenna Port Conducted Emissions




Figure 133 Plot of Receiver Antenna Port Conducted Emissions




Figure 134 Plot of Receiver Antenna Port Conducted Emissions




Figure 135 Plot of Receiver Antenna Port Conducted Emissions




Figure 136 Plot of Receiver Antenna Port Conducted Emissions

Measurements shall be made to detect spurious emissions that may be radiated directly from the cabinet, control circuits, power leads, or intermediate circuit elements under normal conditions of installation and operation. The test setup was assembled in a screen room for preliminary screening. The transmitter was placed on a wooden turntable 0.8 meters above the ground plane and at a distance of 1 meter from the receive antenna, plots were taken of the radiated emissions. Final radiated emissions testing were performed with the transmitter placed on a wooden turntable 0.8 meters above the ground plane and at a distance of 3 meters from the Field Strength Measuring (FSM) antenna. The EUT was operational and radiating into the standard antenna as no antenna port connection is provided. The receiving antenna was raised and lowered from 1m to 4m in height to obtain the maximum reading of spurious radiation from the EUT. The turntable was rotated though 360 degrees to locate the position registering the highest amplitude of emission. The frequency spectrum was then searched for spurious emissions generated from the transmitter, interface cabling, and test setup. The amplitude of each spurious emission was maximized by raising and lowering the FSM antenna, and rotating the turntable before final data was recorded. The frequency spectrum from 30 MHz to 12,000 MHz was investigated during radiated emissions testing. A Biconilog antenna was used for frequency measurements of 30 to 6,000 MHz. A doubleridge horn antenna was used for frequencies of 5,000 MHz to 12,000 MHz. Emission levels were measured and recorded from the spectrum analyzer in dBµV. Data was taken at the Rogers Labs, Inc. 3 meters open area test site (OATS). A description of the test facility is on file with the FCC and Industry Canada (refer to annex for site registration letters).

The EUT was operated in all available test modes emulating worst-case operation while radiated emissions testing were performed. The amplitude of each spurious emission was maximized and amplitude levels recorded while operating at the open area test site at a distance of 3-meters.

Figure 137 Plot of Receiver Radiated Spurious Emissions taken at 1 meter




Figure 138 Plot of Receiver Radiated Spurious Emissions taken at 1 meter




Figure 139 Plot of Receiver Radiated Spurious Emissions taken at 1 meter




Figure 140 Plot of Receiver Radiated Spurious Emissions taken at 1 meter




Figure 141 Plot of Receiver Radiated Spurious Emissions taken at 1 meter




Figure 142 Plot of Receiver Radiated Spurious Emissions taken at 1 meter




Figure 143 Plot of Receiver Radiated Spurious Emissions taken at 1 meter




Figure 144 Plot of Receiver Radiated Spurious Emissions taken at 1 meter




Figure 145 Plot of Receiver Radiated Spurious Emissions taken at 1 meter
