# 6 Radio Spectrum Technical Requirement

## 6.1 Antenna Requirement

#### 6.1.1 Test Requirement:

FCC Part 15 Subpart C Section 15.247 & 15.203 RSS-Gen Section 8.3

#### 6.1.2 Conclusion

Standard Requirement:

Testing shall be performed using the highest gain antenna of each combination of licence-exempt transmitter and antenna type, with the transmitter output power set at the maximum level. When a measurement at the antenna connector is used to determine RF output power, the effective gain of the device's antenna shall be stated, based on a measurement or on data from the antenna manufacturer.

#### EUT Antenna:

The antenna is integrated on the main PCB and no consideration of replacement. The best case gain of the antenna is 0 dBi.





Test mode a :TX mode\_Keep the EUT in continuously transmitting mode with all modulation types. All data rates for each modulation type have been tested and found the data rate @ 1Mbps is the worst case of IEEE 802.11b; data rate @ 6Mbps is the worst case of IEEE 802.11b; data rate @ 6Mbps is the worst case of IEEE 802.11n(HT20)..11g; data rate @ 6.5Mbps is the worst case of IEEE 802.11n(HT20).

Only the data of worst case is recorded in the report.

### 7.1.2 Test Setup Diagram



#### 7.1.3 Measurement Procedure and Data

1) The mains terminal disturbance voltage test was conducted in a shielded room.

2) The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a  $500hm/50\mu$ H + 50hm linear impedance. The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded.

3) The tabletop EUT was placed upon a non-metallic table 0.8m above the ground reference plane. And for floor-standing arrangement, the EUT was placed on the horizontal ground reference plane,

4) The test was performed with a vertical ground reference plane. The rear of the EUT shall be 0.4 m from the vertical ground reference plane. The vertical ground reference plane was bonded to the horizontal ground reference plane. The LISN 1 was placed 0.8 m from the boundary of the unit under test and bonded to a ground reference plane for LISNs mounted on top of the ground reference plane. This distance was between the closest points of the LISN 1 and the EUT. All other units of the EUT and associated equipment was at least 0.8 m from the LISN 2.












#### 9.6 Conducted spurious emission

(Only worst case is shown below) Lowest Channel




**Middle Channel**
