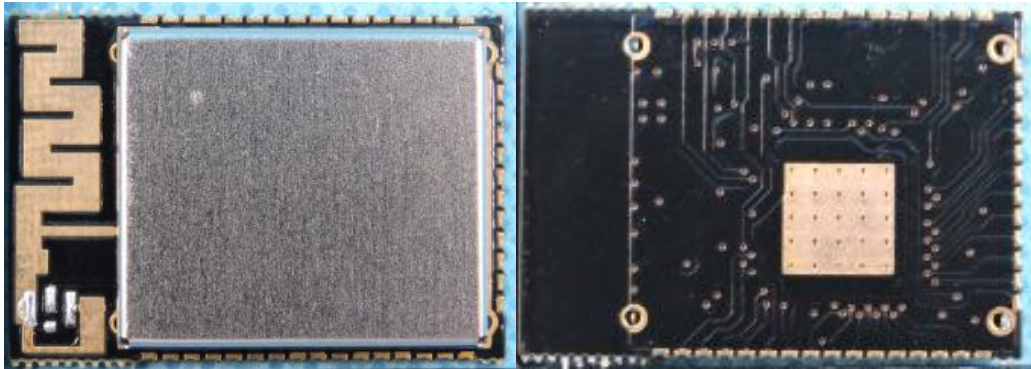
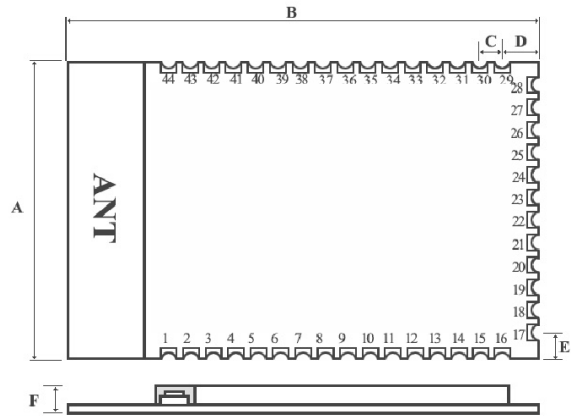

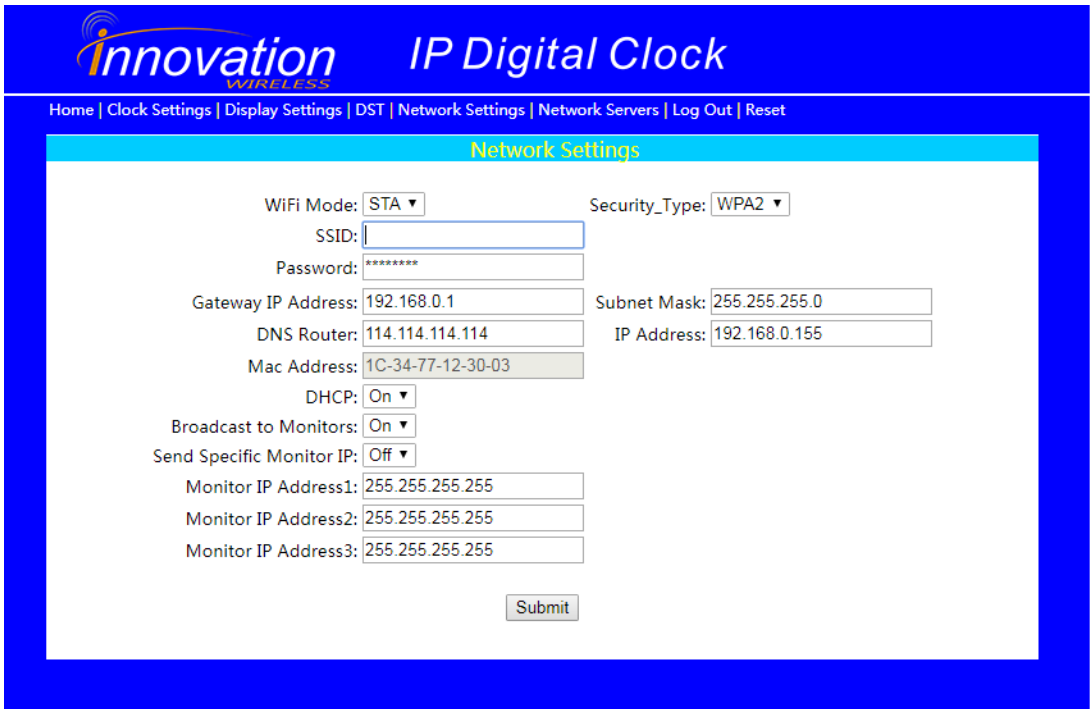

Quick start:

The module is easy to use. In order to allow users to quickly become familiar with the module, this section will guide the user through simple settings to achieve configuration and communication in various modes.

Power on enters AP mode (factory default AP mode). If the AP is not in the AP, you can enter AP mode by pressing and holding the AP/STA button. Open the WiFi-enabled computer or mobile phone to connect to the innovation-wifi device, enter 192.168.1.1 for parameter configuration, as shown below:

## FCC Statement

## FCC Radiation Exposure Statement

This modular complies with FCC RF radiation exposure limits set forth for an uncontrolled environment. This transmitter must not be co-located or operating in conjunction with any other antenna or transmitter. This modular must be installed and operated with a minimum distance of 20 cm between the radiator and user body.

If the FCC identification number is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module. This exterior label can use wording such as the following: "Contains Transmitter Module FCC ID: VMH-MEX1076 Or Contains FCC ID: VMH-MEX1076"

Any company of the host device which install this modular with Single modular approval should perform the test of radiated emission and spurious emission according to FCC part 15C : 15.247 and 15.209 requirement, Only if the test result comply with FCC part 15C : 15.247 and 15.209 requirement, then the host can be sold legally.

Note: 1. The OEM integrator has to be aware not to provide information to the end user regarding how to install or remove this RF module in the user's manual of the end product which integrates this module.

2. OEM integrator also need to responsible for Part 15 B compliance if necessary.
