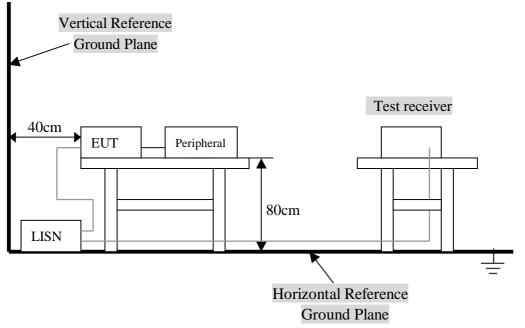

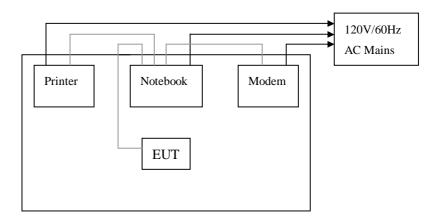
#### 4. 2 Test Procedure

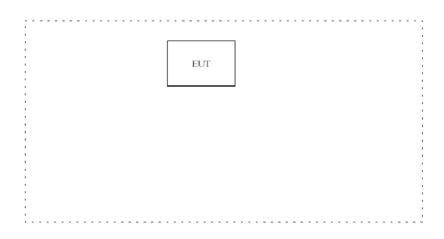

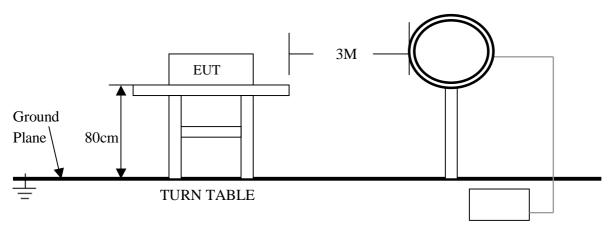

#### 5. 2 Test Procedure

- 1. The EUT was tested according to ANSI C63.4 2003.
- 2. The EUT, peripherals were put on the turntable which table size is 1m x 1.5 m, table high <u>0.8</u> m. All set up is according to ANSI C63.4-2003.
- 3. The frequency spectrum from <u>30</u> MHz to <u>1</u> GHz was investigated. All readings from <u>30</u> MHz to <u>1</u> GHz are quasi-peak values with a resolution bandwidth of <u>120</u> KHz. All readings are above <u>1</u> GHz, peak values with a resolution bandwidth of <u>1</u> MHz. Measurements were made at <u>3</u> meters.
- 4. The emissions from the EUT were measured continuously at every azimuth by rotating the turntable. The Receiving antenna high is varied from  $\underline{1}$  m to  $\underline{4}$  m high to find the maximum emission for each frequency. Emissions below 30MHz were measured with a loop antenna while emission above 30MHz were measured using a broadband E-field antenna.
- 5. Maximizing procedure was performed on the six (6) highest emissions to ensure EUT compliance is with all installation combinations. All data was recorded in the peak detection mode. Quasi-peak readings was performed only when an emission was found to be marginal (within -4 dB of specification limit), and are distinguished with a "**QP**" in the data table.
- 6. Both the horizontal and vertical field components were measured above 30 MHz while below 30 MHz the antenna was rotated in 3 axes.

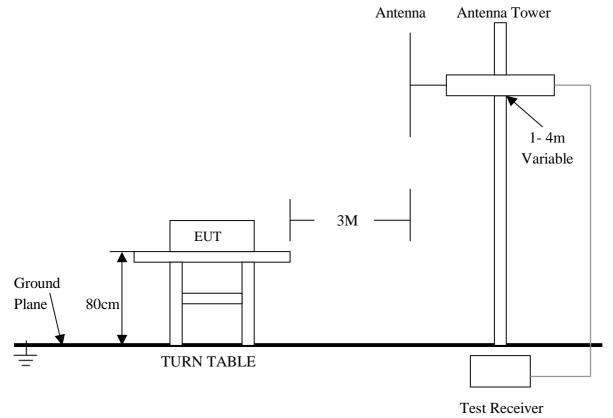

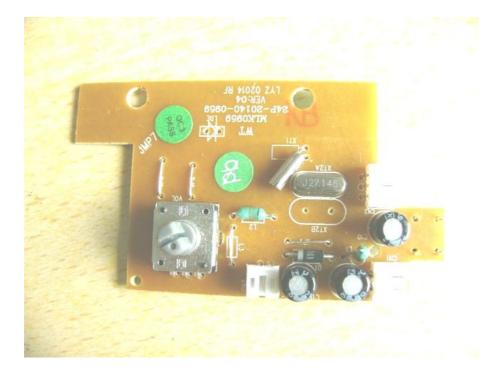

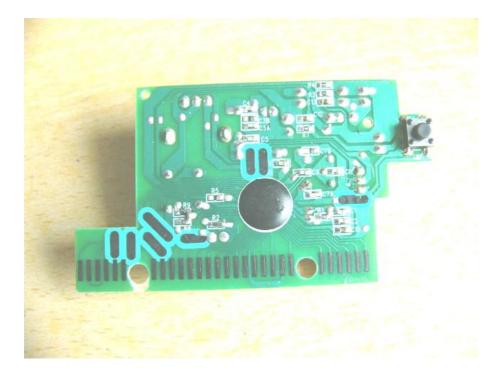
