Dear Ms. Dortch:

Intermap Technologies ("Intermap"), by its attorneys, hereby submits numerous items in support of its request for equipment authorization, listed specifically below. Due to their proprietary nature, Intermap requests that these items be withheld from public inspection and not be placed in the Commission's public files, pursuant to Section 552(b)(4) of Part 5 of the U.S. Code and Sections 0.457(d) and 0.459 of the Commission Rules.¹

These items, chiefly schematics and internal photos of Intermap's devices, contain information qualifying as trade secrets and commercial information that

would not routinely be made available for public inspection.² Specifically, they contain sensitive and protected intellectual property concerning Intermap's product design that, if disclosed, could be detrimental to Intermap's business. Non-parties could use knowledge of the information contained in these documents to replicate the unique technology. Intermap has taken measures to protect against disclosure of the information, including not allowing any public disclosure and not selling the equipment.
