Battery Replacement

1)



Prepare a CR2050 coin cell battery and a battery cover as shown above

2)



Place the coin-cell battery with positive terminal (+) face outwards.

3)



Adjust the battery cover as shown above (*triangle pointing at about 1'o clock*) so that >90% of the thickness of the cover is inserted into the casing (body).



Press a little bit and turning clockwise for tightening. (*Approximately 10 degree, there is a stopper so won't overturn*).



After tighten up the cover, it should be flush with the casing (body).
