## 2.6 TRANSMIT POWER CONTROL (TPC)

U-NII devices operating in the 5.25-5.35 GHz band and the 5.47-5.725 GHz band shall employ a TPC mechanism. The U-NII device is required to have the capability to operate at least 6 dB below the mean EIRP value of 30 dBm. A TPC mechanism is not required for systems with an e.i.r.p. of less than 500 mW.

Maximum E.I.R.P of this device is 427.6mW which less than 500mW, therefore it's not require TPC function.

## 2.7 STATEMENT OF MAUNFACTURER

This device (Client) is without radar detection, then the manufacturer statement confirming that information regarding the parameters of the detected Radar Waveforms is not available to the end user. **And the device doesn't have Ad Hoc mode on DFS frequency band.**

**Note 1:** This is the level at the input of the receiver assuming a 0 dBi receive antenna.

**Note 2:** Throughout these test procedures an additional 1 dB has been added to the amplitude of the test transmission waveforms to account for variations in measurement equipment. This will ensure that the test signal is at or above the detection threshold level to trigger a DFS response.

**Note 1:** The instant that the Channel Move Time and the Channel Closing Transmission Time begins is as follows:

- For the Short Pulse Radar Test Signals this instant is the end of the Burst.
- For the Frequency Hopping radar Test Signal, this instant is the end of the last radar Burst generated.
- For the Long Pulse Radar Test Signal this instant is the end of the 12 second period defining the Radar Waveform.

**Note 2:** The Channel Closing Transmission Time is comprised of 200 milliseconds starting at the beginning of the Channel Move Time plus any additional intermittent control signals required to facilitate a Channel move (an aggregate of 60 milliseconds) during the remainder of the 10 second period. The aggregate duration of control signals will not count quiet periods in between transmissions.

**Note 3:** During the U-NII Detection Bandwidth detection test, radar type 1 is used and for each frequency step the minimum percentage of detection is 90 percent. Measurements are performed with no data traffic.

## PARAMETERS OF DFS TEST SIGNALS

Step intervals of 0.1 microsecond for Pulse Width, 1 microsecond for PRI, 1 MHz for chirp width and 1 for the number of pulses will be utilized for the random determination of specific test waveforms.

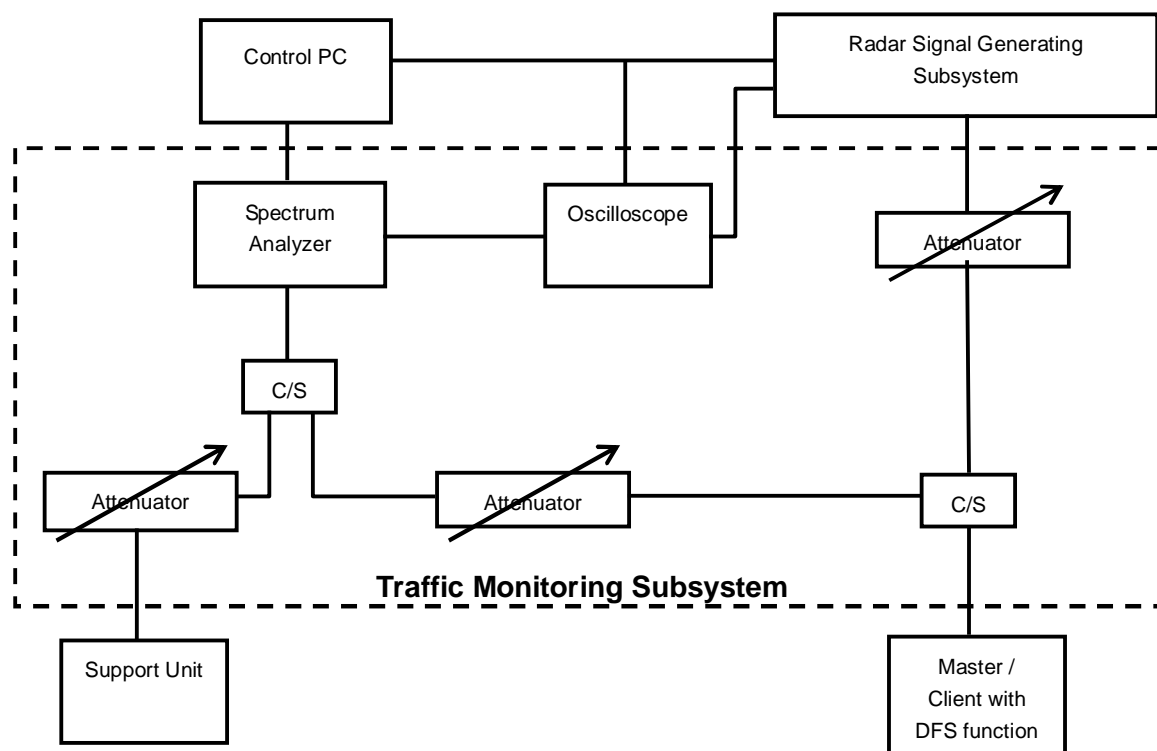

## 5. TEST PROCEDURE

### 5.1 BV-ADT DFS MEASUREMENT SYSTEM:

A complete BV-ADT DFS Measurement System consists of two subsystems: (1) the Radar Signal Generating Subsystem and (2) the Traffic Monitoring Subsystem. The control PC is necessary for generating the Radar waveforms in Table 6, 7 and 8. The traffic monitoring subsystem is specified to the type of unit under test (UUT).

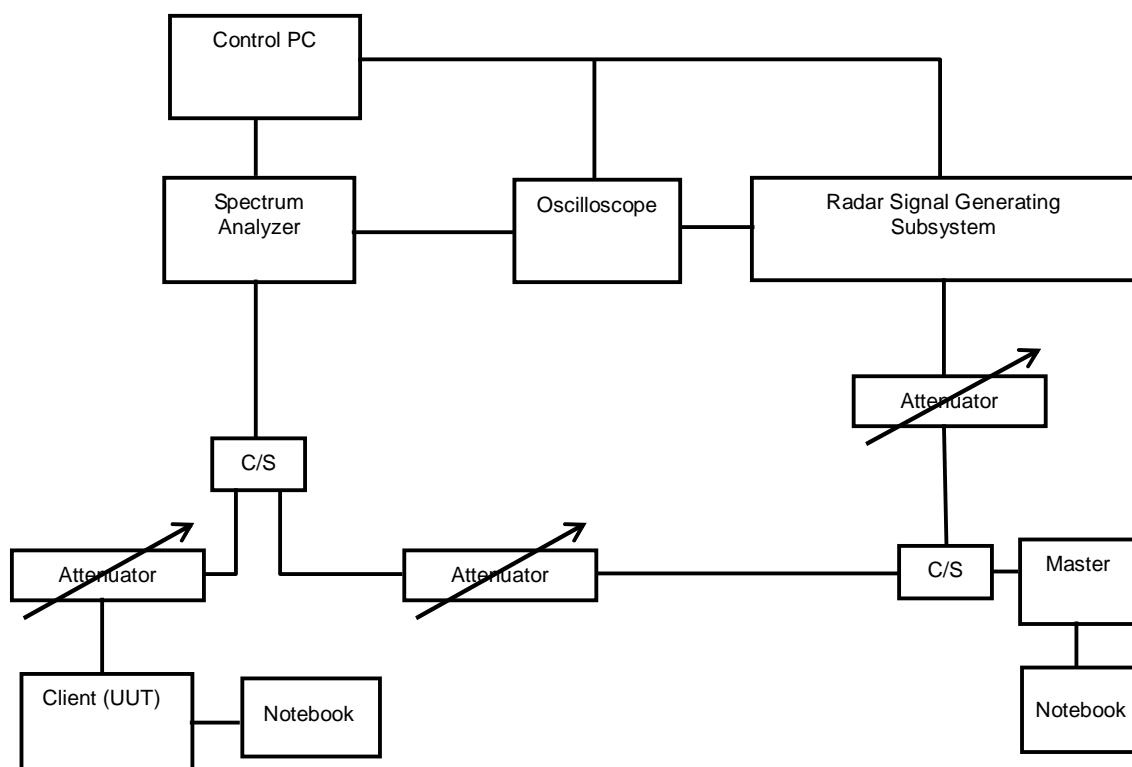

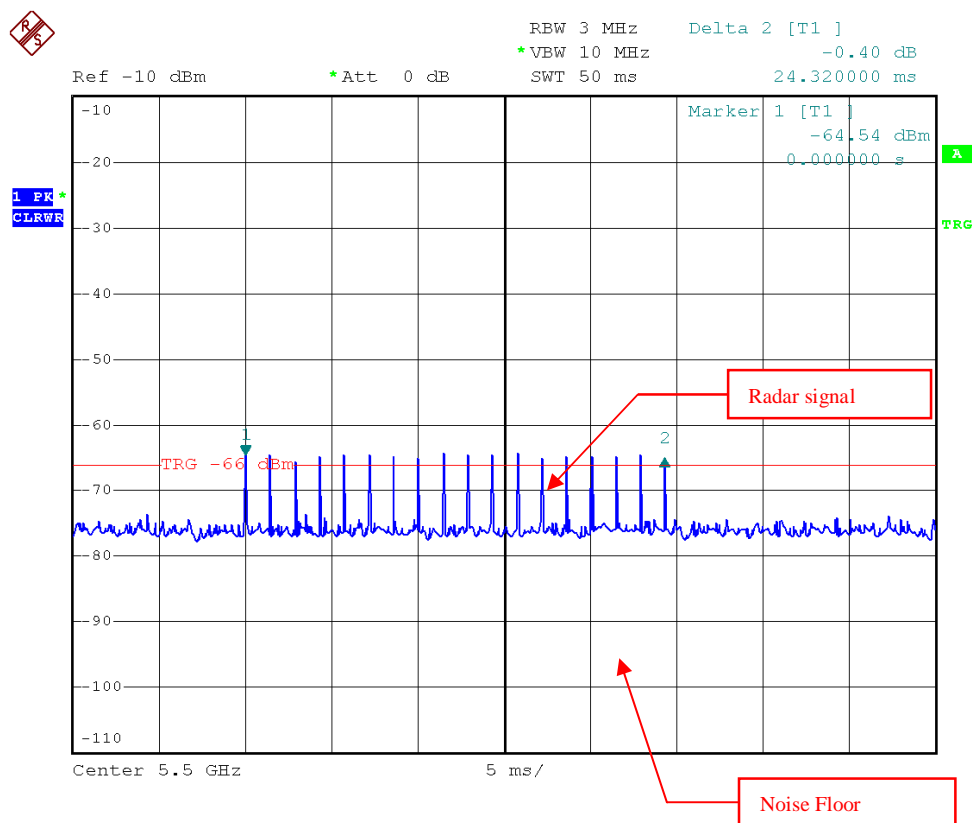

#### 6.2.1.1 DFS DETECTION THRESHOLD

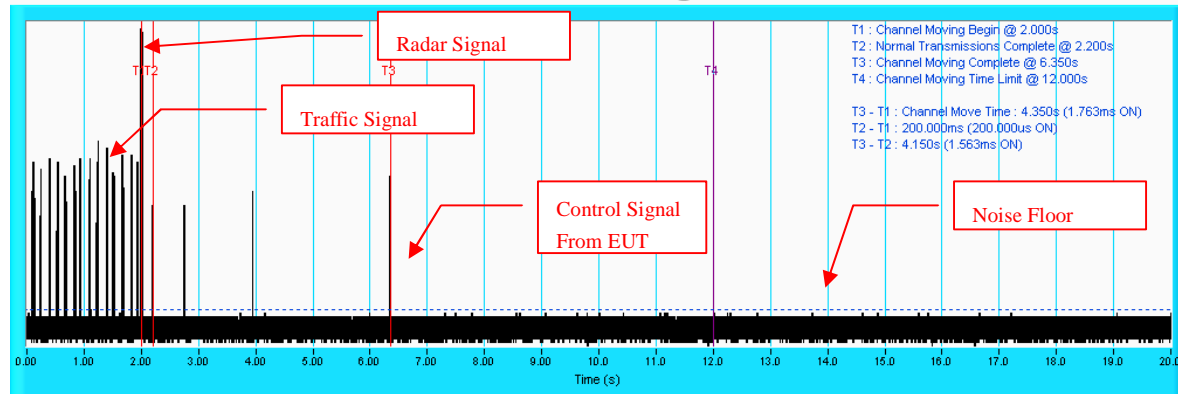
For a detection threshold level of  $-62\text{dBm}$  and the Master antenna gain is  $-3.38\text{dBi}$ . The Required detection threshold is  $-64.38\text{dBm}$  ( $= -62 + 1 - 3.38$ ) $\text{dBm}$ . The conducted radar burst level is set to  $-64.38\text{dBm}$ .



Radar Signal 1

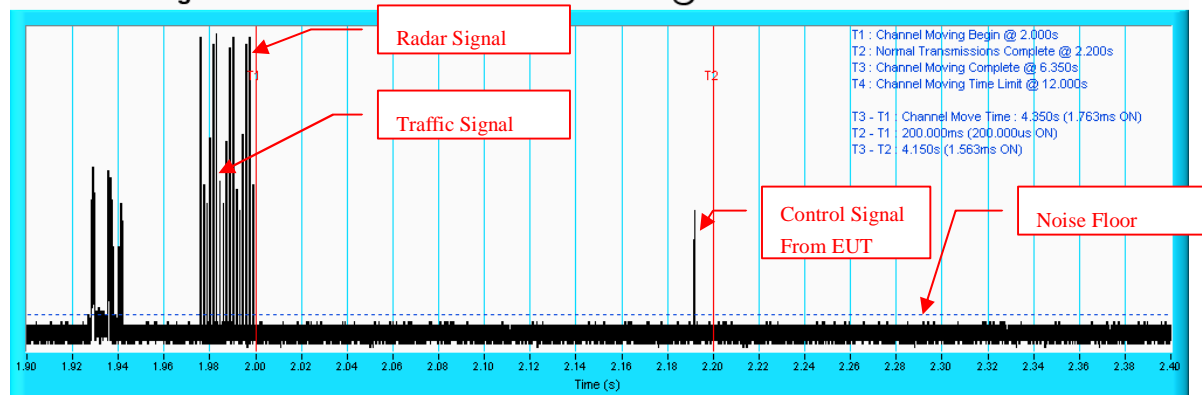

Channel Closing Transmission Time & Channel Move Time @ CH102 - 5510MHz

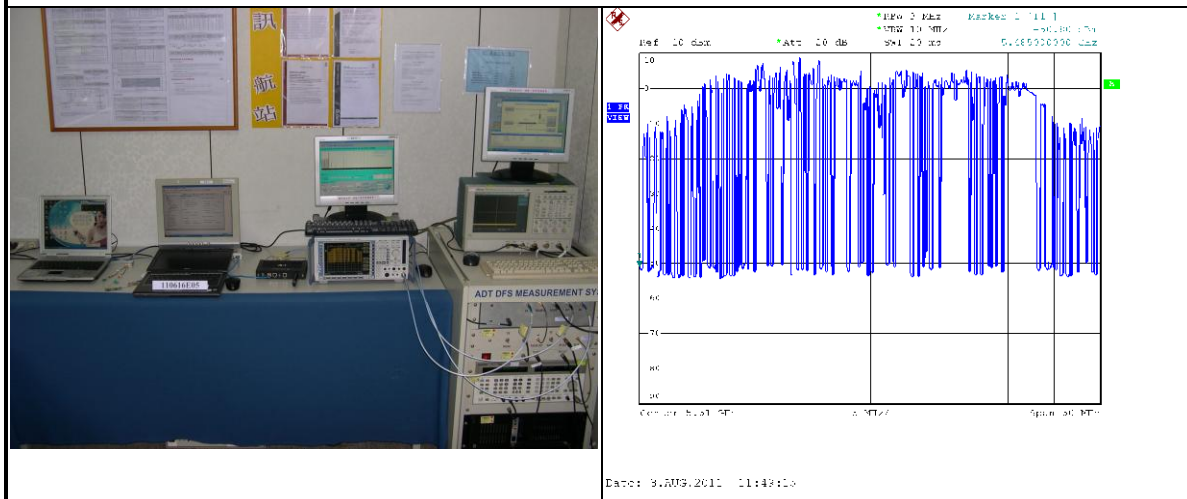

Non - Occupancy Period @ CH102 - 5510MHz

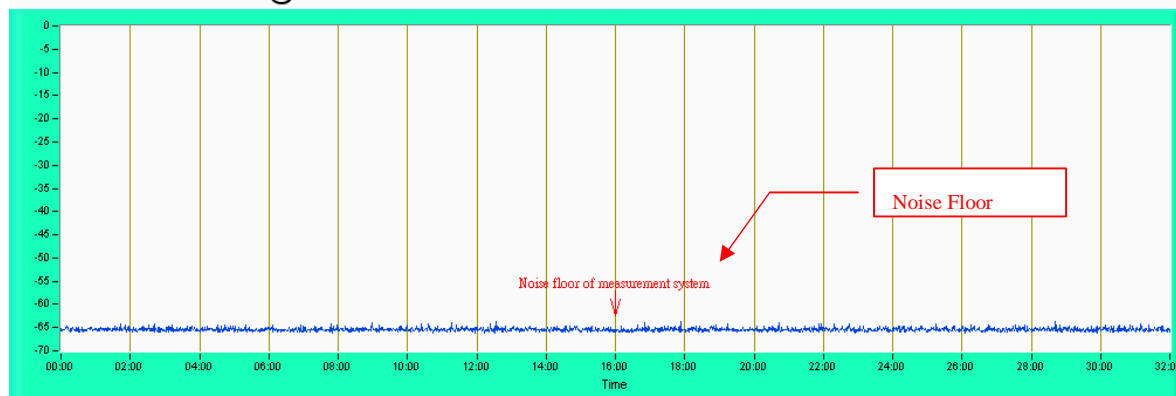

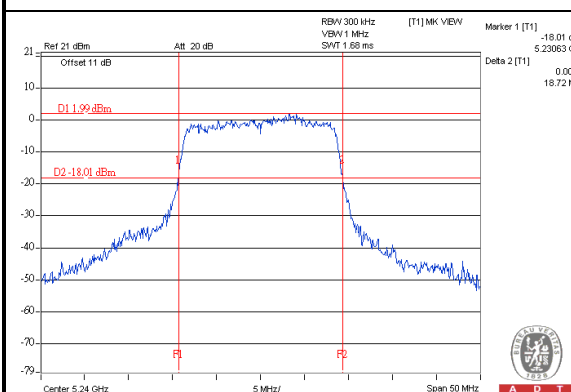
EUT (Client ) links with master on 11n HT20 mode



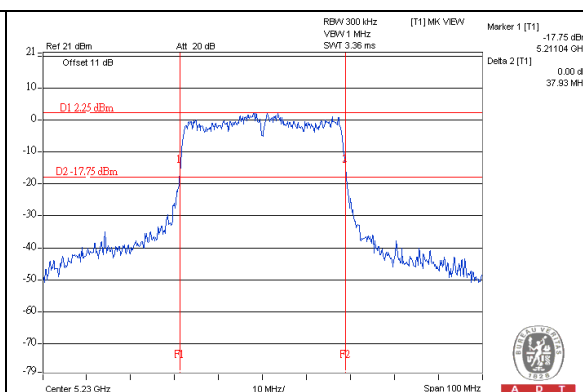
EUT (Client ) links with master on 11n HT40 mode

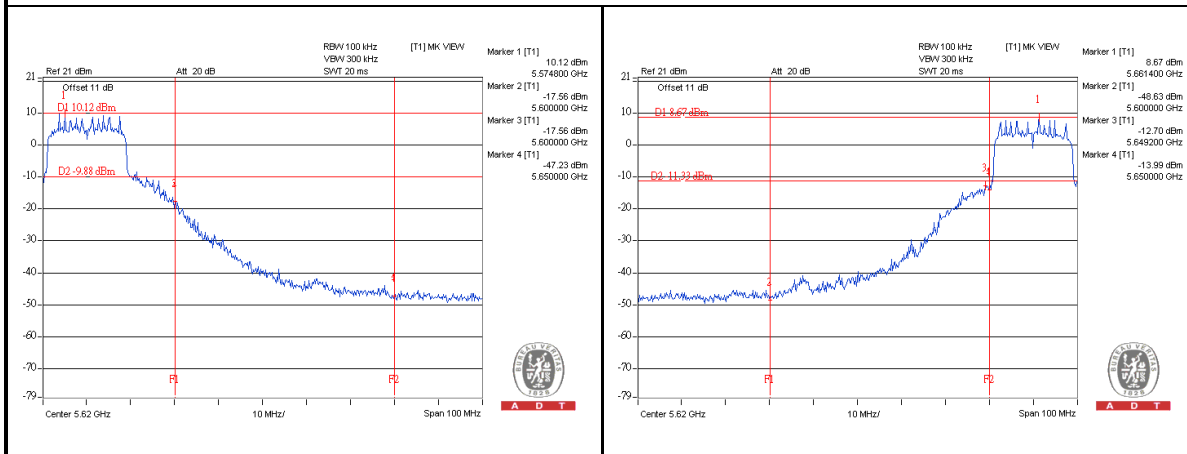

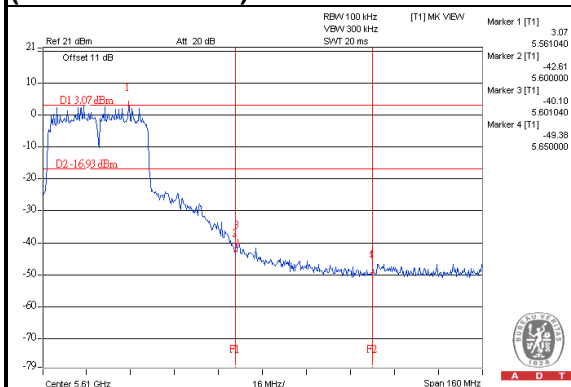

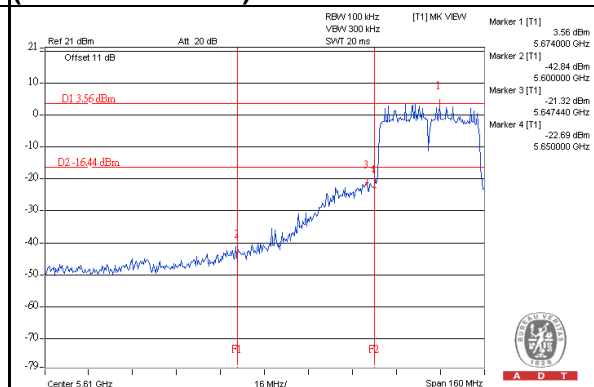

### 802.11n (20MHz) OFDM MODULATION (CH 116: 5580MHz)



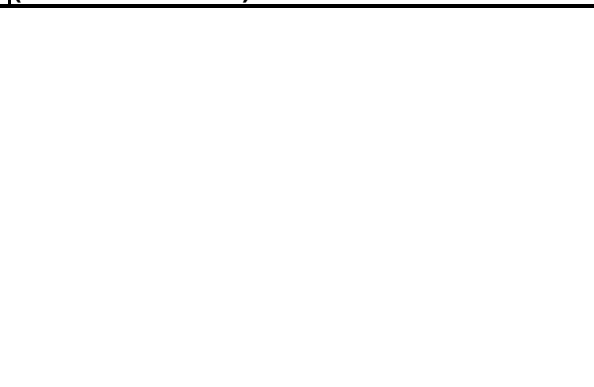
### 802.11n (20MHz) OFDM MODULATION (CH 132: 5660MHz)
