#### 2.6 Transmit Power Control (TPC)

U-NII devices operating in the 5.25-5.35 GHz band and the 5.47-5.725 GHz band shall employ a TPC mechanism. The U-NII device is required to have the capability to operate at least 6 dB below the mean EIRP value of 30 dBm. A TPC mechanism is not required for systems with an e.i.r.p. of less than 500 mW.

Maximum EIRP of this device is 6.266 mW which less than 500mW, therefore it's not require TPC function.

#### 2.7 Statement of Maunfacturer

Manufacturer statement confirming that information regarding the parameters of the detected Radar Waveforms is not available to the end user. And the device doesn't have Ad Hoc mode on DFS frequency band.




#### 5. Test Procedure

#### 5.1 DFS Measurement System

A complete DFS Measurement System consists of two subsystems: (1) the Radar Signal Generating Subsystem and (2) the Traffic Monitoring Subsystem. The control PC is necessary for generating the Radar waveforms in Table 10, 11 and 12. The traffic monitoring subsystem is specified to the type of unit under test (UUT).


#### Radiated Setup Configuration of DFS Measurement System

	b) Software to ping the client is permitted to simulate data transfer but must have random ping intervals.


### Wireless Traffic Loading



#### 5.2 Calibration of DFS Detection Threshold Level

The measured channel is 5500MHz. The radar signal was the same as transmitted channels, and injected into the antenna of AP (master) or Client Device with Radar Detection, measured the channel closing transmission time and channel move time. The calibrated detection threshold level is set to -64dBm. The tested level is lower than required level hence it provides margin to the limit.

#### Radiated setup configuration of Calibration of DFS Detection Threshold Level






**Channel Closing Transmission Time & Channel Move Time**


