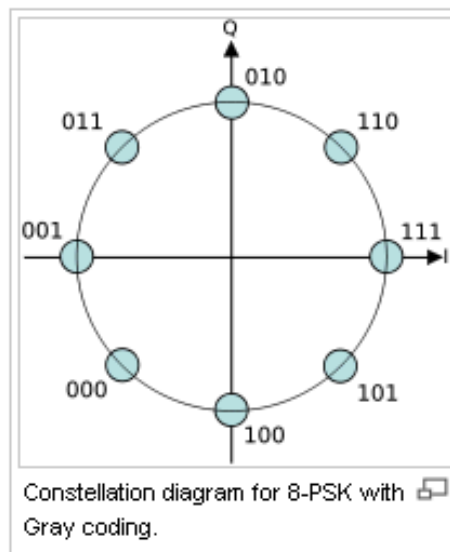

## 7.2 Antenna Requirement

### Standard requirement

15.203 requirement:

For intentional device. According to 15.203. an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

15.247(c) (1)(i) requirement:

(i) Systems operating in the 2400-2483.5 MHz bands that are used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

### EUT Antenna

The antenna is integrated on the main PCB and no consideration of replacement. The best case gain of the antenna is 2 dBi.

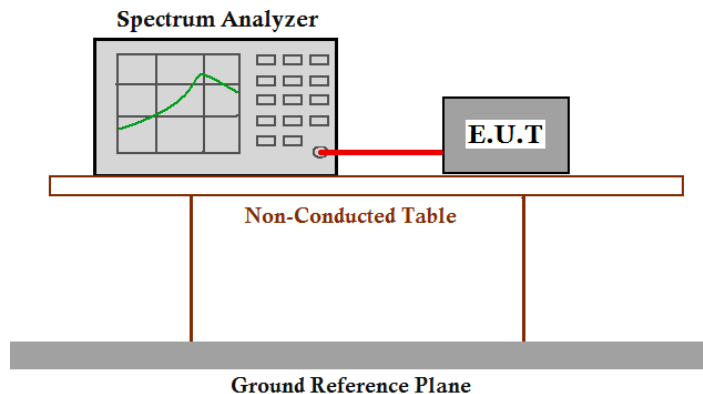

**Test Status:** Pre-test the EUT in continuous transmitting mode at the lowest (2402 MHz), middle (2441 MHz) and highest (2480 MHz) channel with different data package. Compliance test in normal mode (DH5) and EDR mode (3DH5) as the worst case was found.

**Test Configuration:**



**Test Procedure:**

1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum;
2. Set the spectrum analyzer: Span = approximately 2 to 3 times the 20Db bandwidth, centring on a hopping channel;
3. Set the spectrum analyzer: RBW  $\geq$  1% of the 20dB bandwidth VBW  $\geq$  RBW. Sweep = auto; Detector Function = Peak. Trace = Max Hold.
4. Mark the peak frequency and -20 dB points bandwidth.

1. Remove the antenna from the EUT and then connect a low attenuation RF cable from the antenna port to the spectrum.
2. Set the spectrum analyzer: RBW  $\geq$  1% of the span, VBW  $\geq$  RBW, Sweep = auto; Detector Function = Peak. Trace = Max, hold.
3. Allow the trace to stabilize. Use the marker-delta function to determine the separation between the peaks of the adjacent channels. The limit is specified in one of the subparagraphs of this Section. Submit this plot.

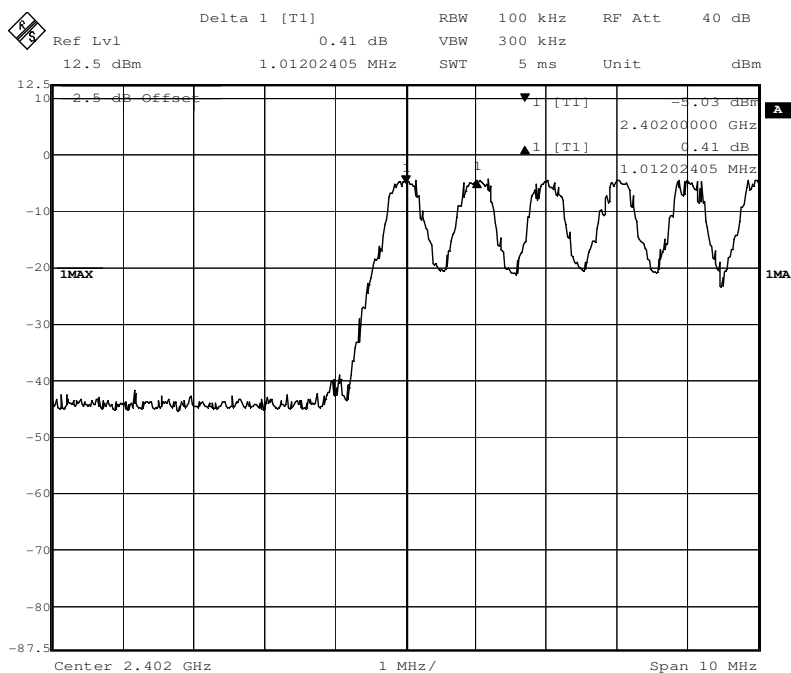

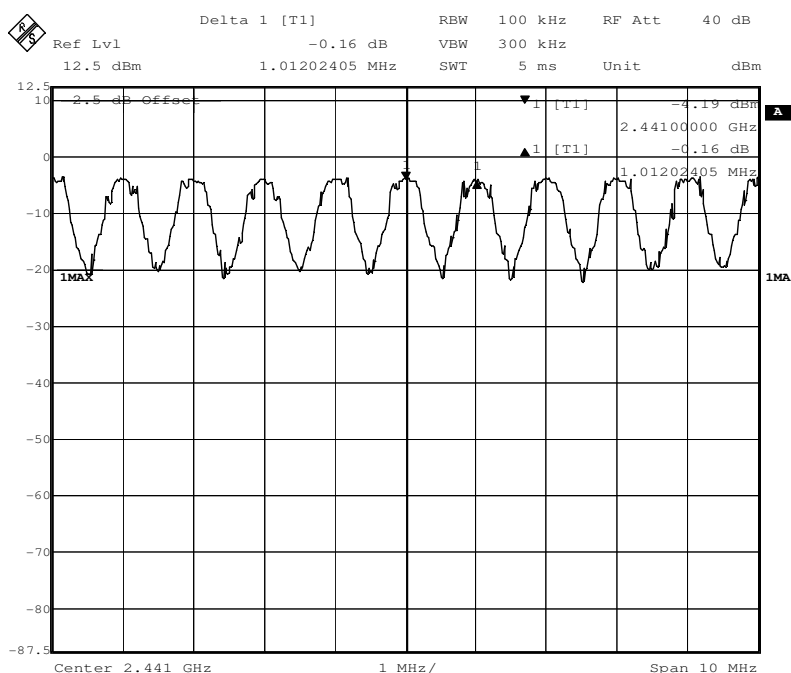

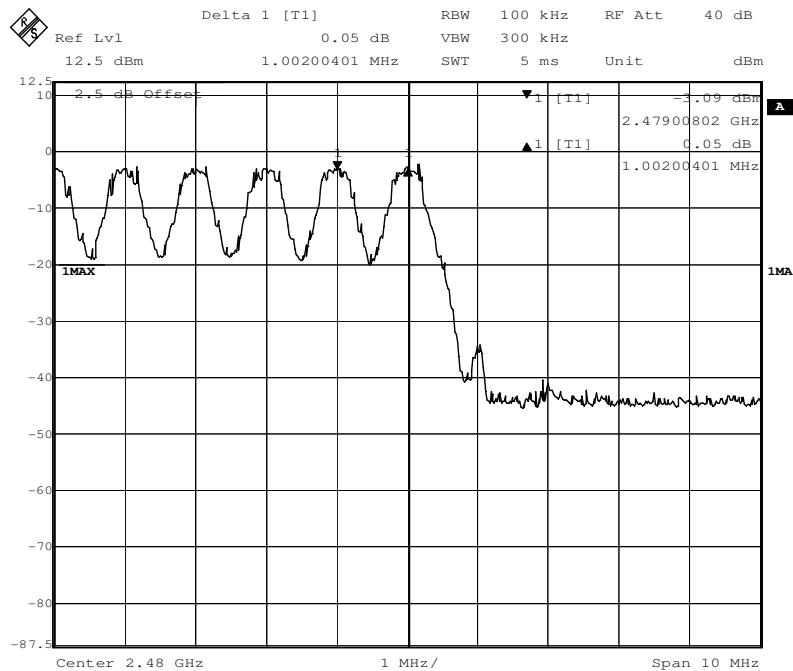


Middle Channels: **Carrier Frequencies Separated**

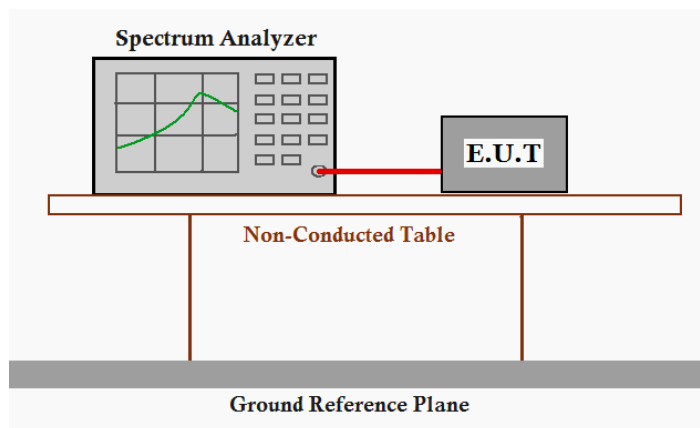

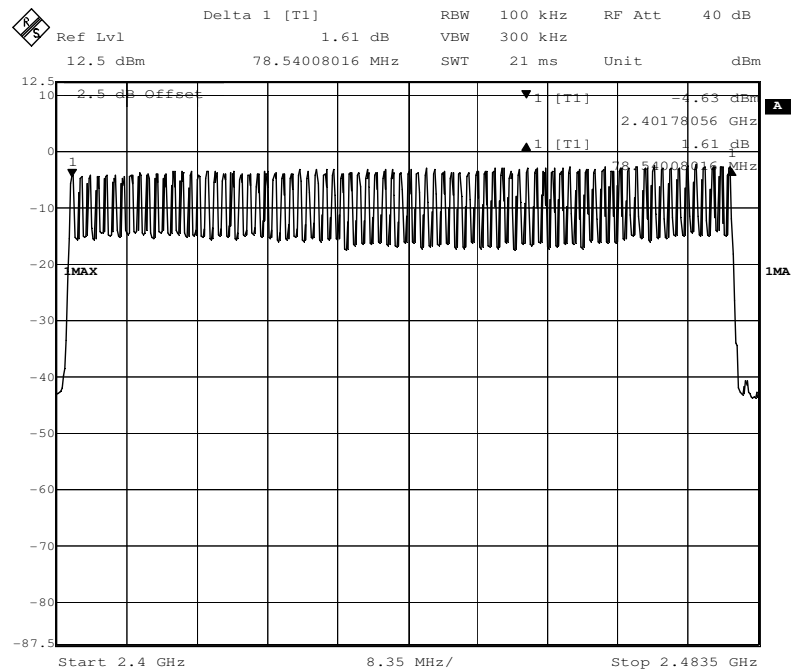


### Test Procedure:

1. Remove the antenna from the EUT and then connect a low attenuation RF cable from the antenna port to the spectrum.
2. Set the spectrum analyzer: RBW = 100 kHz. VBW = 100 kHz. Sweep = auto; Detector Function = Peak. Trace = Max hold.
3. Allow the trace to stabilize. It may prove necessary to break the span up to sections. in order to clearly show all of the hopping frequencies. The limit is specified in one of the subparagraphs of this Section.
4. Set the spectrum analyzer: start frequency = 2400 MHz. stop frequency = 2483.5 MHz. Submit the test result graph.

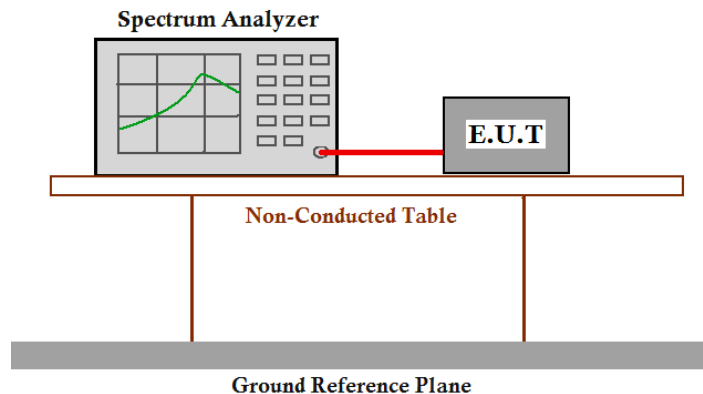

The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. ## 7.7 Pseudorandom Frequency Hopping Sequence

### 7.7.1 Standard requirement

15.247(a)(1) requirement:

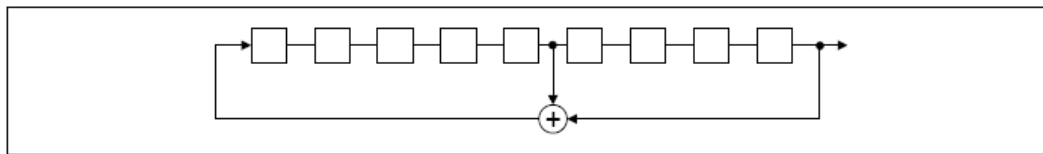
Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater.

Alternatively. Frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW. The system shall hop to channel frequencies that are selected at the system hopping rate from a Pseudorandom ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.

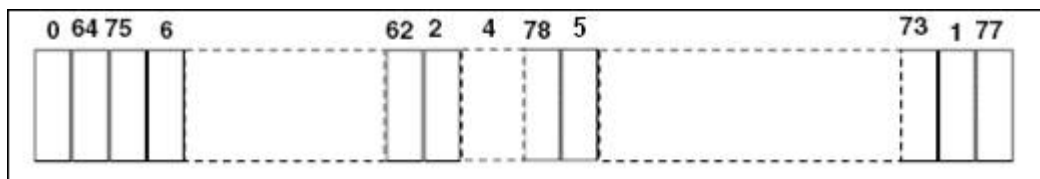
The pseudorandom sequence may be generated in a nine-stage shift register whose 5th and 9<sup>th</sup> stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the first stage. The sequence begins with the first ONE of 9 consecutive ONES; i.e. the shift register is initialized with nine ones.

- Length of pseudo-random sequence:  $2^9 - 1 = 511$  bits
- Longest sequence of zeros: 8 (non-inverted signal)

**Test Procedure:** The receiver scanned from the lowest frequency generated within the EUT to 25GHz. When an emission was found, the table was rotated to produce the maximum signal strength. An initial pre-scan was performed for in peak detection mode using the receiver. The EUT was measured for both the Horizontal and Vertical polarities and performed a pre-test three orthogonal planes. For intentional radiators, measurements of the variation of the input power or the radiated signal level of the fundamental frequency component of the emission, as appropriate, shall be performed with the supply voltage varied between 85% and 115% of the nominal rated supply voltage. For hand-held or body-worn devices rotated through three orthogonal axes(X,Y,Z) to determine which attitude (orientation) and equipment arrangement produces the highest emission relative to the limit; the attitude and equipment arrangement that produces the highest emission relative to the limit was used in making final radiated emission measurements.

Now set the VBW to 10 Hz, while maintaining all of the other instrument settings. This peak level, once corrected, must comply with the limit specified in Section 15.209. If the dwell time per channel of the hopping signal is less than 100 ms, then the reading obtained with the 10 Hz VBW may be further adjusted by a "duty cycle correction factor", derived from  $20\log(\text{dwell time}/100 \text{ ms})$ , in an effort to demonstrate compliance with the 15.209 limit.

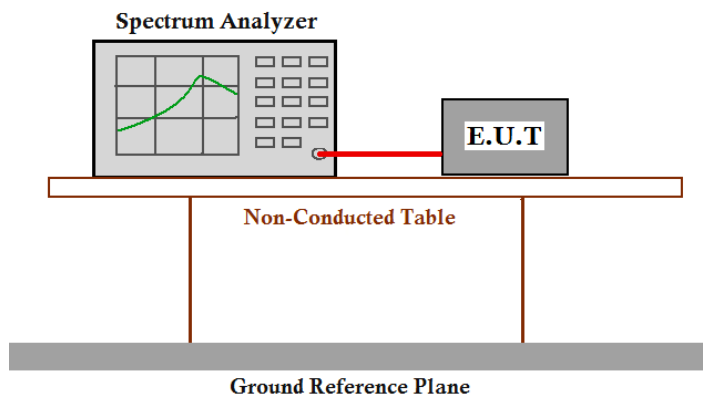
(d) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in Section 15.209(a) is not required. ### Test procedure:

1. The mains terminal disturbance voltage test was conducted in a shielded room.
2. The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a  $50\Omega/50\mu\text{H} + 5\Omega$  linear impedance. The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded.
3. The tabletop EUT was placed upon a non-metallic table 0.8m above the ground reference plane. And for floor-standing arrangement, the EUT was placed on the horizontal ground reference plane, but separated from metallic contact with the ground reference plane by 0.1m of insulation.
4. The test was performed with a vertical ground reference plane. The rear of the EUT shall be 0.4 m from the vertical ground reference plane. The vertical ground reference plane was bonded to the horizontal ground reference plane. The LISN 1 was placed 0.8 m from the boundary of the unit under test and bonded to a ground reference plane for LISNs mounted on top of the ground reference plane. This distance was between the closest points of the LISN 1 and the EUT. All other units of the EUT and associated equipment was at least 0.8 m from the LISN 2.

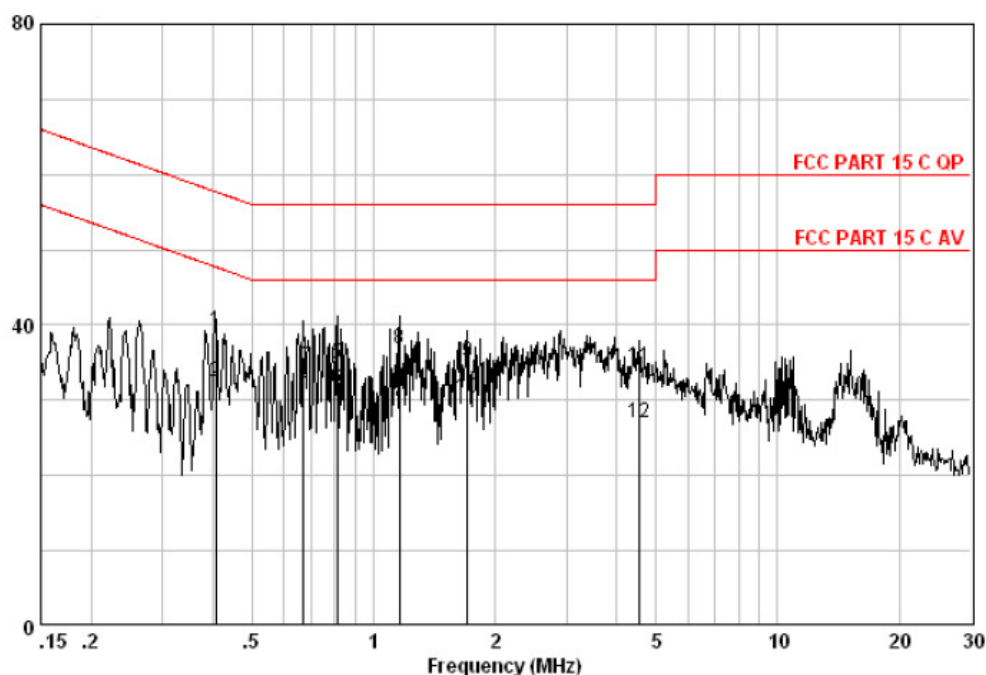

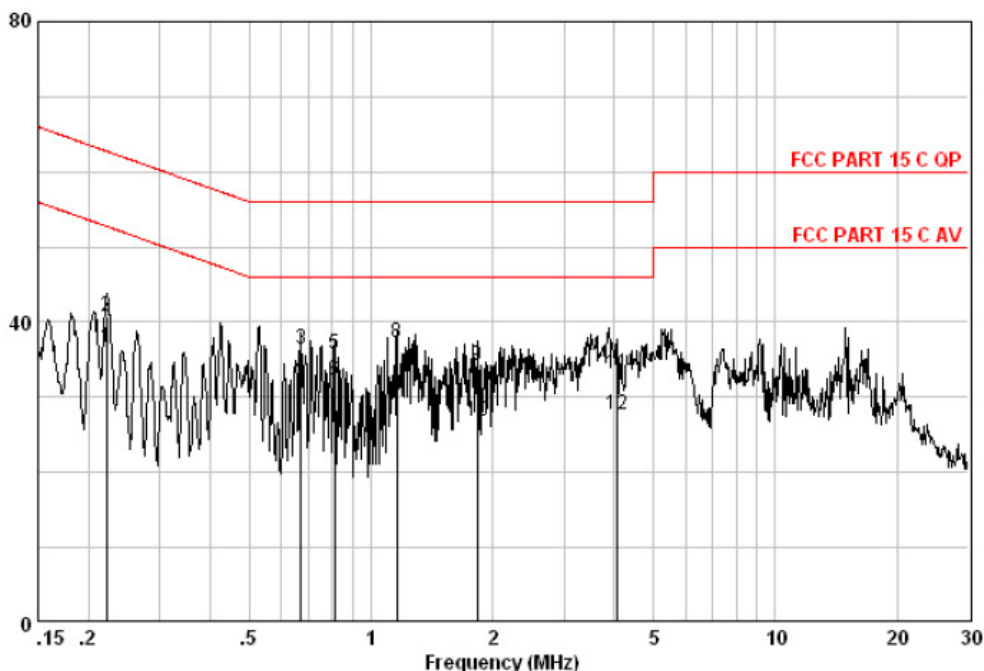
