## 4 MEASUREMENT METHOD

### 4 MEASUREMENT METHOD

The IEEE 1528, OET 65 Bulletin C and CEI/IEC 62209 standards provide requirements for reference dipoles used for system validation measurements. The following measurements were performed to verify that the product complies with the fore mentioned standards.

### 4.1 RETURN LOSS REQUIREMENTS

The dipole used for SAR system validation measurements and checks must have a return loss of -20 dB or better. The return loss measurement shall be performed against a liquid filled flat phantom, with the phantom constucted as outlined in the fore mentioned standards.

### 4.2 MECHANICAL REQUIREMENTS







### 4 MEASUREMENT METHOD

The IEEE 1528, OET 65 Bulletin C and CEI/IEC 62209 standards provide requirements for reference dipoles used for system validation measurements. The following measurements were performed to verify that the product complies with the fore mentioned standards.




Figure 1: Validation Waveguide Dimensions





# SAR MEASUREMENT PLOTS @ 5200 MHz








# BODY SAR MEASUREMENT PLOTS @ 5400 MHz






# BODY SAR MEASUREMENT PLOTS @ 5600 MHz




Photograph of the depth in the Head Phantom




Photograph of the depth in the Body Phantom




Head Setup Photo(Left Tilt )




Head Setup Photo(Right Cheek)



Head Setup Photo(Right Tilt)






# 10mm body-worn Back Side Setup Photo(hotspot)


