AT312 is subscriber equipment in the WCDMA/GSM system. The HSPA/UMTS frequency band is Band II/V; The GSM/GPRS/EDGE frequency band includes GSM850 and GSM900 and DCS1800 and PCS1900, but only Band II and Band V and GSM850 and PCS1900 bands test data included in this report. The 3G Smart Phone implements such functions as RF signal receiving/transmitting, HSPA/UMTS, LTE and GSM/GPRS/EDGE protocol processing, voice, video MMS service, GPS and WIFI etc. Externally it provides micro SD card interface, earphone port (to provide voice service) and SIM card interface. It also provides Bluetooth module to synchronize data between a PC and the phone, or to use the built-in modem of the phone to access the Internet with a PC, or to exchange data with other Bluetooth devices.


4.1 Output Power

TEST APPLICABLE

During the process of testing, the EUT was controlled via R&S Digital Radio Communication tester (CMU200) to ensure max power transmission and proper modulation. This result contains output power and EIRP measurements for the EUT. In all cases, output power is within the specified limits.

- b) Connect a low loss RF cable from the antenna port to a CMU200 by an Att.
- c) EUT Communicate with CMU200 then selects a channel for testing.
- d) Add a correction factor to the display CMU200, and then test.

4.1.1 Radiated Output Power


TEST DESCRIPTION

This is the test for the maximum radiated power from the EUT.

Rule Part 24.232(c) specifies, "Mobile/portable stations are limited to 2 watts e.i.r.p. Peak power" and 24.232(e) specifies that "Peak transmit power must be measured over any interval of continuous transmission using instrumentation calibrated in terms of an rms-equivalent voltage." Rule Part 22.913(a) specifies "The ERP of mobile transmitters and auxiliary test transmitters must not exceed 7 Watts."

Per Part 27.50(d) (4) specifies, Fixed, mobile, and portable (hand-held) stations operating in the 1710-1755MHz band are limited to 1W EIRP. Fixed stations operating in this band are limited to a maximum antenna height of 10 meters above ground. Mobile and portable stations operating in this band must employ a means for limiting power to the minimum necessary for successful communications.

TEST CONFIGURATION



TEST PROCEDURE

- 1. EUT was placed on a 1.50 meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The height of receiving antenna is 1.50m. 

According to the TIA/EIA 603D:2010 test method, The Receiver or Spectrum was scanned from 9 KHz to the 10th harmonic of the highest frequency generated within the equipment, which is the transmitted carrier that can be as high as 1910 MHz The resolution bandwidth is set as outlined in Part 24.238, Part 22.917 and Part 27.54. 




4.5 Spurious Emssion on Antenna Port

TEST APPLICABLE

The following steps outline the procedure used to measure the conducted emissions from the EUT.

- 1. Determine frequency range for measurements: From CFR 2.1057 the spectrum should be investigated from the lowest radio frequency generated in the equipment up to at least the 10th harmonic of the carrier frequency. For the equipment of WCDMA band II, this equates to a frequency range of 9 KHz to 20GHz, data taken from 30 MHz to 20 GHz.For WCDMA Band V, data taken from 30 MHz to 10 GHz.
- 2. The sweep time is set automatically by instrument itself. That should be the optimal sweep time for the span and the RBW. If the sweep time is too short, that is sweep is too fast, the sweep result is not accurate; if the sweep time is too long, that is sweep is too low, some frequency components may be lost. The instrument will give an optimal sweep time according the selected span and RBW.
- The procedure to get the conducted spurious emission is as follows:
 The trace mode is set to MaxHold to get the highest signal at each frequency;
 Wait 25 seconds;
 Get the result.
- 4. Determine EUT transmit frequencies: below outlines the band edge frequencies pertinent to conducted emissions testing.

4.6 Frequency Stability Test

TEST APPLICABLE


- 1. According to FCC Part 2 Section 2.1055 (a)(1), the frequency stability shall be measured with variation of ambient temperature from -30 ℃ to +50 ℃ centigrade.
- 2. According to FCC Part 2 Section 2.1055 (E) (2), for battery powered equipment, the frequency stability shall be measured with reducing primary supply voltage to the battery operating end point, which is specified by the manufacture.
- 3. Vary primary supply voltage from 85 to 115 percent of the nominal value for other than hand carried voltage equipment and the end voltage point was 3.40V.

TEST PROCEDURE

In order to measure the carrier frequency under the condition of AFC lock, it is necessary to make measurements with the EUT in a "call mode". This is accomplished with the use of R&S CMU200 DIGITAL RADIO COMMUNICATION TESTER.

- 1. Measure the carrier frequency at room temperature;
- 2. Subject the EUT to overnight soak at -30°C;
- 3. With the EUT, powered via nominal voltage, connected to the CMU200 and in a simulated call on middle channel of WCDMA Band II/V, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming;
- 4. Repeat the above measurements at 10℃ increments from -30℃ to +50℃. Allow at least 0.5 hours at each temperature, unpowered, before making measurements;
- 5. Remeasure carrier frequency at room temperature with nominal voltage. Vary supply voltage from minimum voltage to maximum voltage, in 0.1Volt increments remeasuring carrier frequency at each voltage. Pause at nominal voltage for 0.5 hours unpowered, to allow any self-heating to stabilize, before continuing;
- 6. Subject the EUT to overnight soak at +50°C;
- 7. With the EUT, powered via nominal voltage, connected to the CMU200 and in a simulated call on the centre channel, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming;
- 8. Repeat the above measurements at 10°C increments from +50°C to -30°C. Allow at least 0.5 hours at each temperature, unpowered, before making measurements;
- 9. At all temperature levels hold the temperature to +/- 0.5°C during the measurement procedure;

According to the JTC standard the frequency stability of the carrier shall be accurate to within 0.1 ppm of the received frequency from the base station. This accuracy is sufficient to meet Sec. 24.235, Frequency Stability. The frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block. As this transceiver is considered "Hand carried, battery powered equipment" Section 2.1055(d)(2) applies. This requires that the lower voltage for frequency stability testing be specified by the manufacturer. This transceiver is specified to operate with an input voltage of between 3.30VDC and 4.20VDC, with a nominal voltage of 3.70DC. Operation above or below these voltage limits is prohibited by transceiver software in order to prevent improper operation as well as to protect components from overstress. 

 - 2). for burst transmissions, employ an external trigger that is synchronized with the EUT burst timing sequence, or use the internal burst trigger with a trigger level that allows the burst to stabilize and set the measurement interval to a time that is less than or equal to the burst duration.
- 5. Record the maximum PAPR level associated with a probability of 0.1%.
