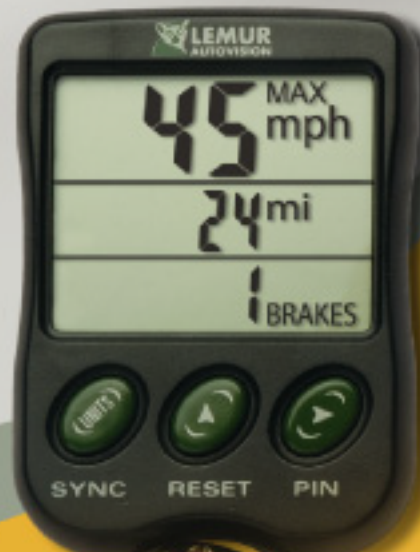

Getting Started

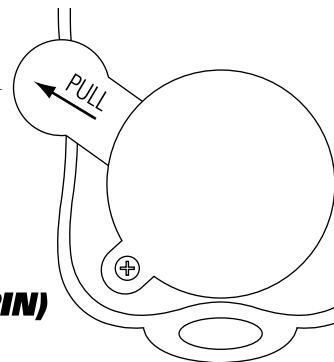
Your **Lemur Autovision™** includes two units: a Key Fob and a Sensor. Follow these 4 easy steps and within minutes your **Lemur Autovision™** will be reporting maximum speed, distance and number of sudden brakes.

4 easy steps...

1: Activate Key Fob

To activate, remove plastic tab from back of Key Fob as shown here and connect the Key Fob to the key that other drivers will use to drive your vehicle.

Remove this tab to activate Key Fob →



2: Set Personal Identification Number (PIN)

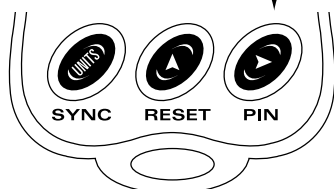
NOTE: Your **Lemur Autovision™** is already set with a default PIN number - 0000. You must enter this number before you set your own personal PIN.

A: To enter the PIN mode:

press and hold  until the display changes.

Use the  to change the digits one at a time

and the  to select digits one at a time.



B: Enter the OLD four digit PIN.

(0000 for a new Lemur Autovision™)

If an invalid OLD PIN is entered in this step then the screen will show TAMPER. (See Resetting the Display Values to Zero under Operation).

C: Enter a NEW four digit number (except 1234).

D: CONFIRM PIN by re-entering the NEW PIN. PASS will display on the screen. Proceed to Step 3.

If the PIN entered does not match the PIN you set in Step 2.c then, FAIL will be displayed. Repeat Step 2.

If you forget your PIN

If you forget your secret PIN you can change your PIN by entering 1234 as the OLD PIN and then enter your new PIN (See Step: 2: Set Personal Identification Number).

The Key Fob automatically invokes a two hour countdown before the new PIN is saved. If you press any button during this two-hour countdown, the new PIN will NOT be saved and TAMPER will be displayed.

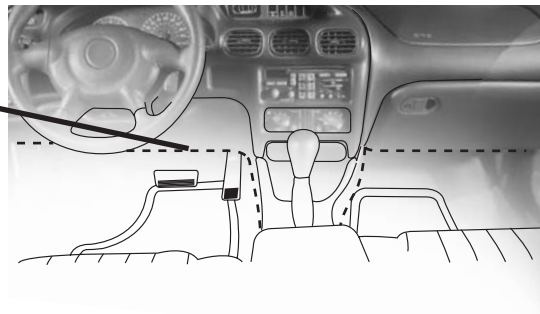
Step 3: Plug in the Sensor

NOTE: Before you plug in the Sensor, please read both Steps 3 and 4 and have your Key Fob handy.

A: Locate the OBD-II port under the dashboard in the general area marked by the dotted line.

B: Plug Sensor firmly into OBD-II port

C: The LED will turn green. It will remain green for 2 minutes.



While it is green you must complete Step 4.

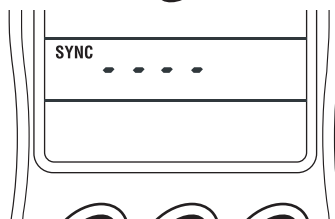
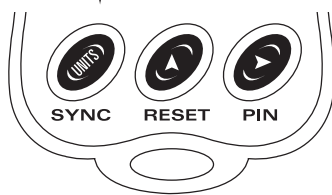
Step 4: Synchronize the Key Fob and Sensor

NOTE: To enable your Key Fob to read the Sensor, both must be synchronized.

You only need to do this once. The Sensor LED must be GREEN while you synchronize the Sensor and Key Fob.



A. On the Key Fob, press and hold (UNIT5) until the display changes



B. Enter your secret PIN

If Sync is successful PASS will display on the screen.

C. Turn on the vehicle. The Sensor LED will blink red for up to one minute.

D. Verify Data Reception. Within one minute the Sensor LED will blink GREEN.

You have successfully installed your Lemur Autovision™.

If Key Fob displays FAIL...
you must repeat Steps 3 and 4 above and be sure Key Fob is within three feet or one metre of the Sensor.

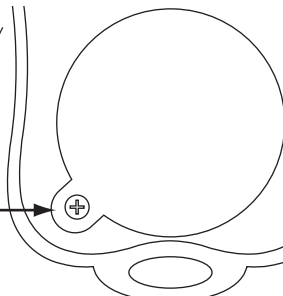
If Key Fob displays TAMPER...
you have entered an invalid PIN (See Resetting the Display Values to Zero under Operation) Then repeat Steps 3 and 4 above.

If Sensor LED continues to blink red after 1 minute...
then unplug Sensor and repeat Steps 3 and 4 above.

Battery Replacement

Replace Key Fob battery with a new CR2450 Coin Cell when LCD becomes dim.

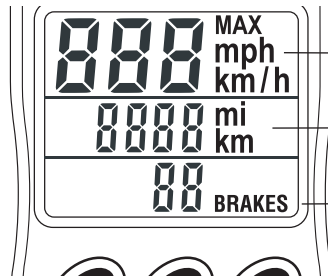
To replace battery remove screw.



Operation

Now that Lemur Autovision™ is installed, you are ready to use the system.

1. Data Displayed



The Lemur Autovision™ will display:

- **Maximum speed** in mph or km/h (displays up to 158 mph or 255 km/h.)
- **Distance traveled** in miles or kilometers (displays up to 9,999 miles or 9,999 kilometres).
- **Sudden Brakes**-when the vehicle speed is reduced by 12 mph or 20km/h in less than two seconds. (displays up to 99 sudden brakes).

2. Retrieving Vehicle Data

The Sensor reads and stores the vehicle usage data. The Key Fob automatically retrieves and updates the data from the Sensor every 30 seconds. Each time the vehicle key is returned you can review the data on the Key Fob.

NOTE: The data on the Key Fob will continue to update until you reset the values to 0 (zero).

3. Resetting the Display Values to Zero

A. Press and hold the  **until the display changes.**

B. Enter your secret four-digit PIN. The statistics on the Key Fob will reset to 0 (zero).

If an invalid PIN is entered, the data will not reset and TAMPER will appear on the Key Fob.

The number of resets is also shown on the Key Fob. The Reset count increases by one each time the data on the Key Fob is reset.



4. Tamper Indicator

Lemur Autovision™ has built-in protection to ensure that the data you see on your Key Fob is a true indication of vehicle usage.


If the Key Fob displays TAMPER one of the following events has taken place:

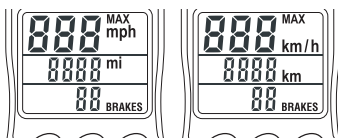
- A. Invalid PIN entered
- B. The Sensor was removed and reconnected to the OBD-II port.

To remove TAMPER the Key Fob must be reset using a valid PIN (See 3: Resetting the Display Values to Zero).



5. Changing the Units

To toggle the Units displayed on the Key Fob between Imperial and Metric, press and release 



An Important Safety Notice

Lemur Autovision™ is designed and tested to comply with the OBD-II codes used on most cars and light trucks manufactured for 1996 or later. For a list of compliant vehicles visit www.rootfour.com.

You should note, however, that there may be issues that affect the performance of your vehicle's computers:

- Some vehicle models do not fully comply with these codes.
- The on-board computer control system and sensors on any vehicle may be malfunctioning or may not be up to the specifications for that vehicle.
