Friis Formula

Friis transmission formula: $Pd = (Pout \cdot G) / (4 \cdot \pi \cdot R^2)$

Where

Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

Pd id the limit of MPE, 1 mW/cm² . If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

5.1.2 Test Procedure

Software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel individually.

Antenna Gain: The maximum Gain measured in fully anechoic chamber is 1.58 in linear scale.
