#### Important Information about the Sagemcom "F@ST 3896" :

## Installation and Safe Usage Instructions:

- 1. Place the router in a vertical orientation on a flat surface.
- Connect the manufacturer supplied AC to DC power adapter. The F@ST 3896 xxx router requires the use of a 12VDC, 3.5A power adapter. Only use a manufacturer supplied and approved power adapter and Ethernet cable.
- Connect the power adaptor of "F@ST 3896" to the AC mains in accordance with the installation instructions in this booklet, and the
  markings on the identification label (voltage, current, and frequency of electricity network).
- 4. Connect a coaxial cable to the port labeled "COAX" on one end and to a working cable wall outlet or splitter on the other end.
- 5. For connection of a computer with an Ethernet cable use one of the RJ45 ports on the product marked "1", "2", "3", or "4". Then connect the other end of the Ethernet Cable to the Ethernet port of a computer. Repeat as necessary with the other available Ethernet ports.

When using this device, basic safety precautions should always be followed to reduce the risk of fire, electric shock, and injury to persons including the following:

- 1. Do not use this product near water and avoid contact with moisture. For example, does not use near a bathtub, wash bowl, kitchen sink, laundry tub, in a wet basement, or near a swimming pool. Care should be taken so that liquids are not spilled on this equipment.
- This equipment is for indoor use only, do not place or install in an outdoor location.
- Place your product on a firm, solid surface, no obstacle at a minimum distance of 20cm (0.65ft). If you put it on something unsteady, it may fall and be damaged. If you place it on a soft surface, such as rug, sofa or cushion, the vents may be blocked, causing the product to overheat.
- 4. Never insert objects into the vents of this equipment as this can result in the risk of electrical shock or fire.
- As the power adapter is the only way to connect to the electrical network, the product must be installed near an easily accessed power outlet.
- 6. This equipment should only be operated with the type of power supply (Voltage and Current) indicated on the marking label.
- 7. Do not overload wall outlets or extension cords. Doing so can result in the risk of fire or electrical shock.
- Avoid blocking any vent openings or exhaust exits on this equipment. Do not place equipment in a built-in installation such as a cabinet that may impede the flow of air through the ventilation openings.

  - Air temperature between 0°C (32 F) and +40°C (104 F).
    - Relative humidity between 20% and 90% non-condensing.
  - Altitude: 2743 meters (9000ft) maximum.

## IMPORTANT NOTE:

The device for operation in the band 5150-5250 MHz is only for indoor use to reduce the potential for harmful interference to co-channel mobile satellite systems.

# Wall Mounting (Optional)

While many users place their F@ST 3896 product on their desk, it can be optionally wall mounted.

The number of the screw: 2 pcs.


Dimension for the screw: 4.5~5.0 mm.

Length of the thread is 9.4-10mm.

Thickness of the screw head is 1.85-2.15mm.

There are 2 slots on the underside of the modem that can be used for wall mounting.

You will need 2 suitable screws which screw diameter would be 4.5~5.0 mm to wall mount the F@ST 3896





Note: When wall mounting the unit, ensure that it is within reach of the power outlet.

To wall mount the unit:

- 1. Ensure that the wall you use is smooth, flat, dry and sturdy and use the 2 screw holes which are 70mm (2.76 inch) apart from each other.
- 2. Fix the screws into wall, leaving their heads 3 mm (0.12 inch) clear of the wall surface.
- 3. Remove any connections to the unit and locate it over the screw heads. When in line, gently push the unit on to the wall and move it downwards to secure.
