### 2. SYSTEM TEST CONFIGURATION

# 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

#### 2.2. EUT Exercise

The EUT (Transmitter) was operated in the engineering mode to fix the Tx frequency which was for the purpose of the measurements.

#### 2.3. Test Procedure

#### 2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. According to the requirements in Section 7 and 13 of ANSI C63.4-2003. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-Peak and Average detector mode.

#### 2.3.2 Radiated Emissions

The EUT is placed on a turn table which is 1.0 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes according to the requirements in Section 8 and 13 of ANSI C63.4-2003.



#### 4. DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition.

EUT staying in continuous transmitting mode. Channel Low, Mid and High for each band with max. data rate were chosen for full testing.

The field strength of spurious radiation emission was measured as EUT lie down and stand position (E1 and H mode) for both GSM and GPRS. The worst-case of H mode for GSM 850 band and E1 for GSM 1900 band for channel Low, Mid and High at GSM mode was reported.



#### **5.3.** Measurement Procedure

The transmitter output was connected to a calibrated attenuator, the other end of which was connected to a power meter. Transmitter output was read off the power meter in dBm. The power output at the transmitter antenna port was determined by adding the value of the attenuator to the power meter reading.







#### 5.8. Measurement Procedure

The EUT was placed on a non-conductive, The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and the EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. This maximization process was repeated with the EUT positioned in each of its three orthogonal orientations.



Figure 7-1: GSM Channel Low





Figure 7-2 GSM Channel Mid

Figure 7-4: PCS Channel Low





Figure 7-5 PCS Channel Mid

Figure 7-6: PCS Channel High




Figure 7-7: EDGE 850 Channel Low



Figure 7-9: EDGE 850 Channel High





Figure 7-10: EDGE 1900 Channel Low

Figure 7-11 EDGE 1900 Channel Mid




Figure 7-12: EDGE 1900 Channel High



Band Edge Requirements: In the 1 MHz bands immediately outside and adjacent to the frequency block, a resolution bandwidth of at least 1 percent of the emission bandwidth of the fundamental emission of the transmitter may be employed to measure the out of band Emissions. Limit, -13dBm.

Figure 8-4: Bad edge emission at antenna terminals – GSM Channel Lowest





Figure 8-5: Band edge emission at antenna terminals – GSM Channel Highest

Figure 8-7: Out of Band emission at antenna terminals –PCS Channel Mid









Figure 8-9: Band edge emission at antenna terminals – PCS Channel Lowest





Figure 8-10: Band edge emission at antenna terminals – PCS Channel Highest

Figure 8-11: Band edge emission at antenna terminals – EDGE850 Channel Lowest





Figure 8-12: Band edge emission at antenna terminals -EDGE850 Channel Highest

Figure 8-13: Bad edge emission at antenna terminals –EDGE1900 Channel Lowest





Figure 8-14: Band edge emission at antenna terminals -EDGE1900 Channel Highest







## 8.3. Measurement Procedure

The EUT was placed on a non-conductive, The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and the EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. This maximization process was repeated with the EUT positioned in each of its three orthogonal orientations.



## 9.3. Measurement Procedure

Turn EUT off and set the chamber temperature to  $-30^{\circ}$ C. After the temperature stabilized for approximately 30 minutes recorded the frequency. Repeat step measure with  $10^{\circ}$ C increased per stage until the highest temperature of  $+50^{\circ}$ C reached.


