## Details

To minimize unwanted AC line noise that may degrade the performance of your SE80, take advantage of the filtered outlet on the unit for powering your AC devices - especially USB and other cell phone chargers, dimmer-capable lamps, plasma TVs and other devices employing switching power supplies. Plug a power strip into the SE80 for additional filtered capacity.

The bottom of the unit has a reset button and a gigabit Ethernet port.



# Installing your SE80ac

- 1 Connect one end of an Ethernet cable into the Ethernet port of the SE80ac and the other end to a LAN port on a SmartOS router.



- 2 Plug the SE80ac into a nearby electrical outlet.

The LED flashes red. Wait for the LED to flash white. This process may take about 2 minutes.



- 3 Once the LED stays white, you can unplug the SE80ac and move it to the location where you want it.

The LEDs repeat the colors and flashing. When the light glows solid white again, connection is accomplished and you can log into your network.
