## 2. Antenna requirement

The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

### 2.1. Conclusion

The antenna is a **Dipole Antenna** which permanently attached, and the best case gain of the antenna is **2.53 dBi** . It complies with the standard requirement.



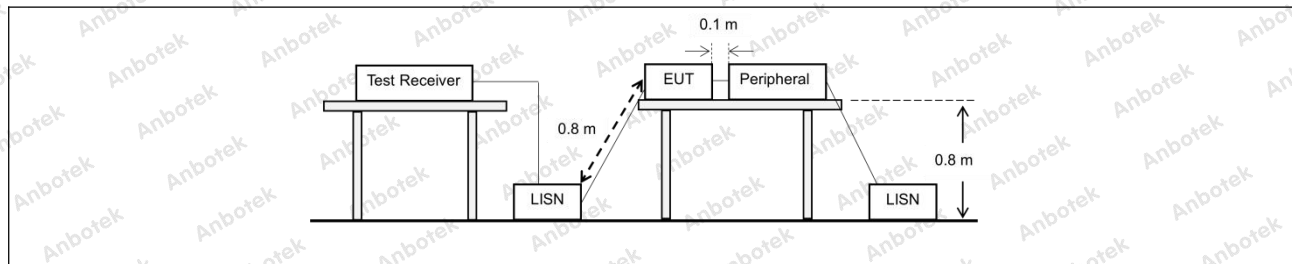

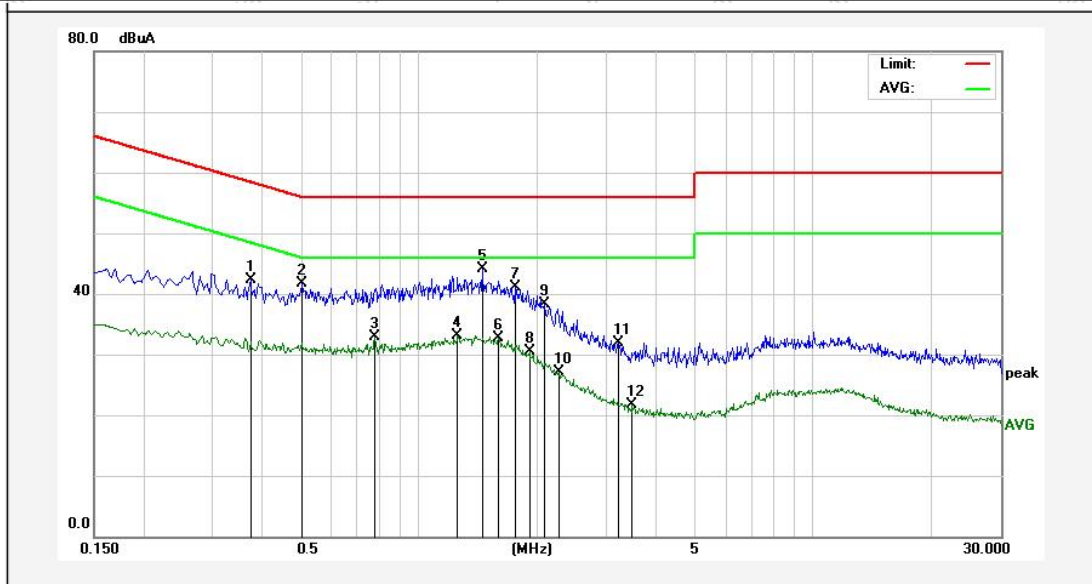

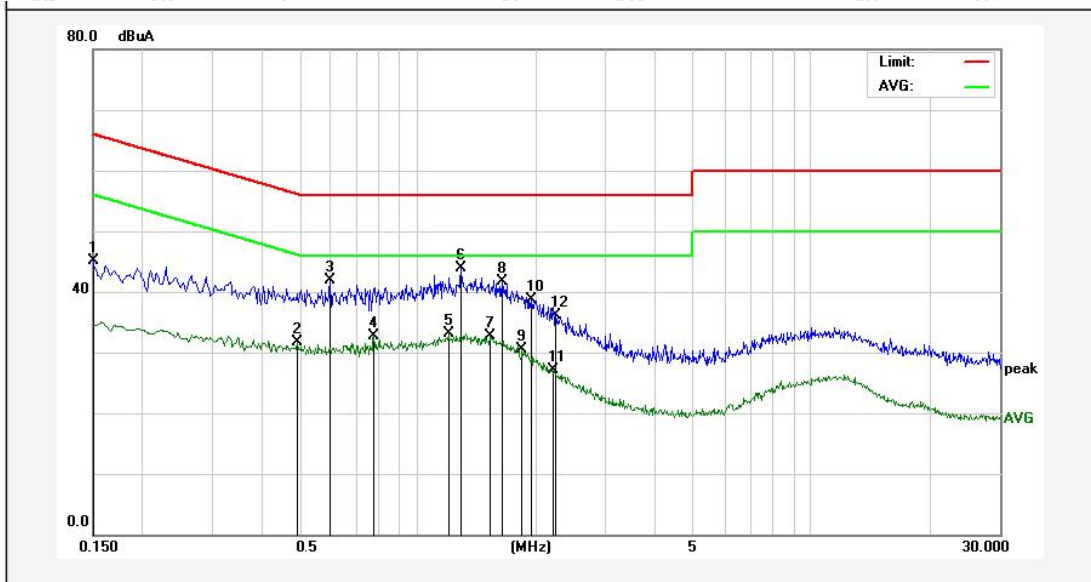

## 4. Occupied Bandwidth

Test Requirement:	47 CFR 15.215(c)
