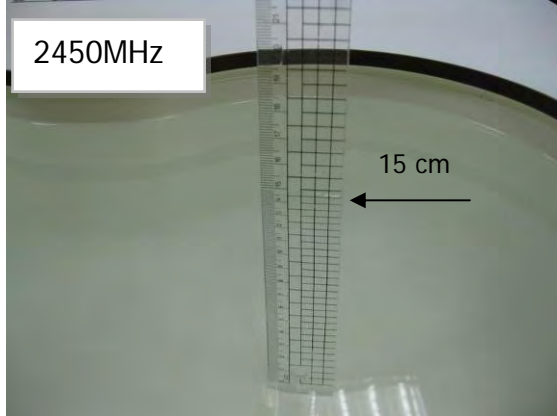

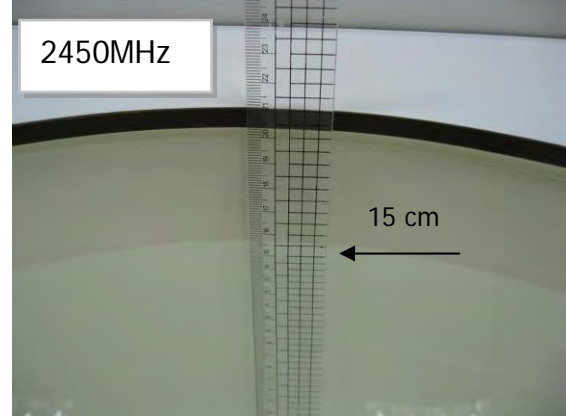

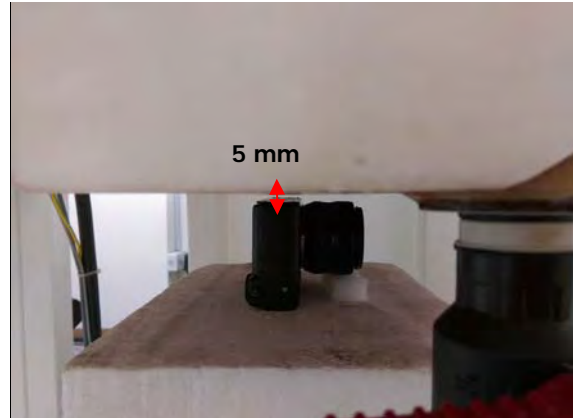


Fig.5 EUT Bottom side to flat phantom

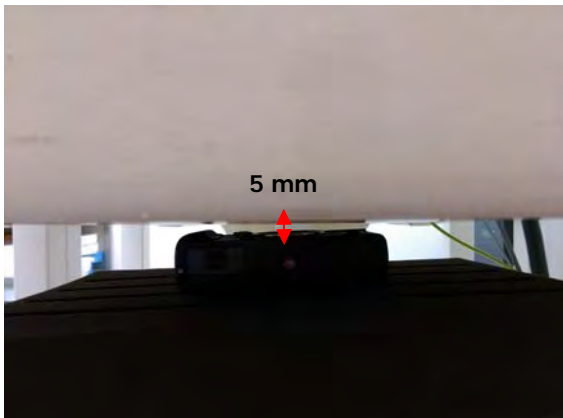


Fig.6 EUT Front side to flat phantom

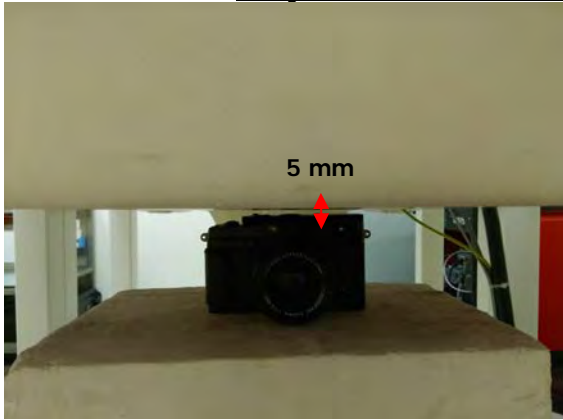


Fig.7 EUT Top side to flat phantom

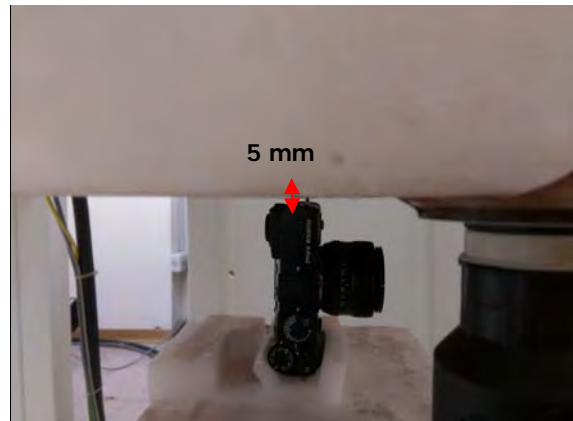
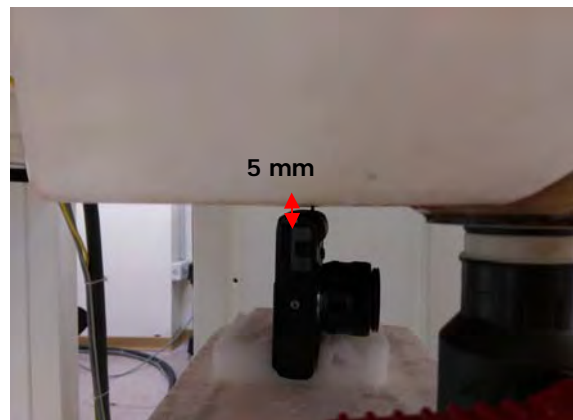


Fig.9 EUT Left side to flat phantom

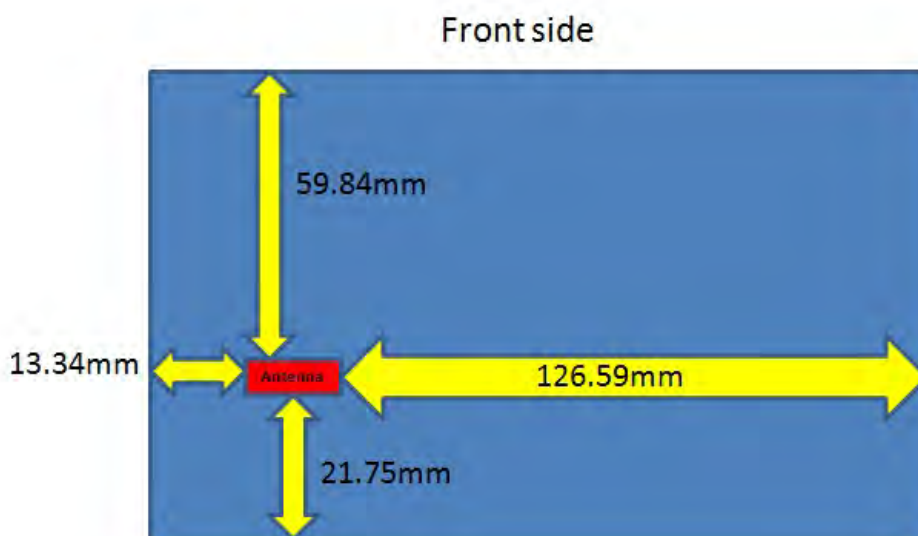


Fig.13 Antenna position of EUT
