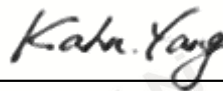

3.1 CONDUCTED EMISSIONS TEST

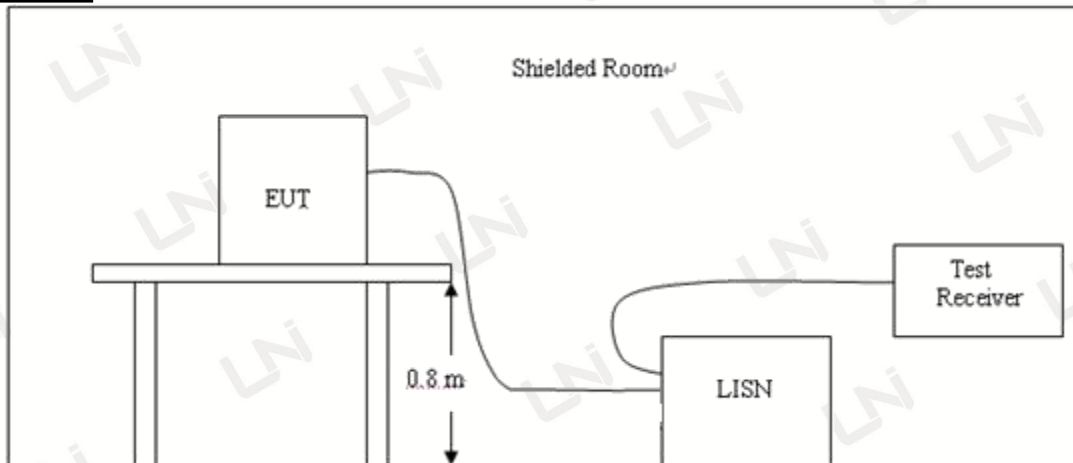

Test Setup



Test Procedure

- 1, The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. A wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10.
- 2, Support equipment, if needed, was placed as per ANSI C63.10.
- 3, All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10.
- 4, If a EUT received DC power from the USB Port of Notebook PC, the PC's adapter received AC120V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5, All support equipments received AC power from a second LISN, if any.
- 6, The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7, Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.

Test Result

This device is pure battery powered and does not require charging.

3.2 RADIATED EMISSION TEST

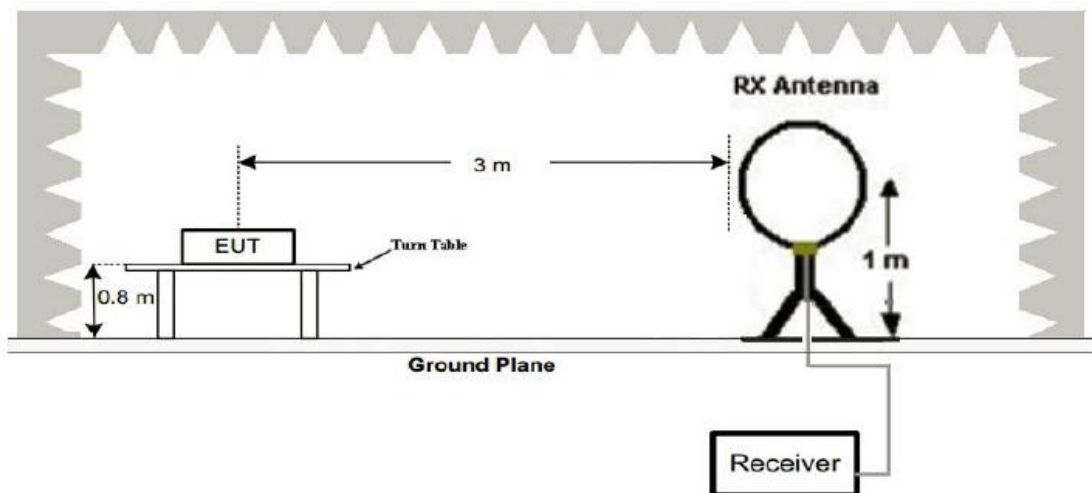

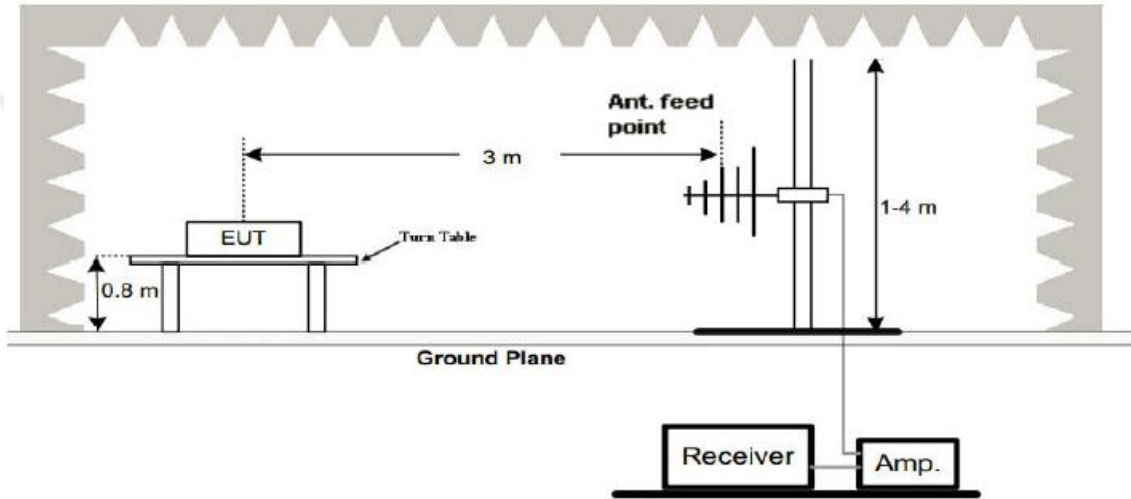

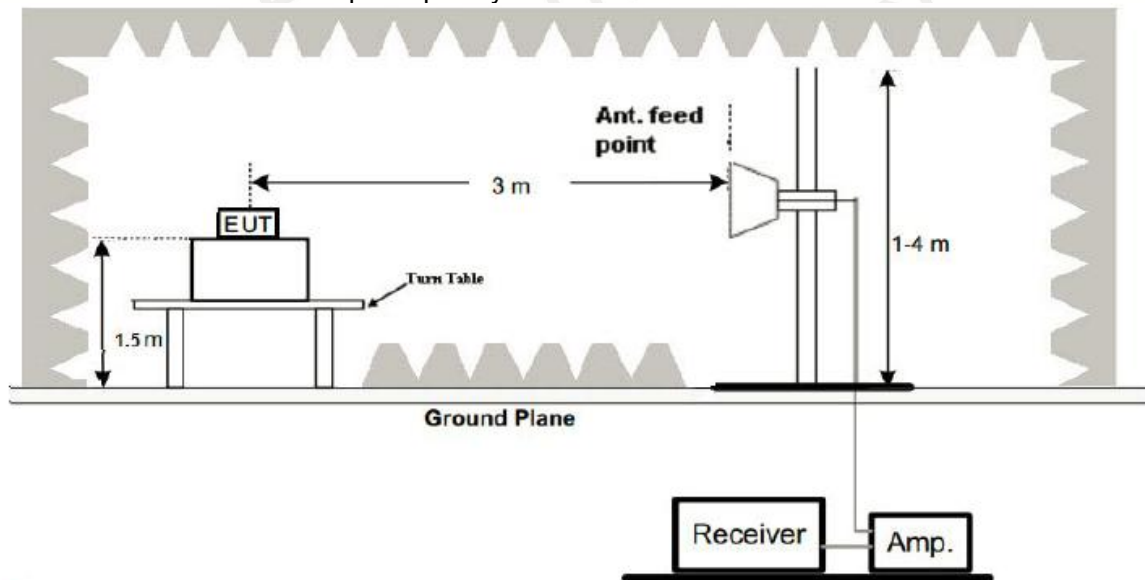
1. Radiated Emission Test-Up Frequency Below 30MHz

Test Procedure

- Below 1GHz measurement the EUT is placed on turntable which is 0.8m above ground plane. And above 1GHz measurement EUT was placed on low permittivity and low tangent turn table which is 1.5m above ground plane.
- The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
- EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emissions.
- Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- Repeat above procedures until the measurements for all frequencies are complete.
- The test frequency range from 9kHz to 25GHz per FCC PART 15.33(a).

Note:

For battery operated equipment, the equipment tests shall be performed using a new battery.

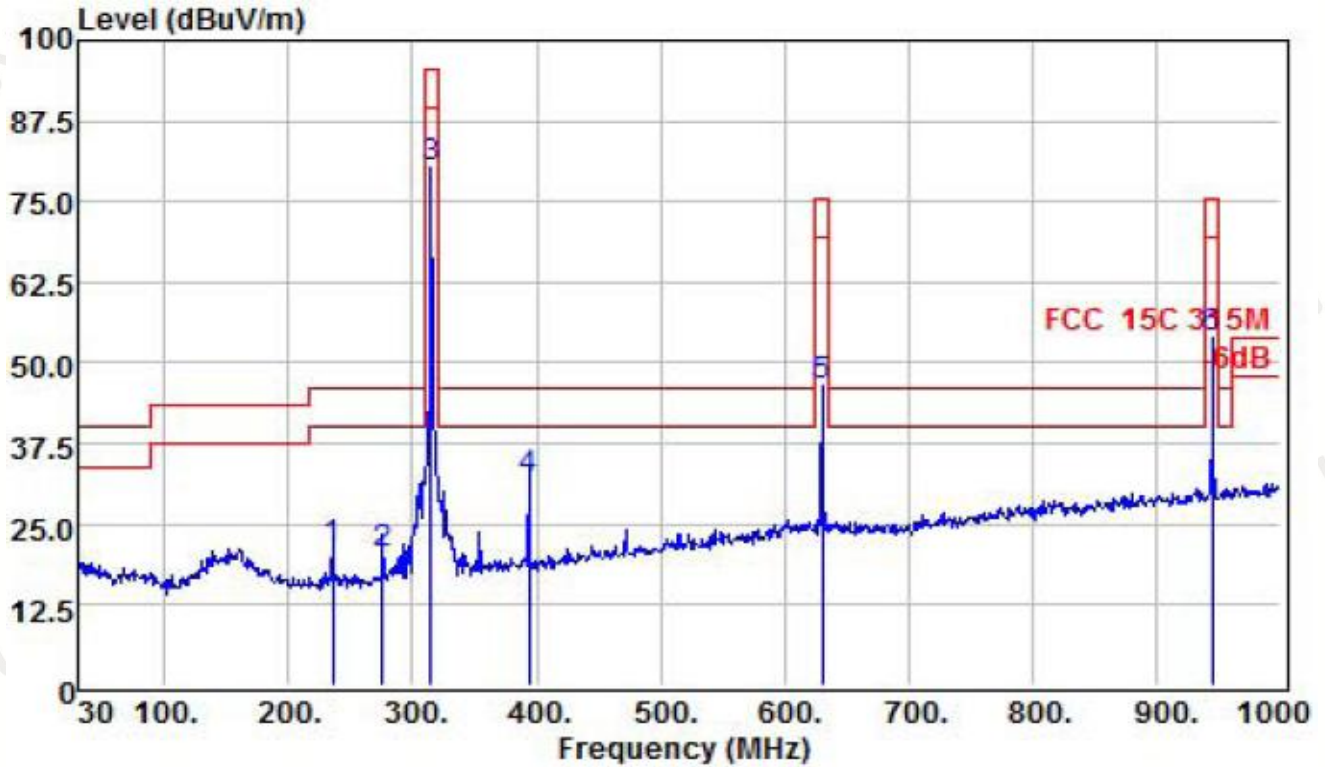

Remark:

- All the test modes completed for test. The worst case of Radiated Emission is Middle channel, the test data of this mode was reported.
- By preliminary testing and verifying three axis (X, Y and Z) position of EUT transmitted status, it was found that "Z axis" position was the worst, and test data recorded in this report.
- Radiated emission test from 9KHz to 10th harmonic of fundamental was verified, and no emission found except system noise floor in 9KHz to 30MHz and not recorded in this report.

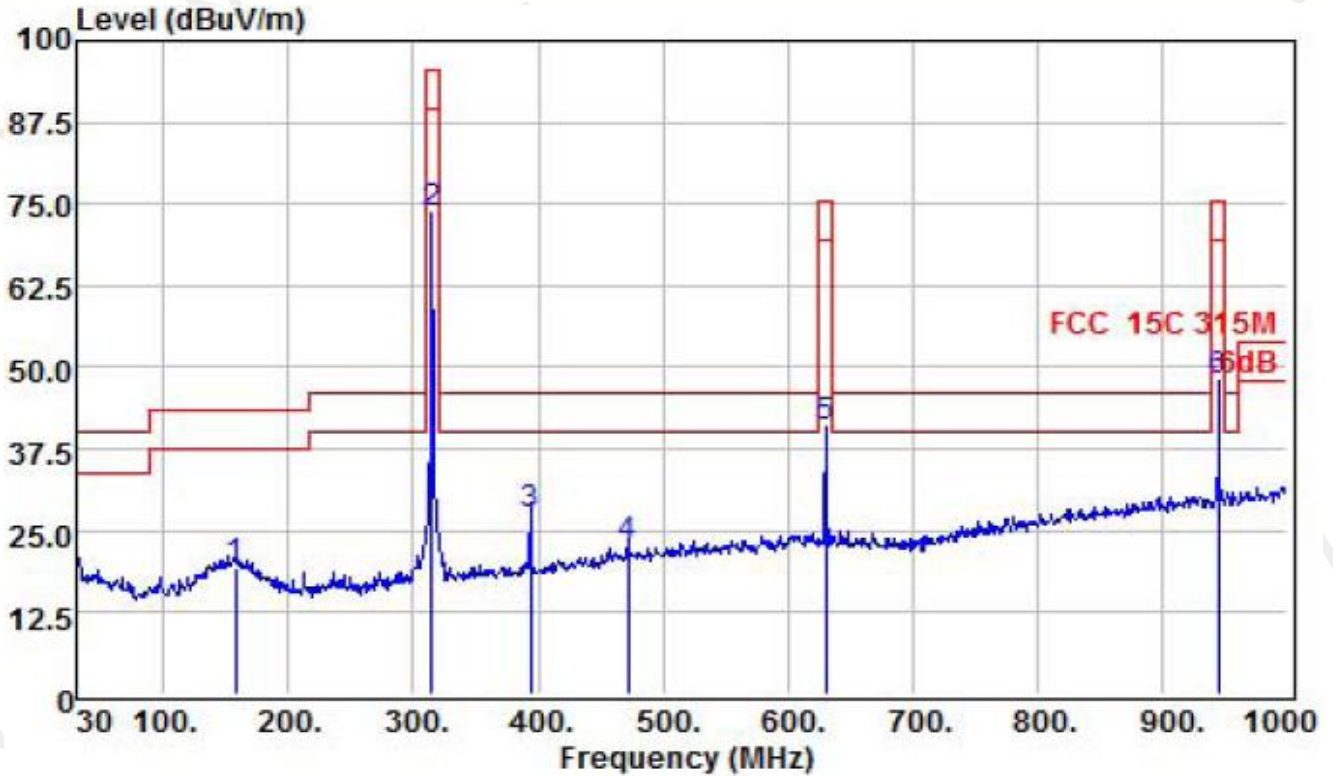

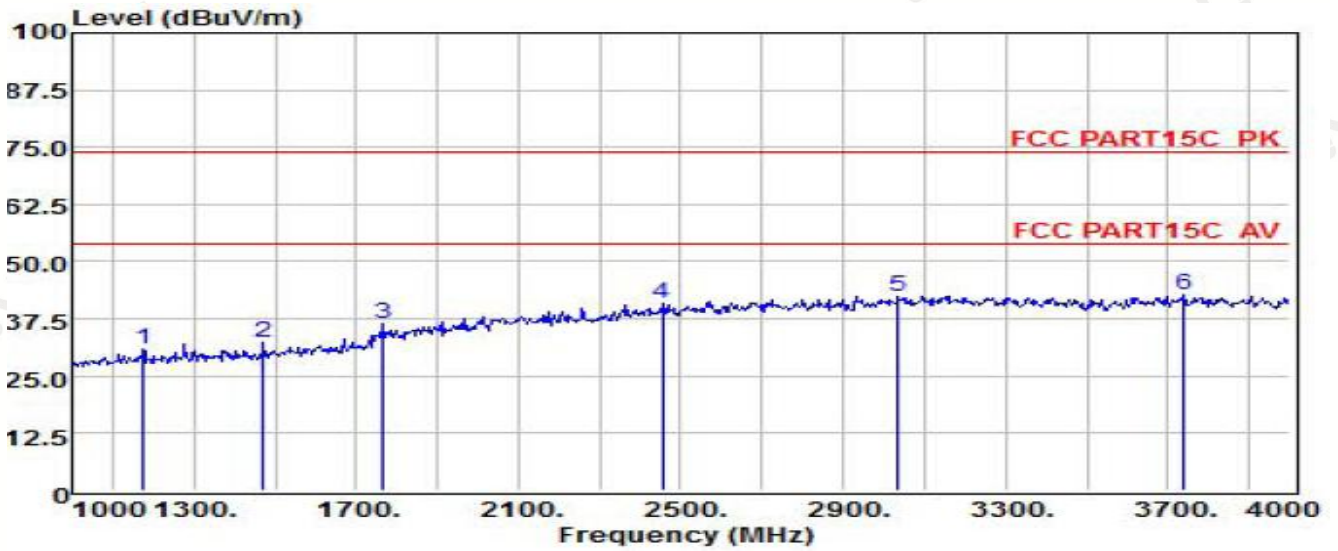

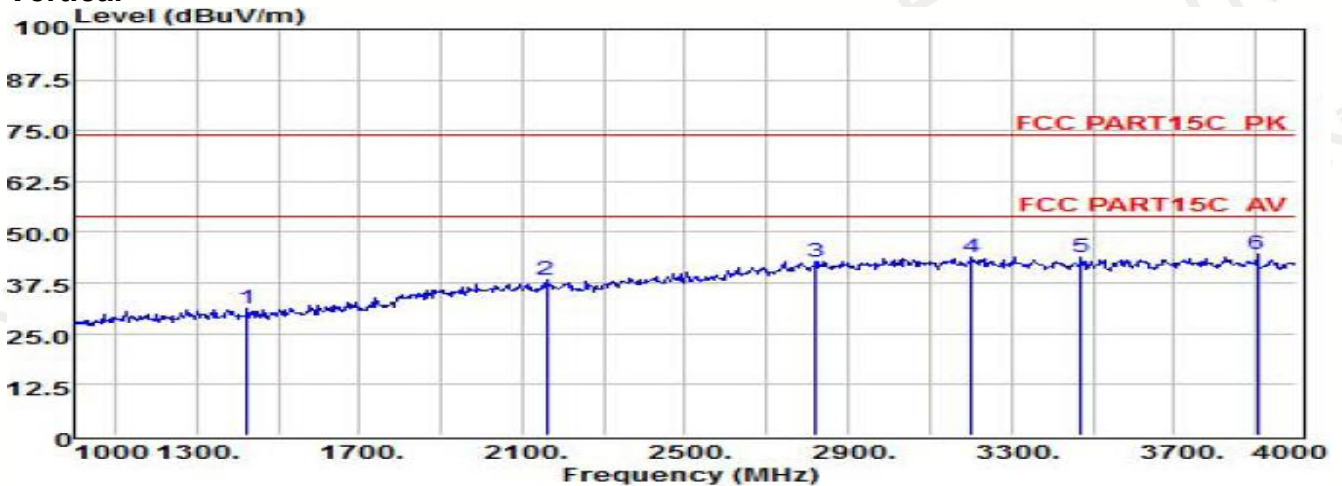

3.3 -20db OCCUPIED BANDWIDTH

Limit

According to 47 CFR 15.231(c) The bandwidth of the emission shall be no wider than 0.25% of the centre frequency for devices operating above 70MHz and below 900MHz. Bandwidth is determined at the points 20dB down from the modulated carrier.

Test Procedure

The transmitter output was connected to the spectrum analyzer through an attenuator. The bandwidth of the fundamental frequency was measured by spectrum analyzer with 30 KHz RBW and 100 KHz VBW. The 20dB bandwidth is defined as the total spectrum the power of which is higher than peak power minus 20dB.

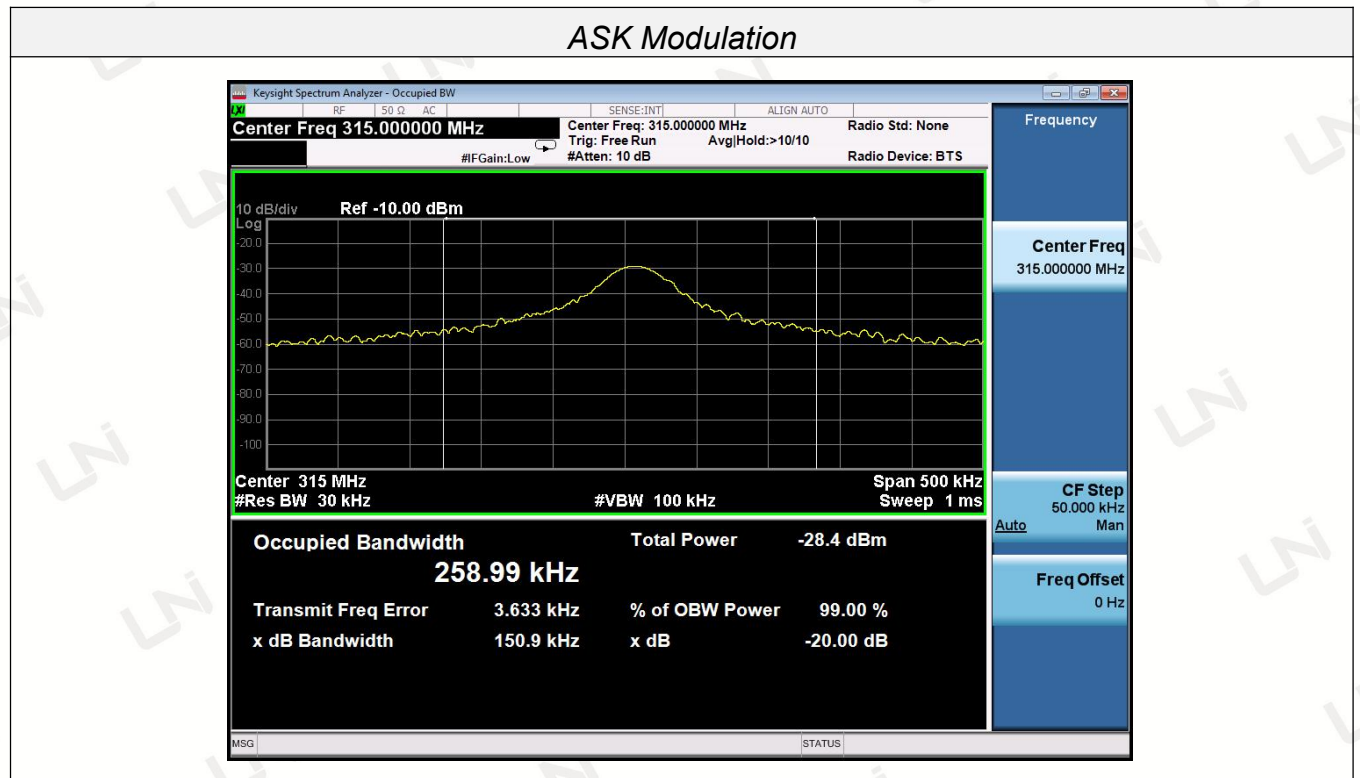

TEST PROCEDURE

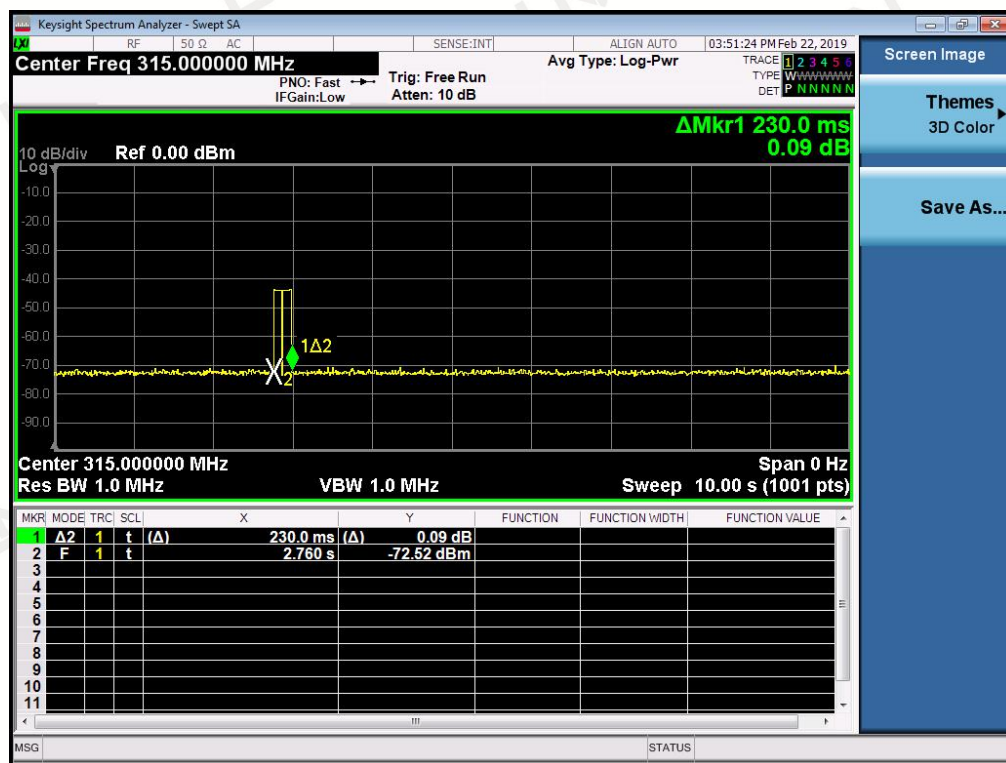
1. The EUT was placed on a wooded table which is 0.8m height and close to receiver antenna of spectrum analyzer.
2. The spectrum analyzer resolution bandwidth was set to 1 MHz and video bandwidth was set to 1 MHz to encompass all significant spectral components during the test. The spectrum analyzer was operated in linear scale and zero span mode after tuning to the transmitter carrier frequency.

3.5 CALCULATION OF AVERAGE FACTOR

The output field strengths of specification in accordance with the FCC rules specify measurements with an average detector. During the test, a spectrum analyzer incorporating a peak detector was used. Therefore, a reduction factor can be applied to the resultant peak signal level and compared to the limit for measurement instrumentation incorporating an average detector.

The duty cycle is measured in 100 ms or the repetition cycle period, whichever is a shorter time frame. The duty cycle is measured by placing the spectrum analyzer to set zero span at 100kHz resolution bandwidth.

Averaging factor in dB = $20\log(\text{duty cycle})$

The duration of one cycle = 135.8ms

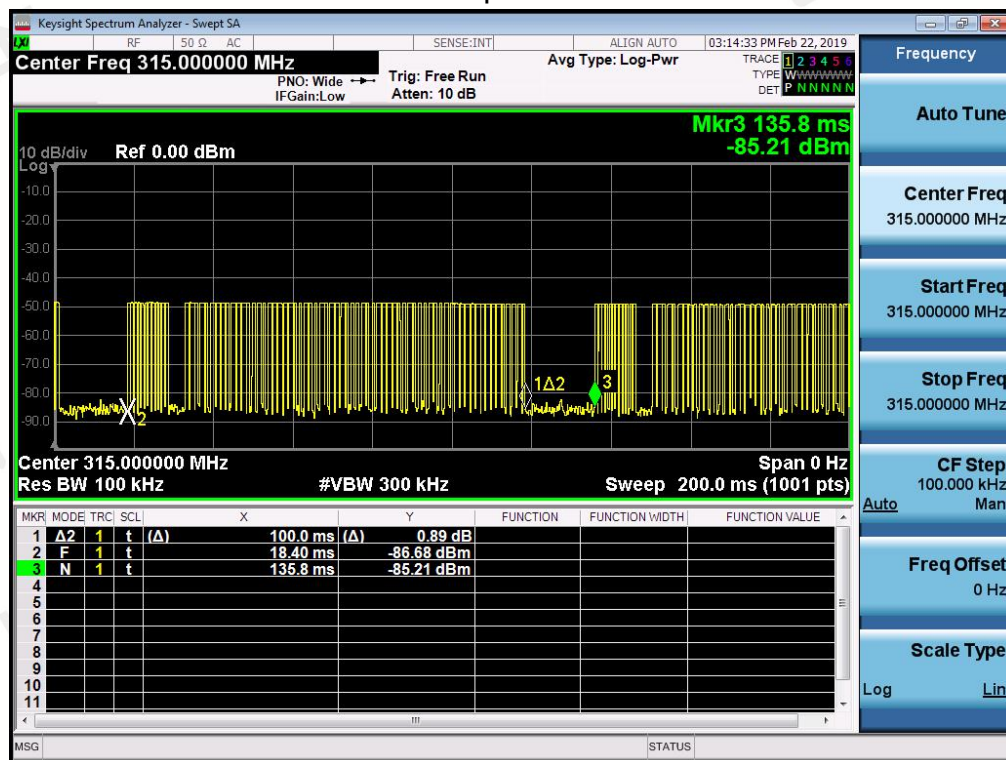
The duty cycle is simply the on-time divided the duration of one cycle

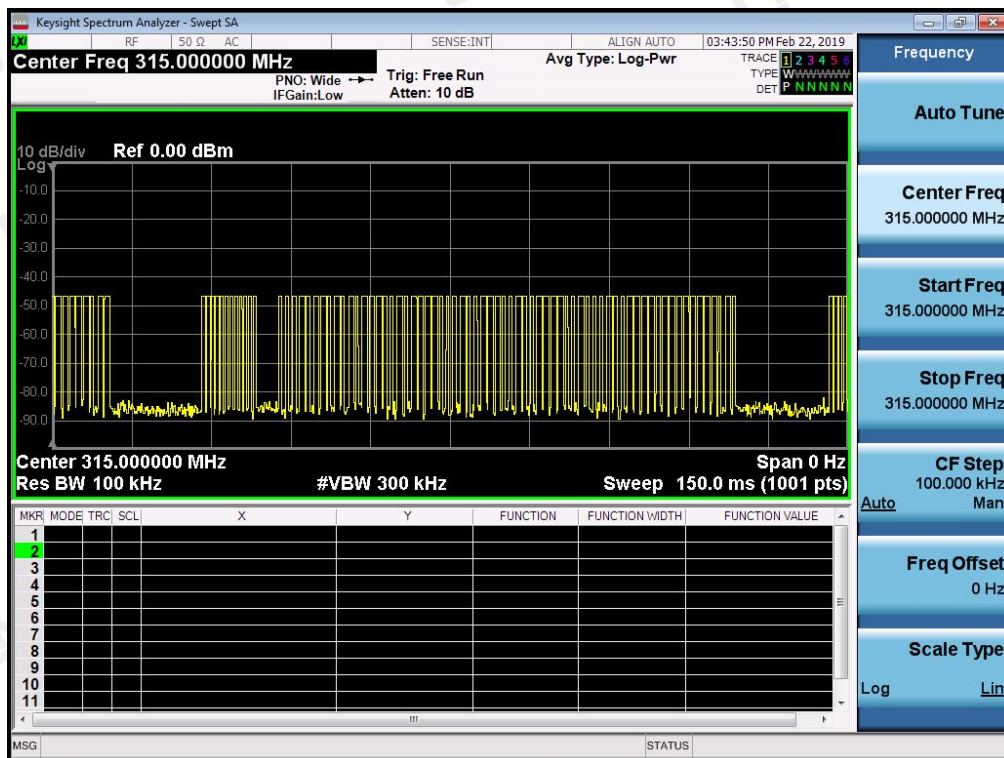
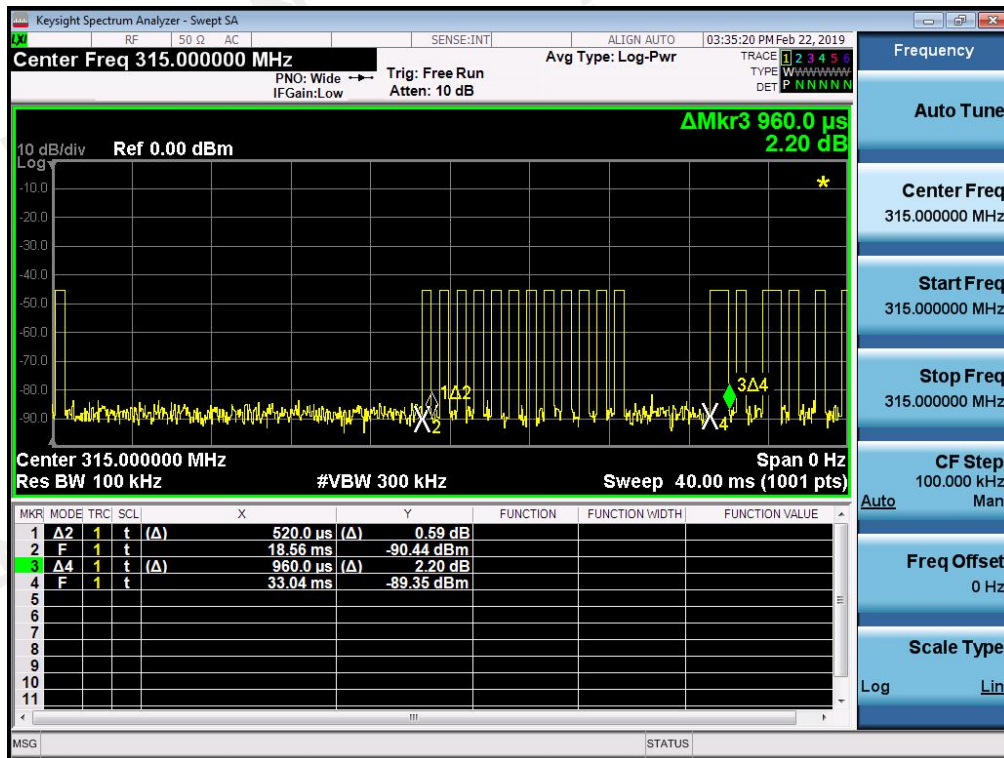
Duty Cycle = $(0.52\text{ms} \times 38 + 0.96\text{ms} \times 37) / 135.8\text{ms} = 55.28\text{ms} / 135.8\text{ms} = 0.4071$

Therefore, the averaging factor is found by $20\log 0.4071 = -7.81\text{dB}$

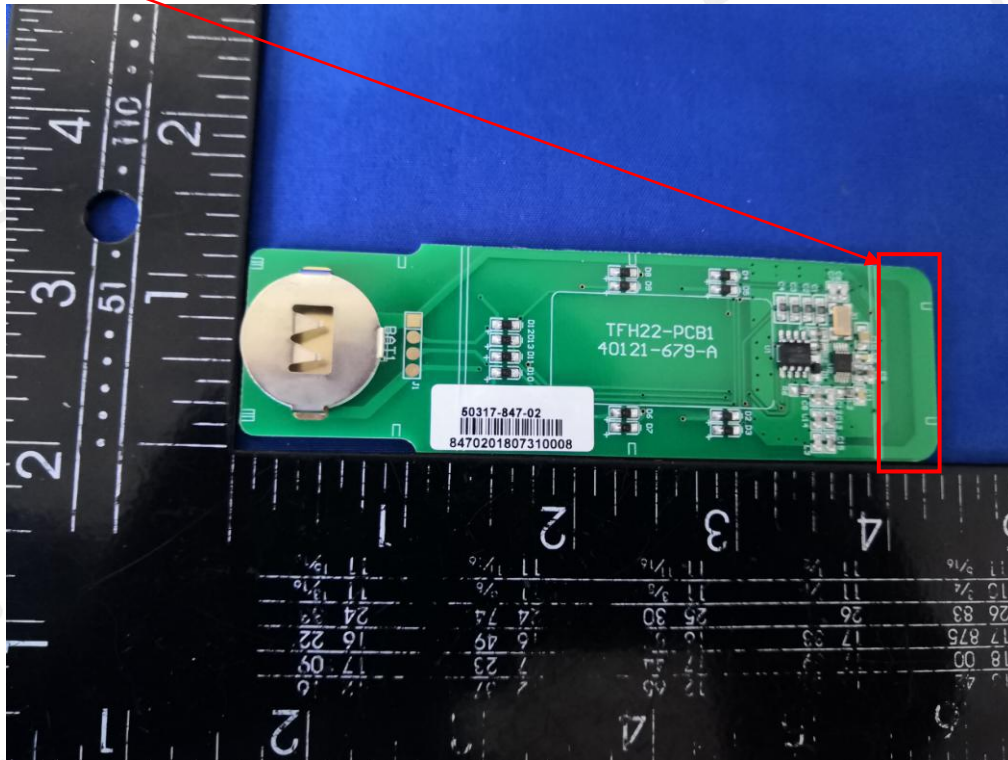
