

## Connect to a Computer




- 1. Screw the antennas to the Wi-Fi PCIe adapter.
- 2. Turn off your computer and unplug the power cord from your computer.
- 3. Remove the side panel of the computer case. Carefully insert the driver into the PCIe slot of the motherboard.
- 4. Put the side panel of the case back and reconnect the power cord, then turn on your computer.

Note: In Windows XP, a Found New Hardware Wizard window will appear when the adapter is detected. Please click Cancel.


### Install Driver and Utility

A: Insert the CD, browse the resource CD and double-click Setup.exe.




B: The Install Shield Wizard will pop out. Click Next to continue and follow the instructions to finish. Then restart the computer to complete the installation.



### Connect to Wireless Network

Join by Windows Wireless Utility

- 1. Click Wi-Fi icon \* at the bottom right corner in Windows.
- 2. Select desired Wi-Fi network and click Connect.
- 3. If the network is unencrypted, you will directly connect to it. If the network is encrypted, enter the password (network security key) and then click Next to connect.
