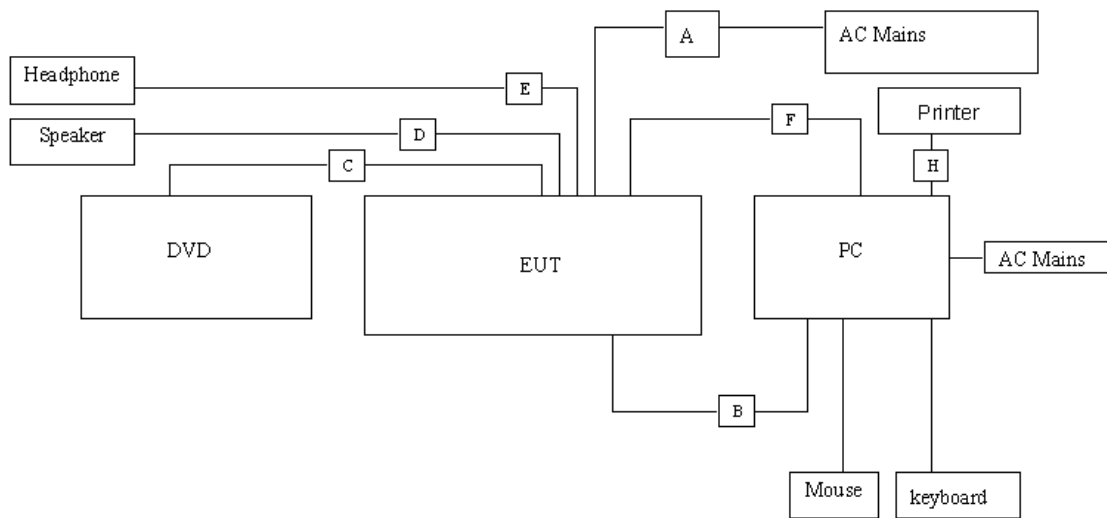

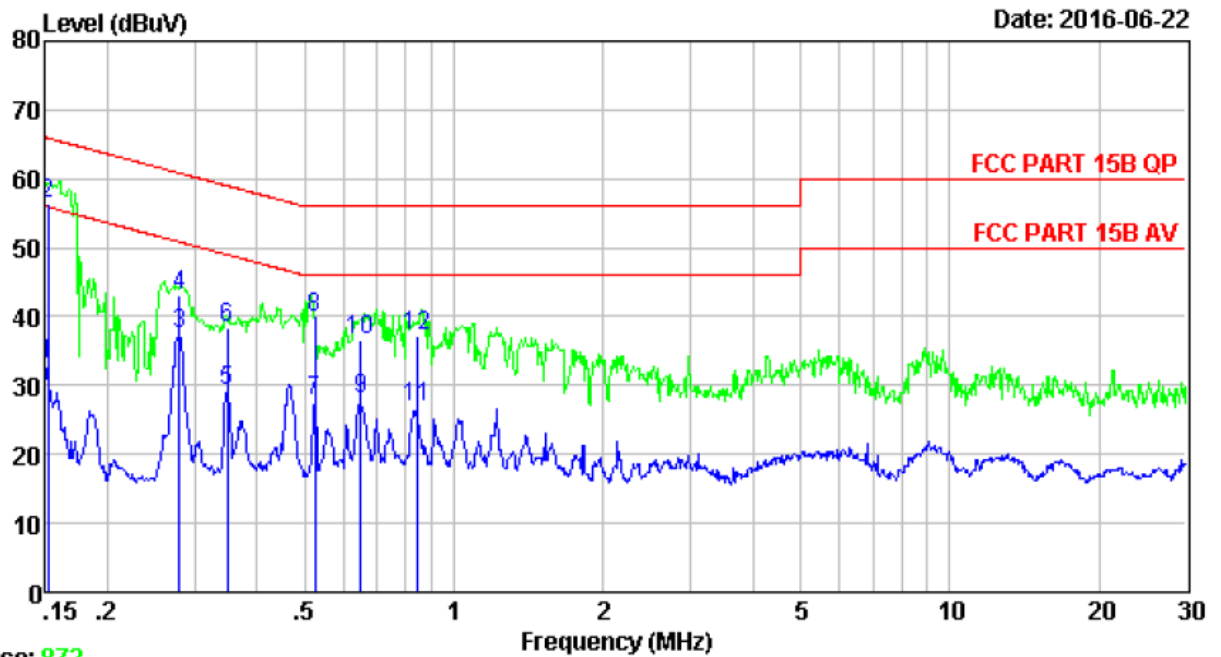

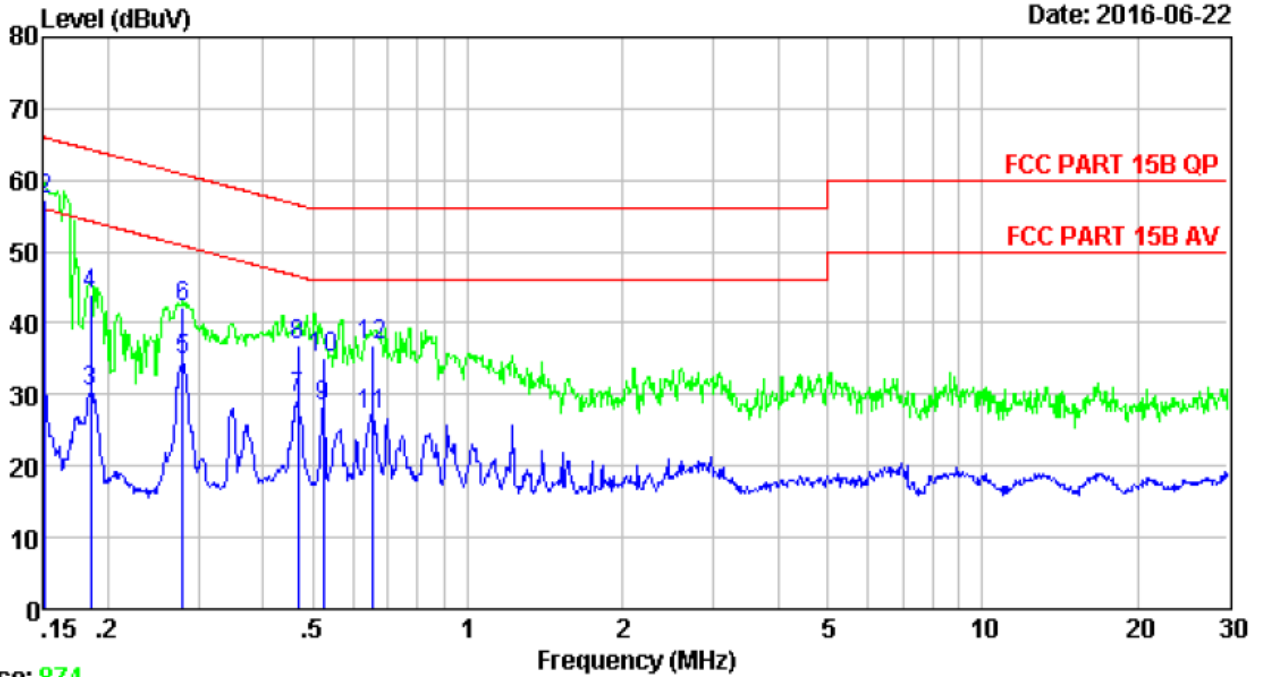

The EUT was placed on a turn table which was 0.8 m above the ground. The turn table can rotate 360 degrees to determine the position of the maximum emission level. The EUT was set 3 m away from the receiving antenna which was mounted on an antenna tower. The measuring antenna moved up and down to find out the maximum emission level. It moved from 1 m to 4 m for both horizontal and vertical polarizations.

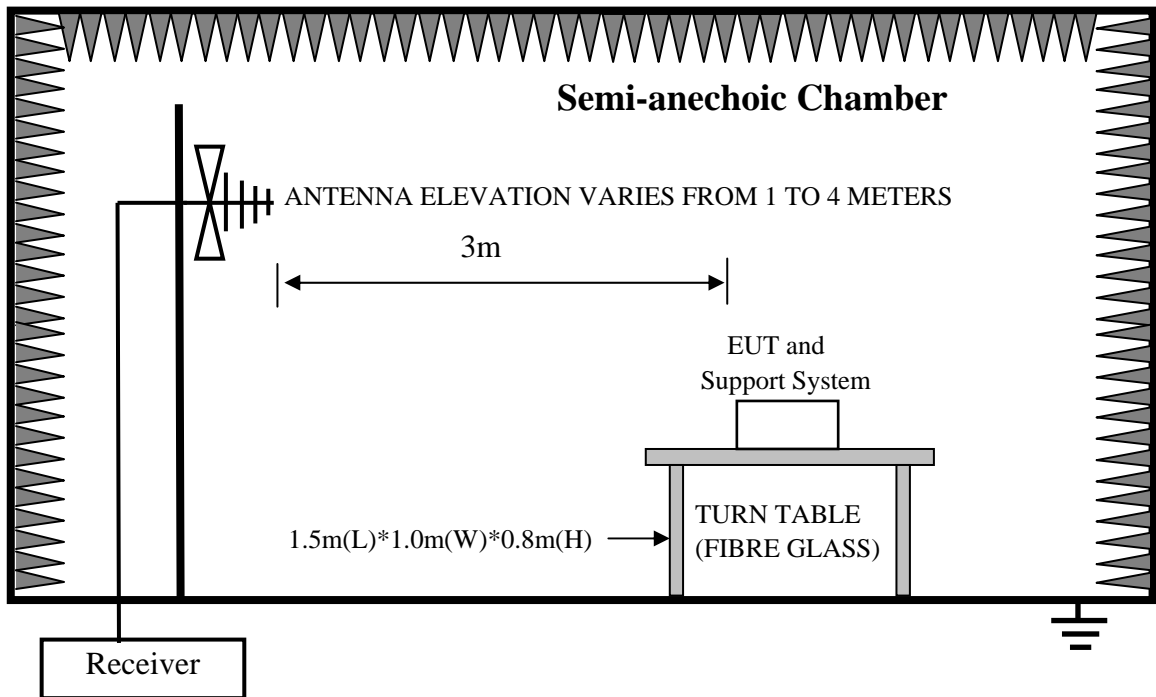
The EUT was tested in the Chamber Site. It was pre-scanned with a Peak detector from the spectrum, and all the final readings from the test receiver were measured with the Quasi-Peak detector.

The bandwidth setting on the test receiver was 120 kHz.

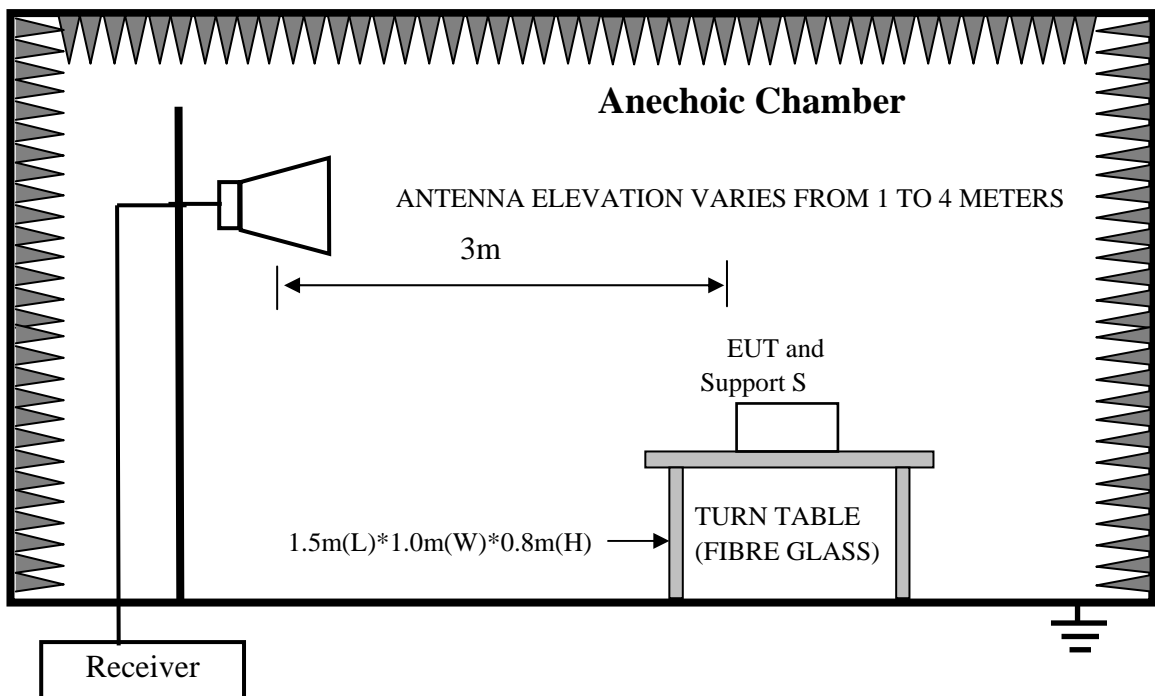
The bandwidth of the Spectrum's VBW is set at 3MHz and RBW is set at 1MHz for peak emissions measurement above 1GHz and 1MHz RBW, 10Hz VBW for average emissions measure above 1GHz

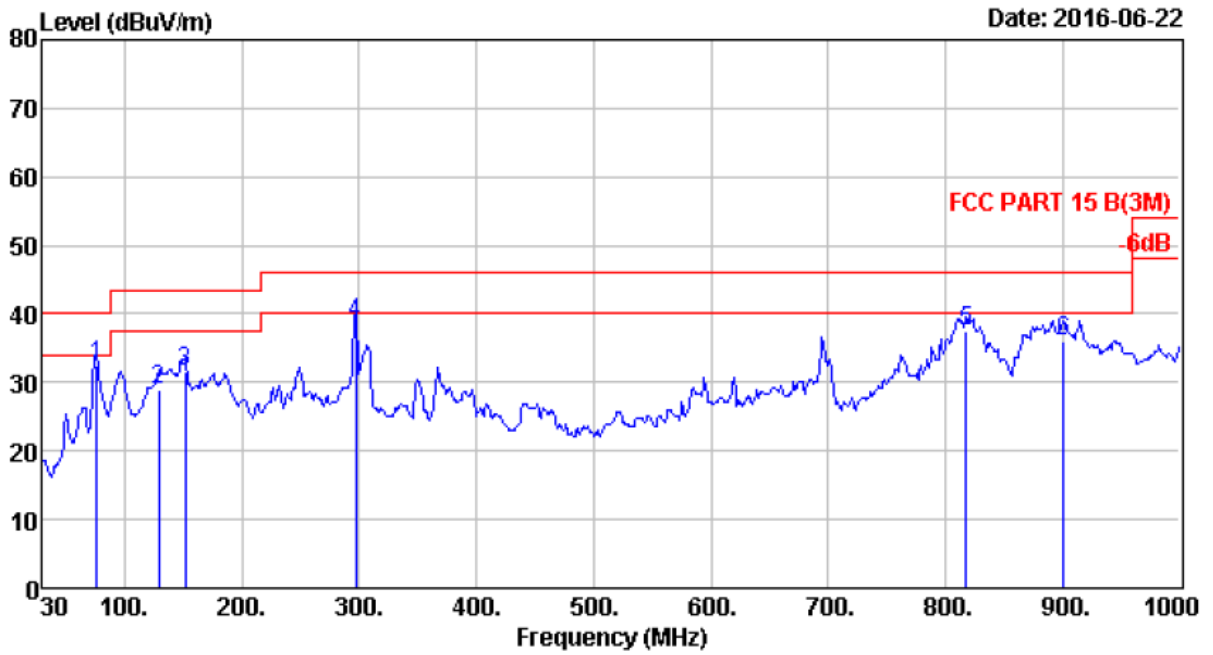
1、 In Semi-anechoic Chamber Test Setup Diagram for 30MHz~1000MHz

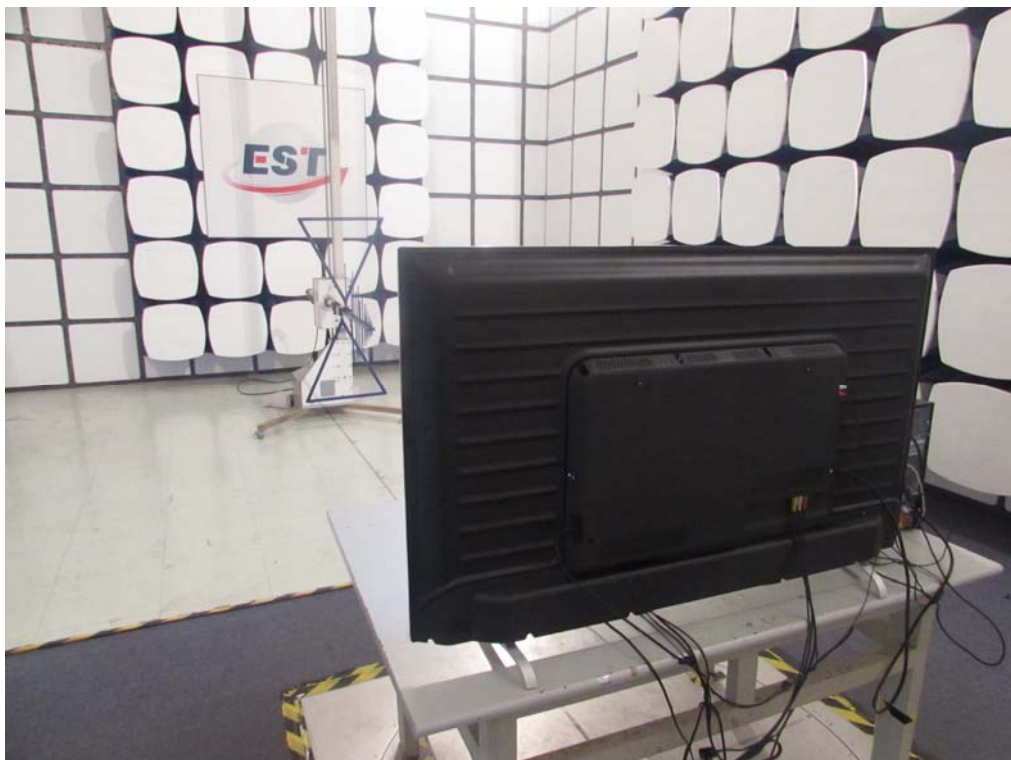

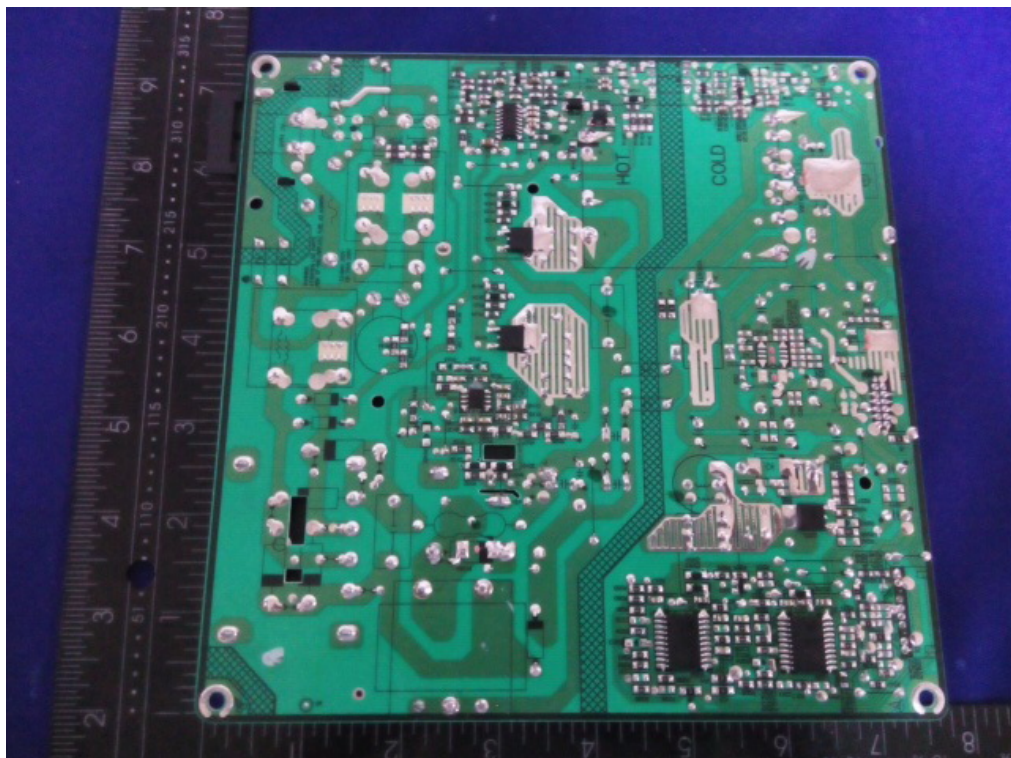
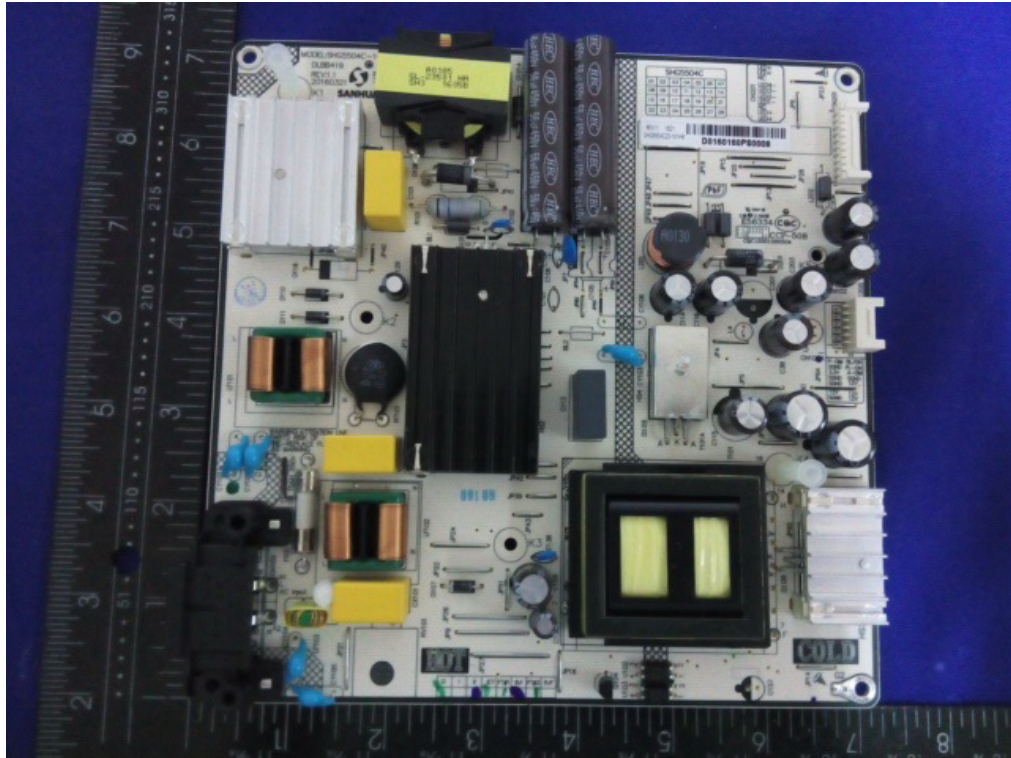
