### 1.3 Mode of Operation

DEKRA has verified the construction and function in typical operation. All the test modes were carried out with the EUT in normal operation, which was shown in this test report and defined as:

Test Mode
Mode 1: Transmitter-1Mbps(GFSK_DH5)
Mode 2: Transmitter-2Mbps(Pi/4 DQPSK_DH5)
Mode 3: Transmitter-3Mbps(8DPSK_DH5)
Mode 4: Transmitter-Hopping

Note:

1. For portable device, radiated spurious emission was verified over X, Y, Z Axis, and shown the worst case on this report.
2. Regards to the frequency band operation for systems using FHSS modulation: normal operation (hopping) was selected to test for conducted spurious test.
3. The extreme test condition for voltage and temperature were declared by the manufacturer.
4. The reading values of all the test items contain cable loss.

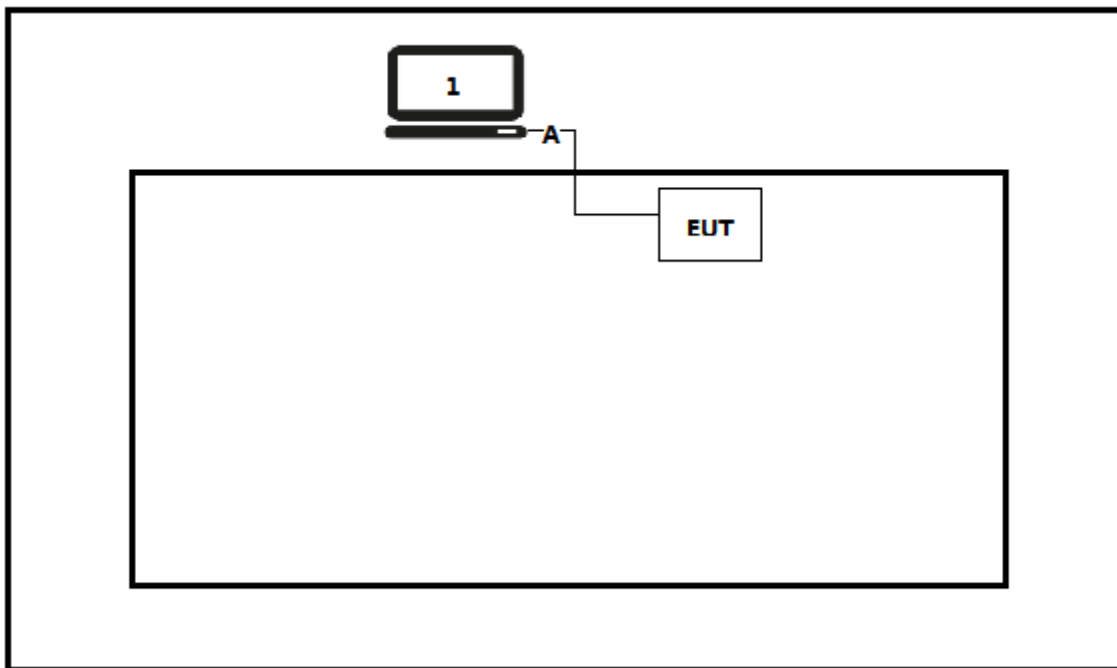

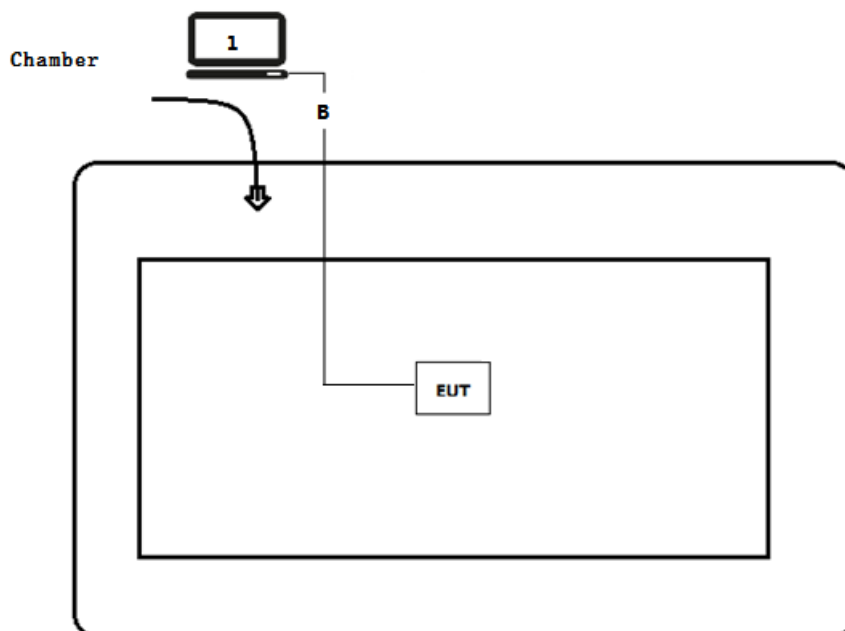

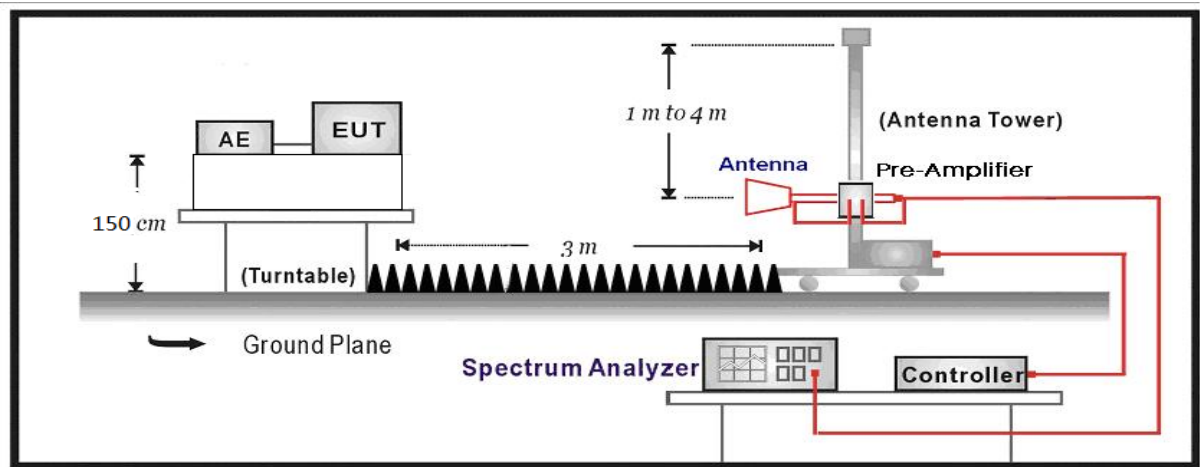
Below 30MHz Test Setup:

## 12. Antenna Requirement

### 12.1. Limit

Antenna Requirement Limit
<p>An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of §15.211, §15.213, §15.217, §15.219, or §15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.</p>
