1.5.2 Test Graph



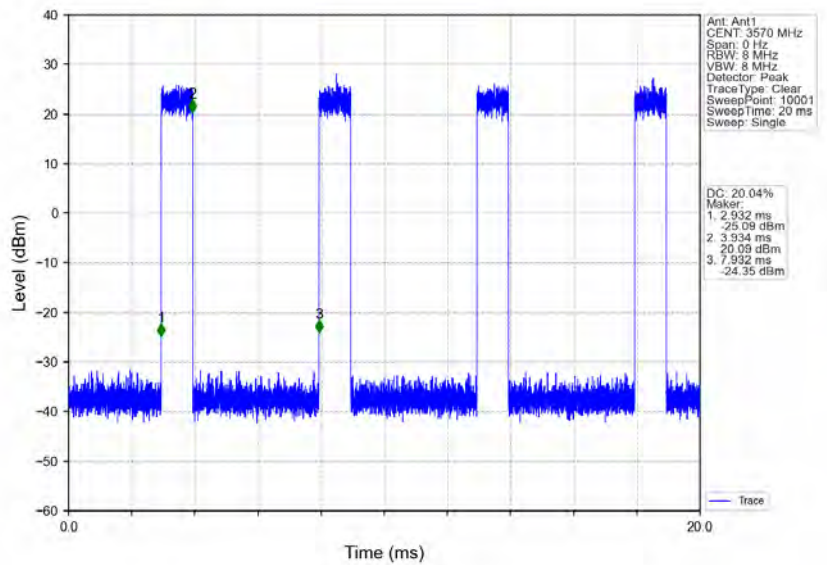

1.6.2 Test Graph



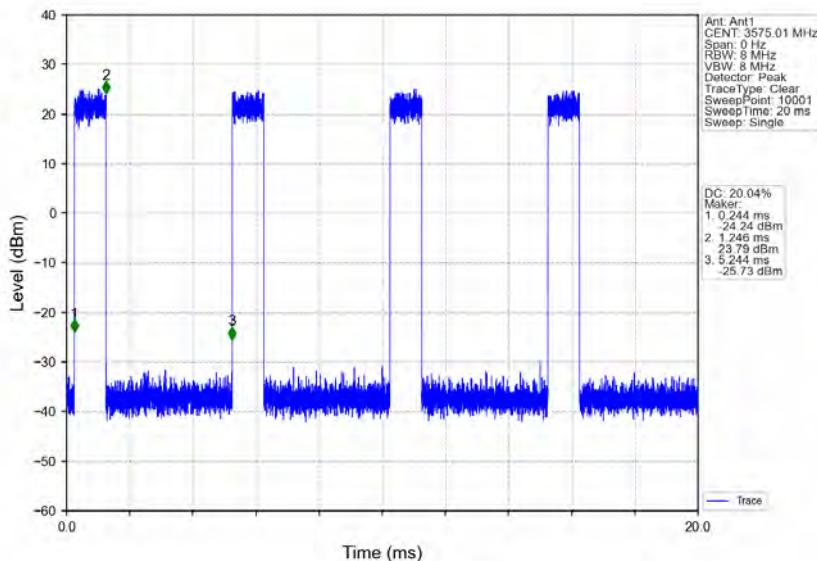
