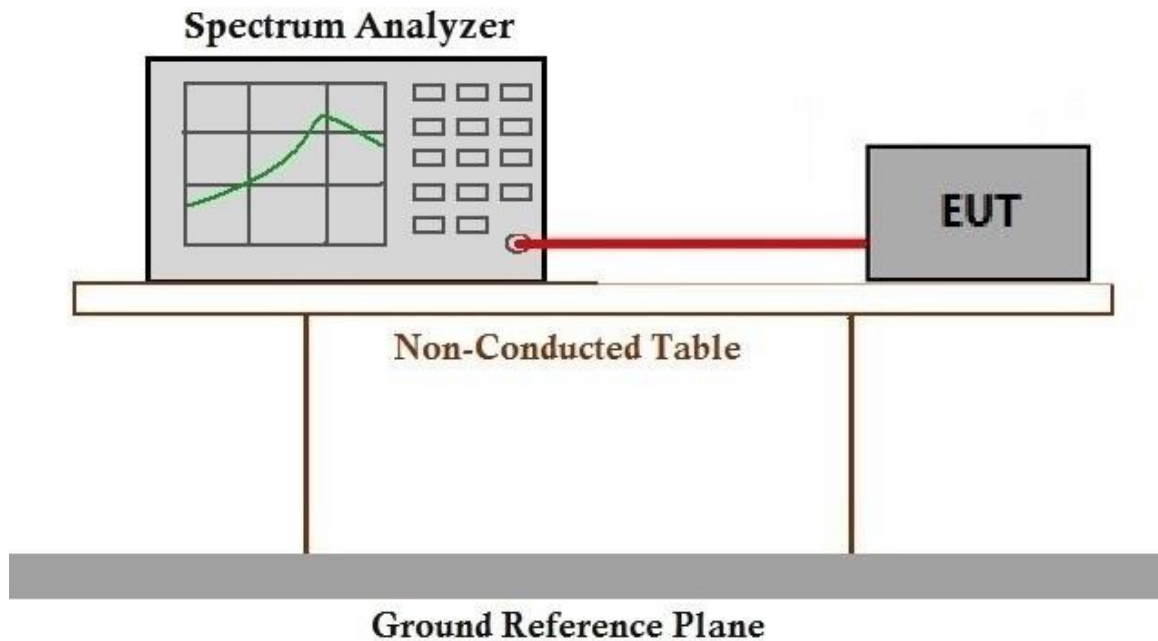

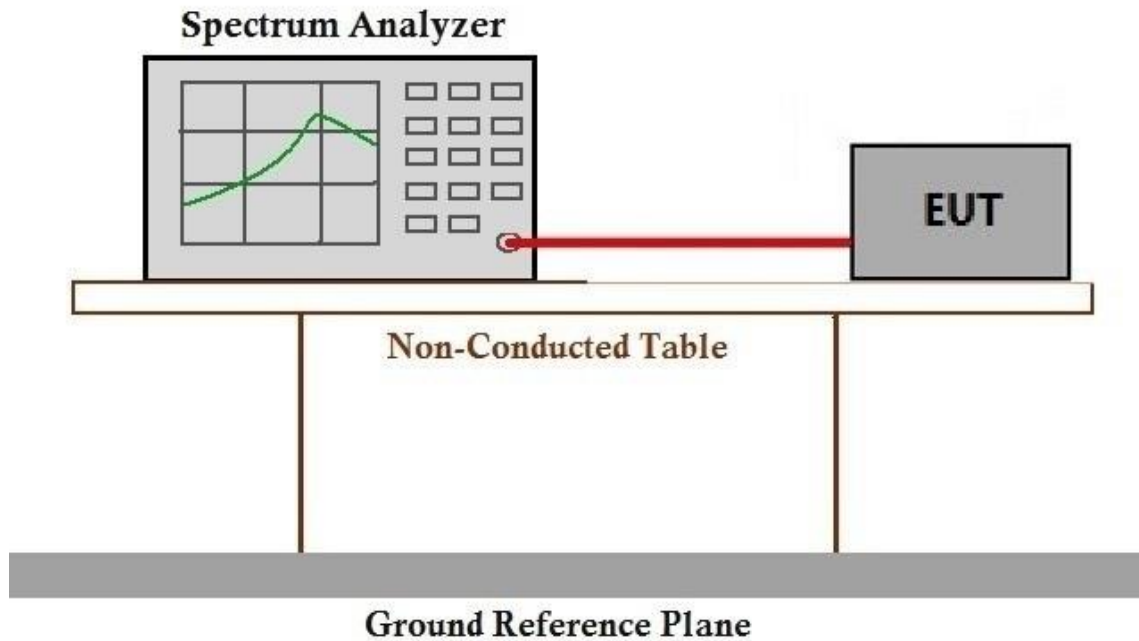

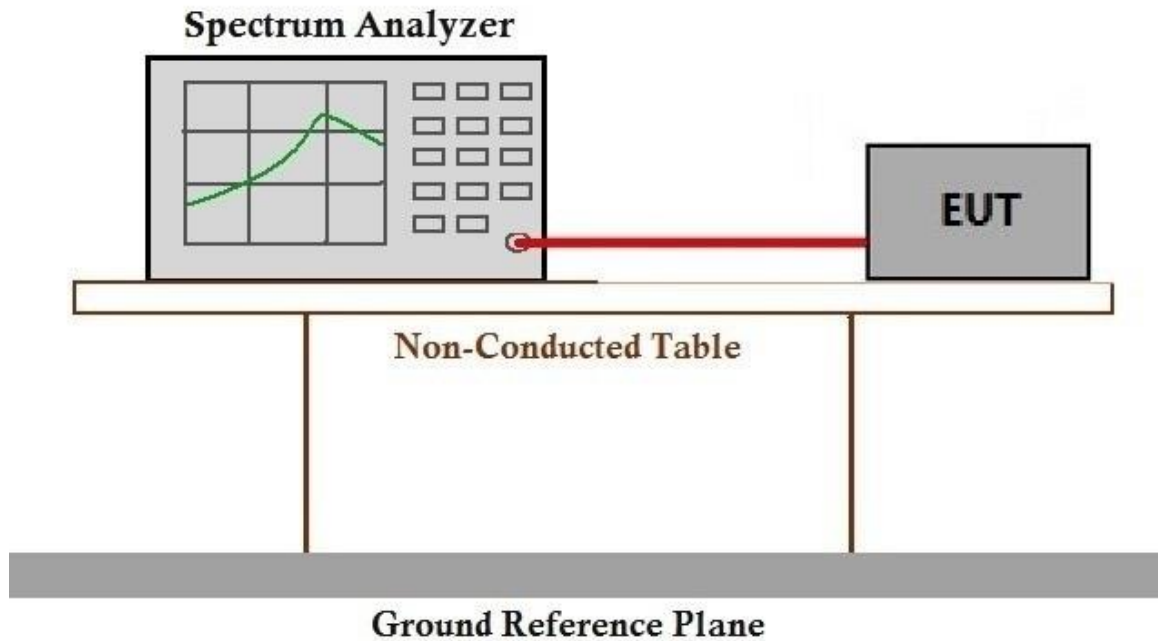

- (4) The transmitter shall be switched on; if possible, without the modulation and the measurement receiver shall be tuned to the frequency of the transmitter under test.

- (16) The input level to the substitution antenna shall be recorded as power level in dBm, corrected for any change of input attenuator setting of the measuring receiver.
- (17) The measurement shall be repeated with the test antenna and the substitution antenna oriented for horizontal polarization.

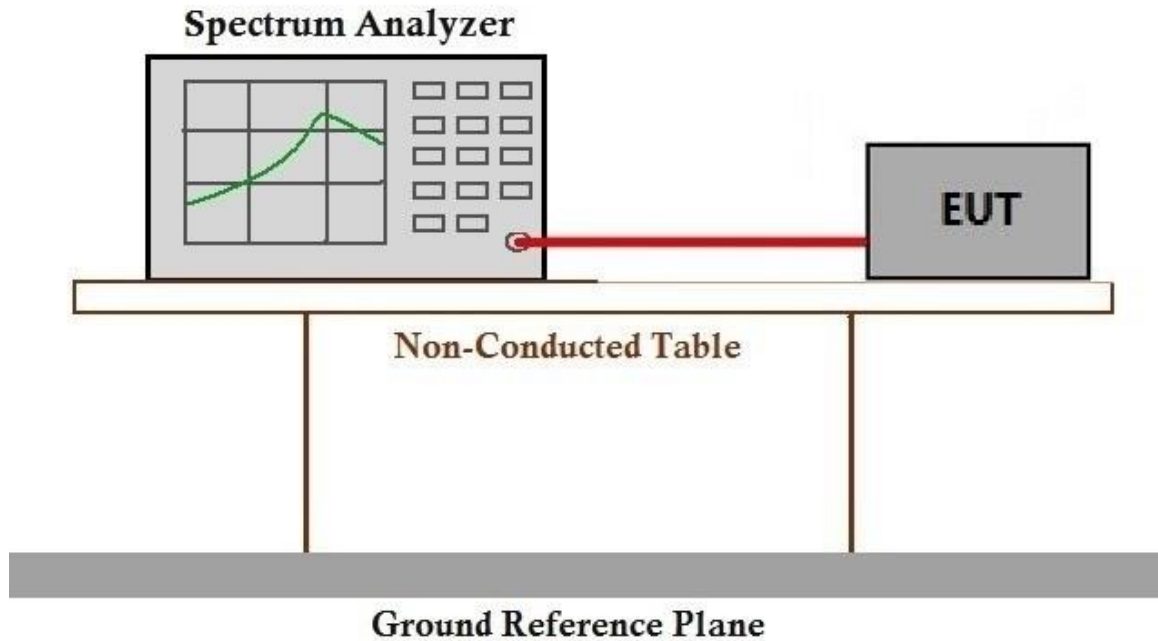
