Hi Jill,

Please address following issues.

Q#1: According to the model difference, 8 models are listed and 4 are TMC with BT/FM transmitters and other 4 are only has TMC with FM transmitter.

This filing can only certify with the model with FM and BT transmitters, other 4 models without BT module need to be removed since this is new filing. To avoid other unnecessary confusion, please update the model difference letter and related documents by removing other two models without BT portion.

Whether other 4 models without BT module can be filed for C2PC, please check KDB 178919 D01 Permissive Change Policy: Depopulated versions of a transmitter require authorization under separate FCC IDs for each version.

Please be noted if it is hardware changed by removing BT module from the GPS, new application is required.

Ans.: After confirm with client, for this application, we only apply four model numbers for BT/FM transmitter, and other four model numbers for FM transmitter will be filed for C2PC by using software to disable BT function. I had removed model number for FM transmitter from test report and related documents, please see the additional files.

Q#2: Please provide operational description.

Ans.: Please see the additional files.

Q#3: User manual does not include RF exposure statement. Please update.

Ans.: I had revised the page 72 of user manual, please see the additional files

Q#4: According to Bluetooth specification, the main difference between GFSK and 8DPSK is the bandwidth of 8DPSK will be much wider than GFSK. Looking to the test report, the 20dB BW of GFSK and 8DPSK are no difference. Please address.

Ans: It is our mistake to insert wrong test data. Please refer to attached report for correct test result.

Q#5: The test result of 20dB BW indicated in page 31 cannot agree with the test plots of 20dB BW. Please address.

Ans: I had revised page 31 of test report, please refer to Q1's test report files.

Q#6: Antenna gain indicated in page 5 of test report does not agree with page 65. Please clarify. Also, please provide antenna specification.

Ans: I had revised antenna gain in page 65 of test report, please refer to Q1's test report files.
