



i. The radiation measurements are performed in X, Y, Z axis positioning for Transmitting mode, and found the X axis positioning which it is the worst case.

j. Repeat above procedures until all frequencies measured was complete.



#### 8.11.3 Measurement Procedure and Data

a. For above 1GHz, the EUT was placed on the top of a rotating table 1.5 meters above the ground at a 3 meter fully-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.

Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak or average method as specified and then reported in a data sheet.
