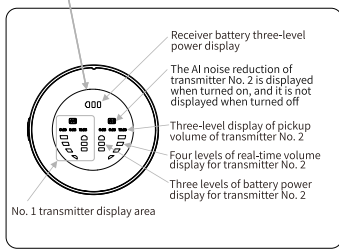


Receiver introduction

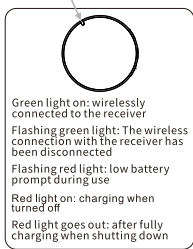

Transmitter status indicator

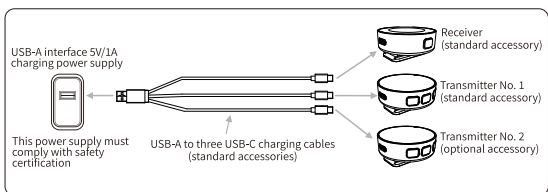

It is recommended to fully charge before use

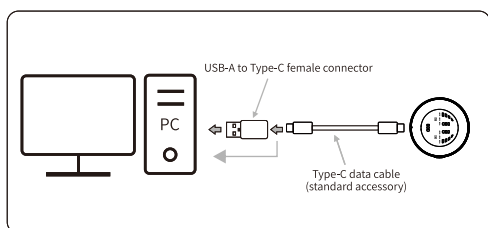
A full charge can last up to 18 hours (depending on the usage environment and number of charges).

During use, the receiver has a low battery indicator (showed one bar of power left) and the transmitter's red light flashes. Please charge it in time.



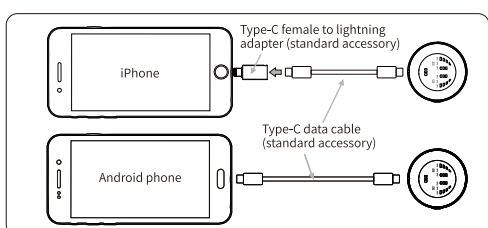

Receiver and computer connection



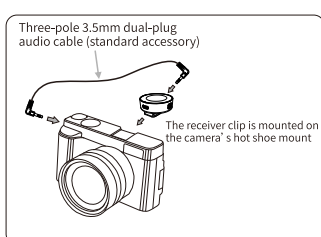

Receiver and mobile phone connection

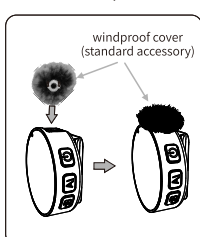

Receiver and camera connections

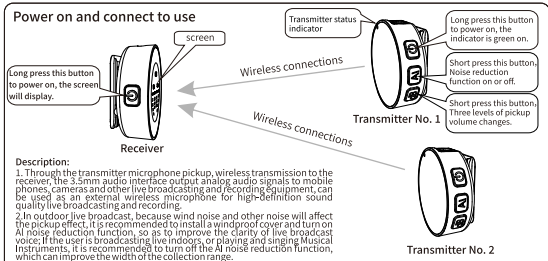


Transmitter Installation windproof cover

Pickup transmitter and receiver wireless connection



Description:
1. Through the transmitter microphone pickup, wireless transmission to the receiver, the 3.5mm audio interface output analog audio signals to mobile phones, cameras and other live broadcasting and recording equipment, can be used as an external wireless microphone for high-definition sound quality live broadcasting and recording.
2. In outdoor live broadcast, because wind noise and other noise will affect the pickup effect, it is recommended to install a windproof cover and turn on AI noise reduction function, so as to improve the clarity of live broadcast voice; If the user is broadcasting live indoors, or playing and singing Musical Instruments, it is recommended to turn off the AI noise reduction function, which can improve the width of the collection range.
