


Fig.1 Photograph of the SAR measurement System




Fig.2 Photograph of the Tissue Simulant liquid depth 15cm for Flat position




Fig.3 Bottom side of the Notebook is paralleled with flat phantom, open the panel with 90 degrees, bottom side is contact with flat phantom.




Fig.4 Bottom side of the Notebook is paralleled with flat phantom, open the panel with 90 degrees, bottom side is contact with flat phantom.




Fig.5 Right side of Notebook is paralleled with flat phantom, and spacing between EUT and Phantom is 15mm.




Fig.7 Back side of Notebook is paralleled with flat phantom, and spacing between EUT and Phantom is 15mm.










Fig.10 Back view of EUT
