$$Pd = (Pout * G) / (4 * pi * r^2)$$

where

Pd = power density in mW/cm<sup>2</sup>

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

**CONCLUSION:**

The BT, Wi-Fi and Wireless 5.1GHz+5.8GHz can transmit simultaneously, but Wi-Fi 2.4G and Wi-Fi 5G can not transmit simultaneously, the formula of calculated the MPE is:

**CPD1 / LPD1 + CPD2 / LPD2 + .....etc. < 1**

**CPD = Calculation power density**

**LPD = Limit of power density**

$(0.003942/1)+(0.018695/1)+(0.007616/1) = 0.030253 < 1$ , which is less than the "1" limit.
