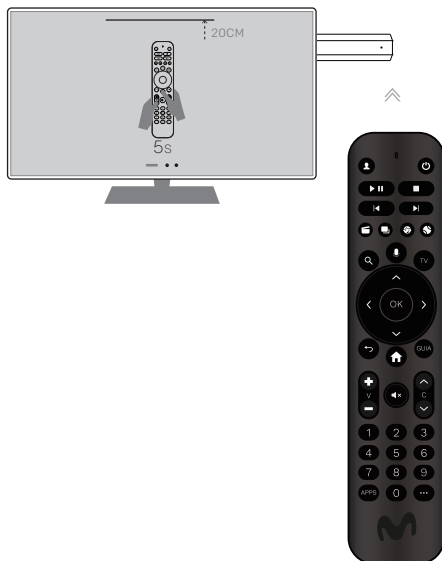
- Power on TV Stick and TV set.
