Note1. Occupational/controlled limits apply in situations in which persons are exposed as a consequence of their employment provided those persons are fully aware of the potential for exposure and can exercise control over their exposure. **RF Exposure Calculations:**

The following information provides the minimum separation distance for the highest gain antenna provided. This calculation is based on the conducted power, considering maximum power and antenna gain. The formula shown in KDB 865664 D01 is used in the calculation.

Equation from KDB 865664 D01, Edition 97-01 is:

$$S = PG / 4\pi R^2$$

Where: S = power density (in appropriate units, e.g. mW/cm<sup>2</sup>)

P = Time-average maximum tune up procedure (in appropriate units, e.g., mW)

G = the numeric gain of the antenna

R = distance to the center of radiation of the antenna (20 cm = limit for MPE)

Wi-Fi 2.4G PG = 17.5dBm + (2.00dB) = 19.50 dBm = 89.125 mW

Wi-Fi 5G PG = 13.0dBm + (2.14dB) = 15.14 dBm = 32.66 mW

Bluetooth PG = 11.5dBm + (2.00dB) = 13.50 dBm = 22.387 mW

Note: The MPE ratio = Mac Test Result ÷ Limit Value

So the simultaneous transmitting antenna pairs as below:

Σ of MPE ratios = WiFi 2.4G + WiFi 5G + Bluetooth = 0.018 + 0.006 + 0.004 = 0.028 < 1

Note: For transmitters, minimum separation distance is 20cm, even if calculations indicate MPE distance is less.
