



INTERNAL VIEW-3 OF EUT(Right earphone)






EXTERNAL VIEW-3 OF Charging case


EXTERNAL VIEW-5 OF Charging case


EXTERNAL VIEW-7 OF Charging case






INTERNAL VIEW-2 OF Charging case
