1 General Information

1.1 General Description

The equipment under test (EUT) is a Sleep Trainer. The oscillation of MCU is generated by a 32.768kHz crystal. The EUT is powered by 3 x 1.5V AA size batteries. When the EUT is turned on and selected an appropriate mode, the Sleep Trainer will record the phenomena of a baby. For examples, crying time and sleeping time. The records can be uploaded to a website through an USB cable and a PC.

The brief circuit description is listed as follows:

- U1, Y2 and associated circuit act as a main processor.
- U2, Y1 and associated circuit act as an USB 1.1 controller.
- U3 and associated circuit act as a serial flash memory.
- U4 and associated circuit act as a voltage regulator.
- U5 and associated circuit act as a voltage level detector.

2 Description of the radiated emission test

2.1 Test Procedure

Radiated emissions measurements are investigated and taken pursuant to the procedures of ANSI C63.4 – 2003.

The equipment under test (EUT) was placed on a non-conductive turntable with dimensions of 1.5m x 1m and 0.8m high above the ground. 3m from the EUT, a broadband antenna mounting on the mast received the signal strength. The turntable was rotated to maximize the emission level. The antenna was then moving along the mast from 1m up to 4m until no more higher value was found. Both horizontal and vertical polarization of the antenna were placed and investigated.

For below 30MHz, a loop antenna with its vertical plane is placed 3m from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. And the centre of the loop shall be 1 m above the ground.

The device was rotated through three orthogonal to determine which attitude and configuration produce the highest emission during measurement for radiated emission measurement.

2.2 Test Result

The emissions meeting the requirement of section 15.109 are based on measurements employing the CISPR quasi-peak detector below 1000MHz and average detector for frequencies above 1000MHz.

The emissions from 30MHz to 1000MHz were investigated, and emissions more 20dB below limit were not reported. Thus, those highest emissions were presented in next pages.

It was found that the EUT meet the FCC requirement.
