



The lowest, middle, highest channel numbers of the Bluetooth Module used and tested in this report are separately 0 (2402MHz), 39 (2441MHz) and 78 (2480MHz).
- Note 2: In EMC test, the composite device of the EUT (e.g. USB, CD, Microphone, Sound Box) were operating as required by 47 CFR Part 15 Subpart A Section 15.31(h), and the other ports and cable of the EUT (e.g., control cable)were operating as required by connecting the load.




3.1 Number of Hopping Frequency

3.1.1 Requirement

According to FCC section 15.247(a)(1)(ii), frequency hopping systems operating in the 2400MHz to 2483.5MHz bands shall use at least 75 hopping frequencies.

3.1.2 Test Description

A. Test Setup:



The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 500hm; the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.





3.2 Peak Output Power

3.2.1 Requirement

According to FCC section 15.247(b)(1), for frequency hopping systems that operates in the 2400MHz to 2483.5MHz band employing at least 75 hopping channels, the maximum peak output power of the intentional radiator shall not exceed 1Watt. For all other frequency hopping systems in the 2400MHz to 2483.5MHz band, it is 0.125Watts.



The Bluetooth Module operates at hopping-off test mode. The lowest, middle and highest channels are selected to perform testing to verify the conducted RF output peak power of the Module.













(Plot B: Channel = 2441)

3.3 20dB Bandwidth

3.3.1 Definition

The 20dB bandwidth is known as the 99% emission bandwidth, or 20dB bandwidth (10*log1% = 20dB) taking the total RF output power.


3.3.3 Test Result

The Bluetooth Module operates at hopping-off test mode. The lowest, middle and highest channels are selected to perform testing to record the 20dB bandwidth of the Module.





3.4 Carried Frequency Separation

3.4.1 Definition

According to FCC section 15.247(a)(1), frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25kHz or two-thirds of the 20dB bandwidth of the hopping channel, whichever is greater.


3.4.2 Test Description

See section 3.1.2 of this report.

3.4.3 Test Result

The Bluetooth Module operates at hopping-on test mode.

For any adjacent channels (e.g. the channel 39 and 40 as showed in the Plot A), the Module does have hopping channel carrier frequencies separated by a minimum of 25kHz or two-thirds of the 20dB bandwidth of the hopping channel (1.06MHz, refer to section 3.3.3), whichever is greater. So, the verdict is PASS.

3.5 Time of Occupancy (Dwell time)

3.5.1 Requirement

According to FCC section 15.247(a)(1)(iii), frequency hopping systems in the 2400 - 2483.5MHz band shall use at least 15 non-overlapping channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. Frequency hopping systems may avoid or suppress transmissions on a particular hopping frequency provided that a minimum of 15 channels are used.

3.5.2 Test Description

See section 3.1.2 of this report.

3.5.3 Test Result

The average time of occupancy on any channel within the Period can be calculated with formulas (for DH5 package type):

The lowest, middle and highest channels are selected to perform testing to record the dwell time of each occupation measured in this channel, which is called Pulse Time here.










(Plot A: Channel = 2402)

3.6 Conducted Spurious Emissions

3.6.1 Requirement

According to FCC section 15.247(c), in any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

3.6.2 Test Description

See section 3.1.2 of this report.

3.6.3 Test Result

The Bluetooth Module operates at hopping-off test mode. The measurement frequency range is from 30MHz to the 10th harmonic of the fundamental frequency. The lowest, middle and highest channels are tested to verify the spurious emissions.










(Plot A.1: Channel = 0, 30MHz to 3GHz)




(Plot A.2: Channel = 0, 3GHz to 25GHz)




(Plot B.1: Channel = 39, 30MHz to 3GHz)






(Plot B.2: Channel = 39, 3GHz to 25GHz)

3.7 Band Edge

3.7.1 Requirement

According to FCC section 15.247(c), in any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

3.7.2 Test Description

See section 3.1.2 of this report.

3.7.3 Test Result

The Bluetooth Module operates at hopping-off test mode. The lowest and highest channels are tested to verify the band edge emissions.





3.8 Radiated Emission

3.8.1 Requirement

According to FCC section 15.247(c), radiated emission outside the frequency band attenuation below the general limits specified in FCC section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in FCC section 15.205(a), must also comply with the radiated emission limits specified in FCC section 15.209(a).


According to FCC section 15.209 (a), except as provided elsewhere in this subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:


As shown in FCC section 15.35(b), for frequencies above 1000MHz, the field strength limits are based on average detector. When average radiated emission measurements are specified in this part, including emission measurements below 1000MHz, there also is a limit on the radio frequency emissions, as measured using instrumentation with a peak detector function, corresponding to 20dB above the maximum permitted average limit for the frequency being investigated unless a different peak emission limit is otherwise specified in the rules.

3.8.2 Test Description

A. Test Setup:







The Bluetooth Module of the EUT is powered by the Battery charged with the AC Adapter which is powered by 120V, 60Hz AC mains supply. The Module is located in a 3m Semi-Anechoic Chamber; the antenna factors, cable loss and so on of the site as factors are calculated to correct the reading. During the measurement, the Bluetooth Module is activated and controlled by the Bluetooth Service Supplier (SS) via a Common Antenna, and is set to operate under hopping-on test mode transmitting 339 bytes DH5 packages at maximum power.

For the Test Antenna:

- (a) In the frequency range of 9kHz to 30MHz, magnetic field is measured with Loop Test Antenna. The Test Antenna is positioned with its plane vertical at 1m distance from the EUT. The center of the Loop Test Antenna is 1m above the ground. During the measurement the Loop Test Antenna rotates about its vertical axis for maximum response at each azimuth about the EUT.
- (b) In the frequency range above 30MHz, Bi-Log Test Antenna (30MHz to 1GHz) and Horn Test Antenna (above 1GHz) are used. Test Antenna is 3m away from the EUT. Test Antenna height is varied from 1m to 4m above the ground to determine the maximum value of the field strength. The emission levels at both horizontal and vertical polarizations should be tested.

3.8.3 Test Result










(Plot A.1: 9kHz to 30MHz)




(Plot A.2: Antenna Horizontal, 30MHz to 1GHz)




(Plot A.3: Antenna Horizontal, 1GHz to 25GHz)






(Plot A.4: Antenna Vertical, 30MHz to 1GHz)




(Plot A.5: Antenna Vertical, 1GHz to 25GHz)




(Plot B.1: 9kHz to 30MHz)






(Plot B.2: Antenna Horizontal, 30MHz to 1GHz)




(Plot B.3: Antenna Horizontal, 1GHz to 25GHz)




(Plot B.4: Antenna Vertical, 30MHz to 1GHz)






(Plot B.5 Antenna Vertical, 1GHz to 25GHz)




(Plot C.1: 9kHz to 30MHz)




(Plot C.2: Antenna Horizontal, 30MHz to 1GHz)






(Plot C.3: Antenna Horizontal, 1GHz to 25GHz)
