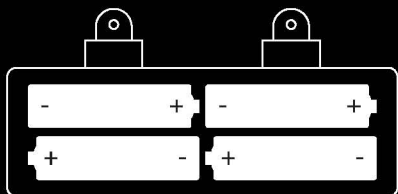




## SETTING UP AND CONNECTING YOUR GUITAR CONTROLLER

### SETTING UP YOUR GUITAR CONTROLLER

Your Guitar Controller runs approximately 40 hours on just 4 AA size batteries. Unscrew the battery cover on the back of your guitar and insert the batteries as shown.



### CONNECTING YOUR GUITAR CONTROLLER for PS2/PS3

The Guitar Controller is a 2.4 GHz wireless controller that connects to a PlayStation® 2 or PlayStation® 3 via a detachable receiver.

The receiver has 2 available connections:

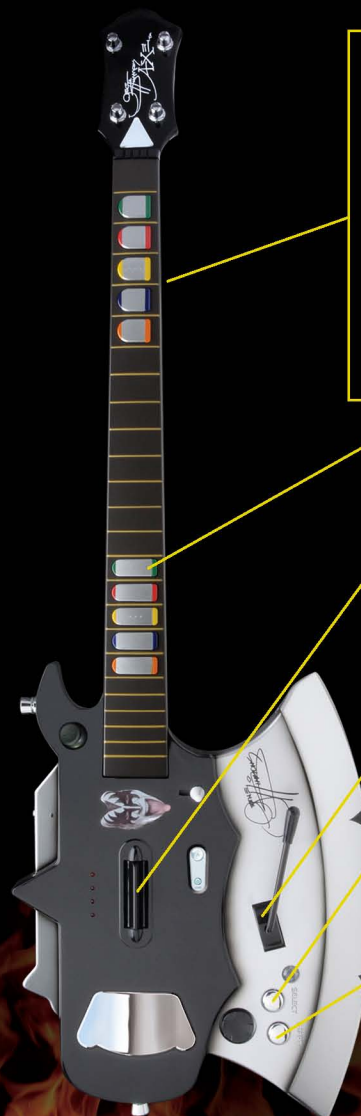
- PlayStation® 2 controller port connector
- USB connector for PlayStation® 3 consoles

The receiver comes ready to plug in to a PlayStation® 2 controller port. To connect the receiver to a USB port, attach the provided USB adaptor and plug the receiver into the appropriate PlayStation® 2 or USB port. The receiver draws its own power directly from the device, and automatically finds your Guitar Controller. No additional physical setup is required.

### CONNECTING YOUR GUITAR CONTROLLER FOR NINTENDO'S WII

The Guitar Controller requires the use of a Wii remote in order to operate. Insert the Wii remote in the cavity in the back. Please make sure that the Wii remote is synchronized with the Wii console.

## USING YOUR GUITAR CONTROLLER



**Green Fret Button** – Activates the green note and used to confirm a menu selection

**Red Fret Button** – Activates the red note and used to cancel a menu selection

**Yellow Fret Button** – Activates the yellow note

**Blue Fret Button** – Activates the blue note

**Orange Fret Button** – Activates the orange note

Narrow color buttons for Rock Band™ only. In Guitar Hero™ mode, these will work the same as the normal fret buttons

**Strum Bar** – Press the Strum Bar UP and DOWN to simulate strumming, activating any fret buttons being pressed. Also use to navigate menus

**Whammy Bar** – Add your own personal touch on longer notes by pressing the whammy bar IN and OUT

**Select** – To confirm a selection and activate power-ups during game play

**Start Button** – Confirm/Pause

**Tilt Sensor** – Activate Star Power by tilting your Guitar Controller up
